



Getting Back to Basics



Since The American Legion was started back in 1919, a personal touch has always been the way our membership has continued to grow and people knew who The American Legion was in their community. Over the last few decades, that personal connection with members has tapered off and we have seen a steady decline in our membership and a less prominent role in our local communities. If this continues to happen, The American Legion may no longer be the organization people know it as today and our programs will continue to suffer. It is up to the grassroots Legionnaires to step up and get back to the basics of reconnecting with former and current members and connecting with new members through Buddy Checks.

Started by Past National Commander Brett Reistad, Buddy Check is a way for members to join together to strengthen their Post and let those members who have lapsed know that they are still wanted. For many, when their membership lapsed, they did not realize they had forgotten to renew their membership, they may not have been able to pay their dues at that time, or they didn't know what their dues were going towards and didn't think that it was important. Buddy Checks are exactly

how they sound, checking in all of your "buddies" in the community. Maybe they need assistance but don't know who to ask or were waiting for someone to make a call, visit, or send them a card to let them know they are wanted.

Organizing a Buddy Check can be done in less than ten steps. First, you need to gather up a team of Legion members to help with the project. Next, get a list of former and current members in the Post from MyLegion.org or Headquarters. After you have the list, split it up between the members in your group. Once everyone has their lists, start making connections through phone calls, door to door visits, letters, or emails. Start the conversation off with who you are and ask them how they have been doing and let the member know that they are missed at the Post, the impact their dues have on your Post programs and activities, and any events or activities that you have coming up. Next, ask the member if they are wanting to renew their dues and the steps that they can take to do so. Finally, thank them for their time and let them know that The American Legion is there if they ever need anything.

During Spring Meetings in May 2019, a Resolution was passed to make the week of Veterans Day and the week of The American Legion Birthday, March 15, "A National Week of Calling". It is the hope that making these personal connections with former and current members will help everyone know who The American Legion is and the programs that are offered to both veterans and children in the community. We encourage every Post to make those calls and connections in your community. 
As Veterans day passes and Thanksgiving and Christmas approaches, it is a good time to reflect and plan.

As a veteran you are entitled to some final benefits when you pass, your family will get a burial flag and you may be eligible for a government marker and some financial benefits. In some cases, your surviving spouse may be eligible for benefits after you pass.

Go to your County Veterans Service officer and talk about these benefits, and what you need to do. That way your family will know what your wishes are. If you want a certain marker, (there are several to choose from) or if you want something inscribed on the marker you need to let someone know

So, working with your service officer and your family or funeral director will help lessen the burden your family will have to make when the time comes. This also ensures that your discharge papers will be on file. While you are at it you can check to see if you are entitled to compensation or pension benefits or are in need of an increase of your service-connected disability.

I hope that you all had a great Veterans day, from my family to yours Happy Thanksgiving and Merry Christmas.

Last month many of you likely participated in a Veterans Day celebration or took advantage of "Veterans Day" sales at your favorite retail store. Whether you were honoring the veterans in your life or scoring a great deal, hopefully you took a moment to reflect on the true meaning of Veterans Day.

Veterans Day, originally known as Armistice Day, was first commemorated, by proclamation of President Woodrow Wilson, on November 11, 1919 to honor those who served in World War I. Wilson stated "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..." On that day, two minutes of silence were observed at 11am, the time when the armistice, or temporary cessation of hostilities, went into effect between Germany and the Allied Nations. This tradition continues today.

On June 4, 1926, Congress passed a resolution calling for the President of the United States to issue an annual proclamation observing the importance of Armistice Day. Twelve years later, on May 13, 1938, Congress passed a special act making Armistice Day a Federal holiday with the expressed purpose of promoting world peace and mutual understanding between nations.

Although WWI was known as the "war to end all wars," we know that was unfortunately not the case. Over 16 million people served in WWII and 5.7 million people served in the Korean War. In light of these two wars, veterans' service organizations lobbied Congress to amend the 1938 act to change Armistice Day to Veterans Day in order to honor veterans of all our wars, not just WWI. That legislation was signed by President Dwight Eisenhower on June 1, 1954.

Veterans Day is not to be confused with Memorial Day—a common misunderstanding, according to the U.S. Department of Veterans Affairs. Memorial Day (the fourth Monday in May) honors American service members who died in service to their country or as a result of injuries incurred during battle, while Veterans Day pays tribute to all American veterans—living or dead—but especially gives thanks to living veterans who served their country honorably during war or peacetime.

Many of these veterans continue serving their communities even after their discharge from the military. A prime example is the work being done by Legionnaires in Nebraska. Whether it's raising money for Legion programs, serving food at shelters, mentoring children through baseball or scouting programs, or visiting the elderly or sick in our veteran's homes and hospitals, Nebraska Legionnaires contribute positively to the health and well-being of our society. So, not only on Veterans Day, but every day of the year, I'd like to say thanks to all our veterans for everything they have done, and continue to do, for our nation.

December. A time for holiday parties and a time to gather with friends and family. A time to reflect on the year to end and the year to come. On behalf of myself and the Department Membership Committee, I certainly wish you the Merriest of Christmases and the Happiest of New Years!

While we may be enjoying the holidays, there's still some work to do on membership. As we usually do, Nebraska has been achieving its incremental national target date goals, but we need to keep the pressure on to make sure we don't fade at the end of the race.

Renewing the dues of current members is always important. However -- please don't rely exclusively on the renewal notices sent from Indianapolis to accomplish that piece of the puzzle. Identify the members who haven't renewed. Follow up. Make some personal contacts. Let them know that their membership is important.

New members -- obviously -- are important, too. We have far more eligible veterans in Nebraska who are not yet members than we have members -- probably by about 2 or 3 to 1. We just need to identify them and ASK them to join. With the passage of the LEGION Act this summer, any veteran not previously eligible who has served one day of active duty since December 7, 1941 became eligible to be a Legionnaire as long as he or she meets the other normal requirements.

This fall, several posts and districts have been taking advantage (with good success) of another good source of members for your posts. Post 500. Those members joined the American Legion on-line or responded to a direct mail solicitation from the national headquarters. We can identify who they are, and we can transfer and/or renew their memberships into a local post. That's where they belong and should want to be.

We plan to make a presentation on the Post 500 transfer process at the Mid-Year Conference in Kearney. I hope you take advantage of the opportunity to see how relatively easy it is -- and the good it can do in gaining you a member or two. I hope to see many of you there and share with you the success some other posts have already had.

Please take a look at the Department website from time to time and click on the "Membership" tab. Links have been added to give you access to two excellent publications from the national headquarters. The Membership Impact Reports and the Training Newsletters both offer a variety of interesting American Legion facts and provide some very useful information that YOU can use when someone asks, "Why should I join the American Legion?"

As I am working on this article on Veterans Day, November 11, 2019, I want to wish all you veterans and your extended families a wonderful day. We realize you will not receive this until later, but it is important to say thank you. Words can mean so much and be courteous and kind or nasty and hurtful. We need to ask ourselves which category we want to be in.

This POW/MIA article every month wants to emphasize

what our government and we ourselves are doing to continue to work for the release and or repatriation of our missing in action.

According to the Defense POW/MIA Accounting Agency there are 83,114 Americans who fought in wars that are still missing. As of July 29, 2019, 16 are from Nebraska.

Resolution number 370: for POW/MIAs, passed



during the 67th National Convention of the American Legion in August 1985, in New Orleans, Louisiana and stated that we support the Presidents pledge of highest national priority to resolve the status of Americans still missing and unaccounted for in Indochina and further resolved that we support the US Government to ensure the issue remains one of the highest national priorities and to accelerate efforts in every honorable way to obtain the immediate release of any American who may still be held captive in Indochina with the fullest possible accounting of those still missing and repatriation of the remains of those who died in service of our nation.

The president of the United States in 1985 was Ronald Reagan who served two terms from 1981 to 1989 as our Commander in Chief. At this same during the 67th American Legion National Convention, The POW/MIA Empty Chair Resolution was passed.

Adopted POW/MIA Resolution 288 calls for designating a POW/MIA Empty Chair at all official meetings of The American Legion as a physical symbol of the thousands of American POW/MIA's still unaccounted for from all wars and conflicts involving the United States.

I am sure most of you know about these resolutions and many of you possibly voted on them. That was 34 years ago and our word is still good and will remain so as we continue to work for finding our missing and our POW's. Although POW/MIA Recognition Day is always the third Friday in September; every day these service personnel are on our minds and in our prayers. It is up to us to make this a better world in which to live.


It must have been a dream, but why? Americans would never sell themselves out for pittance, would they, just to satisfy minority folks' lust to re-write history? Would they?



There is a change to The American Legion Preamble due to the Legion Act. Instead of the Great Wars, it is changed to all wars. I would expect a change coming from National on the SONs Preamble, also. It will be incorporated in all new publications once National provides guidelines.

I have had questions about the dues increase from National that was in a previous article. It is a \$3.00 increase for the National dues, voted on at the National Convention. It will start on July 1, 2020. Squadrons will submit \$11.00 to Detachment of which \$4.00 will stay at Detachment and \$7.00 will be sent to National. Again, the National organization has not had a dues increase for 38 years and as with everything, costs have went up. They are doing their part in cutting costs as staff numbers have decreased at National, fewer road trips for staff members for training and meetings, and state officers are being trained to present information. The Detachment will be looking into a dues increase in June as we were also hit last year at the Convention with an increase from The Nebraska Legion Department of \$2.50. If you are so inclined to vote for or against the dues increase, you might want to attend the Detachment Convention in June, in Kearney.

Membership is still lagging. November 14 was a target date of 35%. As of October 31, 2019, we were at 27%. Did not look like we would make the target date. Do not forget, you can process your membership online if your Squadron Adjutant has a mysal. org account and you authorize him to submit an e-check. This is the first month I, as the Post and Squadron Adjutant, has utilized this program. I made sure the membership approved I could do it, before submitting. Next target date is December 11, 2019 at 45%. I am hoping we can get things going and meet this date for membership. Just a gentle reminder, if you are still mailing in your membership and checks, it takes around 3-4 weeks to get posted at National, via Detachment. Things just take a little longer when doing it by snail mail.

On November 9, I attended the 244th Birthday of the Marine Corps Birthday in Norfolk at Post #16, and conducted the program. On November 10, 2019, I attended the All Veteran's Flagpole dedication ceremony put on by Howells Post 155. The lighted 120' flagpole is located 1 mile East of Hwy 15/32 junction and 600' north on county road 575. It has a 30' X 50' U.S. flag, POW/MIA flag and 5-20' flag poles for the branches of the services, along with benches, two eagles and a granite monument for the late owner of the property, Donald Molacek, Sr. The family designed, erected and paid for the memorial to all Veterans. The Howells Post 155 will help take care of it. On November 11, 2019, at the Veteran's Day in Winside, at 9 AM, I presented information about the SONs and how they can help or are helping locally. At 1 PM, at the Emerson-Hubbard Veteran's Day Program, I was the guest speaker. At 5 PM, I attended the Dixon County Convention in Allen and provided information on upcoming events, the Legion Act membership dates, The Sons of The American Legion, and discussed the Medal of Honor Highway (Hwy 20 project) and NSP K-9 initiative. It has been a busy month.

Nebraska Medal of Honor Highway 20

In early 2018, veterans from Oregon began a push to name Highway 20 from Newport, Oregon to Boston, Massachusetts, The Medal of Honor Highway. Past Department Commander (PDC) Gene Twiford picked up on the effort and began the process of renaming Highway 20 in Nebraska the Nebraska Medal of Honor Highway to honor the 73 Medal of Honor Recipients from Nebraska.

In Nebraska this is no small project. He had to obtain letters of support from every community and county along Highway 20. As he neared completion of this first phase, Ken Hanel and I joined PDC Twiford and began the second phase of gaining the political support that would be needed to run this project past the Nebraska Department of Roads Commissioners (NDoR).

Letters requesting support were garnered from Senator Bob Kerrey (Medal of Honor Recipient), the Nebraska Veterans Council (representing all registered Veteran Service Organizations), along with The American Legion passing a resolution of support for the name change. Letters were then sent to each Nebraska Senator along Highway 20 requesting any assistance they might bring to bear upon the NDoR Commissioners at their meeting on December 13, 2019 in Lincoln at 8:30 in their main building on 1500 Highway 2 across from the State Penitentiary. In those letters, we reported that this action has the support of over 30,000 Nebraska Veterans. I have received a copy of a letter sent to the commissioners by those five Senators supporting the Nebraska Medal of Honor Highway. This was great day for the project. There are two other entities attempting to have highways renamed and the commissioners are only allowed to accept one per year.

Currently we are looking at six signs, one as you enter the state from either end, two placed at the crossroads of The American Legion Memorial Highway (O'Neill) and two at the crossroads of the Veterans of Foreign Wars Memorial Highway (Valentine). The NDoR has suggested that if we are successful a spare sign for immediate replacement of a damaged or missing sign should be stored with the responsible Road Superintendent for that region. Making for a total initial need of twelve signs and the placement of six.

In Nebraska, those that have a highway renamed become responsible for putting up the signage. Thus, we are at the cusp of beginning phase 3. Phase 3 is the formation of a non-profit foundation to be named the Nebraska Medal of Honor Foundation. The Nebraska Medal of Honor Foundation is needed so that those donations needed for the signage can be tax exempt. The intention is to have a governing board of five and a minimum of three Nebraska Veteran Service Organizations would be represented with a maximum of two board members from any one NVSO.

To raise funds for the Nebraska Medal of Honor Foundation Past Area A Commander Ken Hanel and I are walking across Highway 20 much like a walka-thon. The details of the walk are still being formulated. It is scheduled to begin on Mothers Day, May 10th. It will end on May 22nd at Siouxland Freedom Park in South Sioux City, Nebraska.

The Nebraska Medal of Honor Highway belongs to all Nebraskans. This will be the longest named highway in the state and should be a source of pride to all Nebraska veterans, military and patriots.

Get the word out and maybe you know of a foundation, corporation, or possible private donator you can share this with. Honoring these heroes of heroes is among one of the most honorable things a veteran or patriot can do. Keep your ears open for the ability to support the Medal of Honor Highway on the website when it comes up.

What can you do? Attend the meeting on December 13th and wear your hat. Load your car with fellow vets and make it a day you'll always remember. Support the heroes of heroes, our Nebraska Medal of Honor Recipients. We need to overwhelm the commissioners at their December 13, 2019 meeting in Lincoln at 8:30 in their main building on 1500 Highway 2 across from the State Penitentiary.

Legionnaire in the Spotlight H. Nicholas Windeshausen



H. Nicholas Windeshausen was born in Osmond, Nebraska in 1923 to a very poor family with no indoor plumbing. He was one of eleven children. He graduated from St. Mary's Catholic School in 1937 and then from Osmond High School in 1941 and he enlisted in the US Navy in August of 1942.

Windeshausen served in the US Navy as a medic from 1942-1946. During his four years in the service, he attended Hospital Corps School in San Diego, CA; was stationed at the US Naval Hospital Mare Island, CA; was the coordinator of Services Training Center at Treasure Island, CA; was stationed on a receiving ship in San Francisco, CA; was stationed on the US Naval Mobile Hospital NBo.3 in the American Samoa; was stationed on the US Fleet Hospital No. 103 in Guam; was stationed at the USN Trec Station T.I.S.F.; was stationed at the Great Lakes, IL training center; and was discharged in St. Louis, MO as a Pharmacist's Mate, First Class(T) V6. Windeshausen

received the Asiatic-Pacific, American Area Victory Medal and the Good Conduct medal.

After his discharge from the service, Windeshausen married Joyce Pilger in 1946 and at the age of 28 he started at the University of Nebraska-Lincoln in 1951. He earned his bachelors degree in Accounting in 1954, his masters degree in Finances in 1955, and PHD in Management and Marketing in 1962. Windeshausen credits The American Legion and their support of the G.I. Bill as the reason he was able to go to college. He stated, "I want to let you know how much I appreciated receiving, through the G.I. Bill, an education from a great university in order to be well prepared to help others.

Windeshausen taught at the University of Nebraska-Lincoln from 1955-1962 before moving to California and teaching at California State University at Sacramento from 1962-1992. He served as Coordinator of Graduate Studies 1965-1970, Coordinator of Undergraduate Studies 1970-1971, Chairman of the Management Department 1974-1977, and Associate Dean 1977-1980. Windeshausen was instrumental in acquiring AACSB accreditation for the College of Business Administration for both the Undergraduate and Graduate programs.

Windeshausen retired in 1992 and continued to give back to his community. He volunteered with Big Brothers/Big Sisters, Meals a LA Car, Make-A-Wish Foundation, United Way Sacramento, and Catholic Social Services. He was a US Delegate for four United Way International Conferences and served as a Senior Educational Consultant

and served as a Senior Educational Consultant to the Main Event Management Corp.

Windeshausen has been honored for work in both education and the community with the 1986 Distinguished Community Service Award from the United Way; being named an Admiral in "The Great Navy" State of Nebraska; a certificate of Commendation from the Department of Defense, Office of Civil Defense; a Distinguished Leadership and Service Award from Consumer Credit Counselors of Sacramento; and a Lifetime Achievement Award from Delta Sigma, its



highest honor, in 2011. In 2016, he received the Alumni Achievement Award from the Nebraska Alumni Association.

Windeshausen and his wife, Joyce, wanted to leave a lasting legacy of excellence that would help generations of students to come. They established sis scholarships , four at Wayne State College and two at Sacramento State College.








Happy Holidays from the Riders

With our Cornhusker Girls State week-long program, we have taught how democracy works into the lives of countless young women. Children have enjoyed Halloween parties, Easter Egg Hunts and special parties for the children of men and women in the military. In our schools, poppy posters have been made and essays have been written. And, we have done all that while running countless fundraisers to make sure there are funds to run these programs.

What do we know about the history of The American Legion Auxiliary, Department of Nebraska?

*1.) Where and when was the first Department Convention?

2.) How many organized chapters were there? (They were called chapters at that time.)

3.) How many paid memberships at the time of the convention?

4.) What were the dues at the time of the convention?

5.) What was the salary of the Secretary at the time of the convention?

6.) How was the Secretary appointed?

The state headquarters address was 313 Richards Block, Lincoln, NE; and the Auxiliary was to pay its share of office expenses. At the time of the convention, Mrs. W. A. Prince of Grand Island was the Chairman of the Constitution Committee. The convention did adopt a new constitution.

Frank B. O'Connell, the temporary Secretary, left the Auxiliary with three recommendations:

"A statewide effort be made to place hospitals where ex-service men are confined under the jurisdiction of certain chapters, who will look after the welfare and needs of these disabled men.

That the convention goes on record to urge all local chapters of the Women's Auxiliary to take an active part in the affairs of their respective communities, especially as pertains to problems of women.

That the Women's Auxiliary use its best efforts to help take care of the graves of World War Veterans, that it discourages holding athletics on Memorial Day, and that it join hands with the American Legion and other patriotic organizations to cultivate a proper respect for our flag."

I will close with the words of the newly appointed State Secretary, Mrs. H. R. Ball --- "Now, all together ladies, shoulder to shoulder. Let the men and women of the Great War realize that their women folk are doing something definite and tangible to help them! God Bless our boys!"

NATIONAL VETERANS CREATIVE ARTS FESTIVAL



The National Veterans Creative to deal with personal stresses and Arts Festival (NVCAF) is an event struggles. Creative writers share held annually to showcase the poems, short and long stories, talents of veterans receiving therapy at VA Medical Centers across the United States. The festival was held in Kalamazoo, Michigan from October 27 - November 3 with over 100 veterans from 65 VA facilities in attendance. In 2019, 130 VA medical facilities hosted a local festival with a total of 3,552 veterans participating. First-time participants accounted for 45% of the entries, and 23% were female veterans.

How does a veteran qualify to attend the NVCAF? A local VA facility hosts a creative arts festival in early spring, and 1st place winners in the various categories are invited to attend the national festival. The categories coincide with the recreational therapy programs offered at each local facility. Artists create paintings, pencil drawings, sculptures, and wood working during therapy programs as a means

books, and journals about their life struggles and successes during therapy. Soloists, chorus members, dancers, pianists, and dramatic readings use the performing arts as a way to deal with their personal

Leaving very few dry eyes in the house, the NVCAF culminates with gallery viewings of the works of artists and writers followed by the incredible stage show on Sunday. These festivals are life-changing for all who attend as one experiences the transformation of veterans during the week of rehearsals and workshops. I was honored and blessed to represent Nebraska as the Northwestern Division VA&R chair and share a week of my life with these amazing people.

There are grants available through the ALA Foundation for funding local creative arts festivals.

CONSTITUTION & BYLAWS

As you read this article, you may ask the question... "Who is required to have a Constitution, Bylaws, and Standing Rules referred to as "governing documents?" Every level of The American Legion Auxiliary (ALA) organization beginning with National; all Departments (52 States including District of Columbia and Puerto Rico); all Districts (Nebraska has 13); all Counties, and all Units (2019 - Nebraska has 321 Units).

Updating the governing documents is an ongoing responsibility at every level of The American Legion Auxiliary. It can seem overwhelming and a daunting task to undertake. I heartily agree! It is certainly not a preferred or sought after activity. So, then, you might ask, "Why is this so important?" When reviewed, revised, and updated as needed or required by National or Department as those below, questions are easily answered by referring to the governing document. Disputes among members, problems, conflicts, and hurt feelings are likewise resolved before they become unsurmountable issues.

changes to the American Legion Auxiliary Constitution and Bylaws have gone into effect and are to be observed. However, Departments, Districts, Counties, and Units are **NOT** to make these Constitution & Bylaws revisions until National releases approved terminology for The American Legion Auxiliary governing documents.

Preamble: The fourth clause in the American Legion Auxiliary Preamble has been changed to read; "To preserve the memories and incidents of our associations in all Wars;"

Great-Granddaughters: As of September 1, 2019 new applications for Great-granddaughters' membership will no longer be accepted. Great-Granddaughters who are already members may remain members (grandfathered in) as long as annual dues are current. Should annual dues become delinquent, membership will be terminated and all further applications rejected.

Spouses: The "spouse" of a Veteran (male or female) may apply for membership to The American The following significant Legion Auxiliary. The spouse's application approval remains contingent on the Veteran's eligibility and the protocols and requirements set by The American Legion and American Legion Auxiliary.

Eligibility: Eligibility dates have been changed to April 6, 1917, to November 11, 1918 and any time after December 7, 1941. You may still use the old applications until new applications are made available.

So, in conclusion, as the American Legion Auxiliary celebrates its Centennial, we as members "Look to the Future with pride in the Past" and by embarking on the process of reviewing, updating, and revising our Constitutions, Bylaws, and Standing Rules we ready ourselves in preparation for a new era. The Constitution and Bylaws are the enduring foundation upon which we stand as an amazing organization serving the legions of veterans who have served and the Armed Forces who are serving this great country.

VISION 2020

Greetings, Visionaries ---

The vision of the American Legion Auxiliary is to support The American Legion while becoming the premier service organization and foundation of every community providing support for our veterans, our military, and their families by shaping a positive future in an atmosphere of fellowship, patriotism, peace, and security. This is the Vision Statement of the American Legion Auxiliary.

Currently, the membership for the Department of Nebraska stands at 63.10% of goal. As the Department of Nebraska, we have the opportunity to earn \$1,000 from National this year. How can we do this?

First, we need to "Vision" all the good we can do for our veterans and their families with the \$1,000. Next, to earn \$250, we must meet achieve 75% of our membership goal by December 7, 2019 (Pearl Harbor Day Award). Then, to earn another \$250, we must achieve 95% of our goal by May 18, 2020 (Armed Forces Day Award). Finally, we must reach our Department goal 30 days prior to the 2020 National Convention to earn the Celebration Award and \$500.


Now that you know the Vision we need to have to earn this \$1,000, all that we are asking each unit to do is to add one new member to their unit and reach 100% of your goal --- something that is realistic and attainable to help us "Stop the Slide."

275 units are on their way to "Clear Vision" by reaching the "Far Sighted Award" (25% of membership goal). 237 units have surpassed "Blurry Vision" (50% of membership goal). 151 units have Near Vision (75% of membership goal). And, there are 16 units that have already reached 100% or more of their membership goal. What "Clear Vision" they have!

You may have heard about an IRS regulation concerning Auxiliaries. The IRS regulation concerning auxiliaries to veteran service organizations states in part:

"At least 75 percent of its members are veterans, spouses of veterans, or related to a veteran within two degrees of consanguinity (i.e., grandparent, brother, sister, grandchild represent the most distant allowable relationships)."

This has been a regulation for many years, and with the recent review of the Auxiliary eligibility criteria, the issue was evaluated and the decision was made to ensure the organization was compliant. This means that no great or greatgreat-granddaughters can join the Auxiliary. Current members whose eligibility relationship is great-granddaughter, great-great granddaughter, or direct descendent can continue being a members as long as their dues are kept current.



Have you begun to work on your units' "One Week of Caring and Sharing for the Next Century of the ALA?" For one week this spring - April 1-7, 2020 - we are asking units to work together to contact all members of their unit. We want you to call members in good standing, members who still need to renew, and former members who need to rejoin (have not paid dues since 2017). We have handed out this Program Action Plan at Leadership school and District Fall Round Ups, and it can also be found at www.alaforveterans.com. The purpose of these calls is to let members know their membership is valued and/or they are missed.

In order to be a GREAT organization and have a GREAT vision, we need to make sure we are following through on our vision for this organization. No one can do it alone. Won't you help us "Stop the Slide?"




