In response to the call for defunding the nations police and watching a nation in turmoil, Department Commander Gary D. Wooten took it upon himself to draft a letter to local, state, and national law enforcement agencies voicing the Nebraska American Legion's support for maintaining law and order. Commander Wooten presented the letter of support to the Department Executive Committee (DEC) on June 28, 2020 and received a standing ovation for his work. In a unanimous vote of 21-0, the DEC voted to approve the letters as written and send them out to local, state, and national law enforcement agencies and American Legion Posts in the state.

The letter of support was sent out in the August newsletter to all 355 American Legion Posts, all Department, District, and County officers, and all Department Committee members. Commander Wooten asked everyone to share this letter with their local law enforcement agencies and to show that the Nebraska American Legion would be there to assist and support them in whatever capacity they needed.

Many Posts and Legion members took these letters and presented them to their local law enforcement agencies. The following responses were received:

Kearney Police Department Chief Bryan Waugh said, "I received the letter of support for law enforcement today from Commander Gary Wooten. I have shared a copy with our

entire organization. As a proud veteran and Post 52 member, THANK YOU! We truly appreciate it and have the same support and respect for our military, veterans." Lancaster County Sheriff Terry Wagner replied, "Dear Gary, I really appreciated you and The American Legion, Department of Nebraska, for making the effort your support of not just Law Enforcement, but for the nation as a whole. Your words really struck home and reassures those of us in law enforcement that we are not being judged by the actions of a few officers who are not in the job for the right reasons. Thank you again for your support."

Bellevue Chief of Police Capt. Tom Dargy said, "Dear Mr. Wooten, on behalf of the Bellevue Police Department, I would like to take this opportunity to personally thank you for your letter of support. Your support comes during a most difficult time, when it seems that Police Officers are not respected as they should be, so it goes without saying that we are very thankful for your support. Your organization is very important to our community. Thank you again for your support and if we can ever assist you in the future, please do not hesitate to call."

Department Sergeant-at-Arms Shannon Falk delivered the letter to the Nebraska State Patrol Office in Norfolk, Norfolk Police Department, Pierce County Sheriff's Dept., Madison County Sheriff's Dept., Stanton County Sheriff's Dept., West Point Police Department, Battle Creek Police department, and the Albion Police Department. He stated, "The response was extremely positive and each organization expressed their thanks and gratitude for Department's support."

Omaha VAMC Fisher House

The Fisher House program, established in 1990 by Zachary and Elizabeth Fisher, provides free temporary accommodations at no cost, for family members of hospitalized veterans and active duty military personnel. The Fisher House Foundation is committed to improving the quality of life for our men and women in uniform, veterans, and their families and caregivers.

The Omaha VA Medical Center is excited to have opened a Fisher House on our main campus! The open date was September 9, 2020.

The projected \$8 million project, which is being funded by the Fisher House Foundation, will features 16 fully-furnished suites and serve as a "home away from home" for the families of veterans or military service members receiving treatment at the Omaha VA Medical Center. The facility will also feature a large kitchen and dining area, an elevator and a full laundry.

Some items that are not covered in the public FAQ is that this service and eligibility applies to veterans receiving service through Care in the Community and staying in Omaha. Meaning, if the VA is paying for it via authorization, so if a veteran is at UNMC getting treatment overnight, family members are eligible. Two other caveats, parking is assigned near Fisher House within walking distance to include wheelchair access. Also, the term "family" is broadly defined to include relatives, close friends, and caregivers or the equivalent of familial support to a veteran while receiving extended episode of care.



October 1930 (90 years ago)

- Argonne Post 61 at <u>SUTTON</u>, Nebraska was honored at National Convention at <u>BOSTON</u> by being cited as one of the few posts in the United States to secure over 400 percent membership in 1930 over the previous year. The post was presented with a certificate of <u>DISTINGUISHED</u> Service.
- Eight stock-raising **HOMESTEADS** southeast of **ALLIANCE** are open to filing for homestead entry. The land is in the north part of Garden County and is good ranching land. Ex-service men have a 90-day preference beginning November 12. After February 11, the general public can file upon what is left.

October 1940 (80 years ago)

- Nebraska's champion **HOLDREDGE** Junior Drum and Bugle Corps carried off third place honors in the junior corps competition at the Boston **NATIONAL** Convention, from a field of 19 corps.
- <u>BENSON</u> Post 112 and <u>VFW</u> No. 2503 recently presented a flagpole and the <u>AUXILIARY</u> presented a flag to Omaha's new park in Benson.
- Young <u>CITIZENS</u>' contests are again in season in Nebraska and plans are underway for county contests in many parts of the state. Finalists will have a busy two days in Omaha, taking tests and being entertained by the Legion and the World-Herald. The 52 contestants will be guests of the Legion at the <u>BANOUET</u> on November 19 and of the World-Herald on November 20, when the <u>WINNERS</u> will be announced.

October 1950 (70 years ago)

- Eddie <u>MUNSON</u>, of Lincoln Post 3, was the winner of a free, 12-day trip to <u>HAWAII</u> in National Commander George Craig's Hawaiian Trip Membership Contest. Eddie signed up 402 members for 1950. He also had to prepare a 25-word statement on the how he signed up that many members.
- Should you be going through **LEXINGTON** some Sunday and happen to hear a loud buzzing sound coming from the direction of the football field, you will discover that the sound comes from a number of model **AIRPLANES** being flown by members of The American Legionsponsored Lexington Model Club. The Club, now under the direction of Legionnaire Don Ross, was organized in December 1948 with 8 members. The group has increased to 20 youngsters and 6 men. Assisting in the sponsorship are the Plymouth Dealers of Lexington.



Ploesti was the most decorated battle in the history of the American Armed Forces - 1,700 plus airmen took off on a volunteer mission - told half would not return to base. But if successful they would shorten the war by 6 months by destroying Hitler's gas station. The oil fields were more heavily defended than Berlin and more than one-third of the planes/men did not return to base. Five Medal of Honor were awarded.

Legionnaire in the Spotlight Alfred Zieg



Alfred Zieg was born on May 31, 1923 in Waco, Nebraska. Zieg graduated from Schuyler High School in 1941. A year after he graduated, Zieg moved to Las Vegas, Nevada to work for the Union Pacific Railroad. He stated that he went to Las Vegas because he could make 45 cents more an hour working there compared to Nebraska. While working in Las Vegas, Zieg decided to enlist in the US Navy and was sworn in on December 15, 1942 in Reno, Nevada. Three of Zieg's brothers were already serving in World War II.

Following his enlistment, Zieg was sent to California Polytech University for a three month long special radio program. Because of the special program, he never had to attend basic training and never did learn how to swim. After finishing his training, he was sent to Treasure Island in San Francisco for more radio training. Out of the 400 men who were in his group, Zieg was the only one that got every question correct on their initial math exam. The Navy then sent Zieg to Oklahoma A&M University for more radio technology training and then he was sent back to Treasure

Island for his official Radar Schooling. In 1943, Zieg had to take the "Oath of Allegiance to the US". The radar program was classified, and he was not able to tell anyone about the program or what he was learning.

On May 15, 1944 Zieg traveled to Portsmouth, VA to board the USS Wasatch (AGC-9). The ship was one of the first Amphibious Flagships in the US Navy. After finishing sea trials in the Chesapeake Bay, the USS Wasatch traveled to the Panama Canal and into the Pacific Ocean. The first stop for the Wasatch was the shores of New Guinea. Zieg shared, "When we started walking up the shore the beach was rocky. When we looked closer at the shore, we realized that the rocks were really live ammunition shells. We were lucky they didn't go off when we walked on them."

Zieg shared that while on the beach one of his shipmates had climbed up a tree to get some fruit. The shipmate fell out of the tree and Zieg raced to his rescue. He quickly ordered the other men to grab some green branches and start a fire so the ship would send someone to help. Years later at a ship reunion the shipmate that Zieg had helped save remarked that he wished he knew who had saved his life. That was the first time in over 40 years that the two had seen each other.

The USS Wasatch was deployed to join the other ships who were on their way to invade Morotai Island. While in the radar section, Zieg was the only one in their radar group who would climb up the SG Radar Antenna to change the antenna. The antenna was 120 feet up above the ships deck and there was no safety harness for the climb. Following the invasion of Morotai Island on September 15, 1944 the USS Wasatch took General MacArthur back to Leyte. This is when he made his famous comments, "I have returned."

In October of 1944 the USS Wasatch was right in the middle of the Battle of Leyte Gulf. Zieg remarked, "When we left the battle, we were surrounded by who knows how many ships. All you could see was ships everywhere." Over the next year, the ship remained in the area and was part of the Invasions of Lingayen, Balikpapan, and Wakanoura. After the atomic bombs were dropped on Hiroshima and Nagasaki, the USS Wasatch and Zieg were sent to occupy multiple cities in Japan. Most of the Sailors on the ship were contaminated with radiation while stationed there. In November of 1945, the USS Wasatch and its Sailors began to sail back to the United States. The ship traveled to Pearl Harbor and then to San Diego. Once his enlistment had ended, Zieg returned to Nebraska on February 22, 1946. On March 24th, he was married to his wife, Thelma, of 62 ½ years. Zieg noted that he and his wife never had dated during their courtship, but instead sent letters back and forth for many years. Zieg entered an eighteen-month training program through the local natural gas company and worked in both Scribner and Hooper. He retired from the gas company in 1985 after 40 years of working for them.

Starting in 1984 Zieg and wife started traveling following his retirement. They also began to attend his ship reunions in 1989. Prior to moving to Lincoln for his cancer treatments, he did lots of wood working projects and yard work in his free time. One of his favorite projects was the shadow box for his medals and ribbons pictured in this article.

Each year Zieg contacts the catholic school in Fremont to find out the number of students in the high school. He purchases a gold Presidential dollar to each of the students. The dollar has the Statue of Liberty on the back of it and Zieg stated, "I thought that by giving each of the students a coin, that they might better understand the sacrifice of all servicemen." Zieg gives the coins to the students at the Veterans Day program.

Zieg celebrated his 97th birthday on May 31 and received over 700 cards from all over. He also was commissioned as an Admiral in the Great Nebraska Navy. He has three children, Nancy, Tom, and James, all of who live in Lincoln.

Zieg is a lifetime member of the Scribner American Legion Post 121 and of the Hooper Veterans of Foreign Wars Post 10535.

To date, the Gordon Chapter 34 has raised over \$41,000 for the Swanson family in Gordon. The family has had a multitude of accidents and health conditions within their family.

I want to wrap this up by reminding all of the Legion Posts out there that these are the kinds of things that the Riders bring to the table. While not every Chapter is as active, or has a large group, we are all out there helping out in some way and bringing attention to the American Legion Families. What a difference a year makes! Veterans Day 2020 will most likely be different than it was in 2019. Will there be school programs? Will veterans be able to visit with the students? There will be a Veterans Day; we will just adjust to "the new normal."

This did make me remember when I was a child --- many years ago --- and think about what kind of Veterans Day we had. I do not remember ever having a school wide program, but we may have talked about the day. Why is there a Veterans Day? When did the day become a holiday? What did Veterans Day mean? But never a school assembly. No band music, no tributes, and certainly no speeches.

Neither of my Grandfathers or my

Father were in the service, so I really did not pay much attention to the day. I did realize I had four uncles who served in the Military --- two uncles on my Mother's side of the family and two uncles on my Father's side of the family. We knew about their service, but it was never discussed. They did not want to talk about it.

One uncle on my Father's side served in the Army during WWII. To his children, he only spoke a little about being in France and liberating some of the concentration camps. The horror he must have seen. No parades. No parties. Just went back to raising his family. My Father's other brother served in Korea. I know nothing about what he did in Korea. I do remember him coming home. Again, there were no parties or parades. He just went back to farming.

My Mother's oldest brother served in WWII. He was at the "Battle of the Bulge." When we lived in Hawaii, we were able to visit the Pearl Harbor Memorial on the Admiral's Barge during a visit my aunt and uncle made to Oahu. While visiting Pearl Harbor, a documentary was shown. That evening, he had nightmares. The memories were there; he just would not talk about them. He came home and went back to farming. No parties. No parades.

My other uncle on my Mother's side also served in WWII. I have no idea where he served. But, when he came home, he also went back to farming. No parties; no parades. He always felt badly that he enlisted and left for training before he received his high school diploma. When he was in his seventies, he went back to school and received his GED. His children were not aware he was going to school. They were all surprised when he showed them his high school diploma. He was so proud of himself --- and so were they! Both of my Mother's brothers were in the Army.

We all know how the Vietnam veterans returned. No parties; no parades. They went back to their jobs and started raising their families. There certainly were no school assemblies for Veterans Day during that period of our history.

So, when did the Veteran's Day ceremonies begin? What made everyone want to pay tribute to those who served their country? I would like to think that our Legion Family played a large part in these Veterans Day programs. Perhaps, because of the Legion Family contributing to our communities and schools, people began to recognize the sacrifices these men and women made in their lives. Communities wanted to pay tribute for what they had done for our country.

So, on this Veterans Day, I honor every veteran. I cannot ever say I understand the sacrifices each veteran has made, but I would like to say to each of you veterans that I am aware

of all that each veteran has done to give us what you have given to us as a country.

I am also aware that gives me an obligation to not just say I am an American, but that I understand what obligations I have to you and your service to my country. The obligation to make our communities, schools, and government my responsibility.

To all those who have served our nation, Happy Veterans Day!
