# Dan Benes Elected State Commander



Daniel E. Benes of Valparaiso was elected as the State Commander of the Nebraska American Legion during the 103rd Annual Convention held June 25 - 27, 2021, in Lincoln, Nebraska.

Benes is eligible for The American Legion through his 31 years of service in the U.S. Army, Army National Guard, and Army Reserve. He has been a member of The American Legion and Post 371 in Valparaiso for 41 years. He has served as District 7 Commander and Vice Commander, and Post Commander and Vice Commander.

### Why Should Veterans Choose To Use Veterans Affairs Health Care?

There are many reasons why veterans should consider using VA as their health care provider. One of the most important is the VA provides outstanding care to veterans and secondly VA health care providers understand veterans, their needs, and their unique health concerns. The focus of VA medical providers is that of serving veterans, thus their experiences and knowledge of treating veterans goes beyond the medical provider whose practice may see one veteran per month. By using the VA health care system veterans are providing important health care data that benefits current and future veterans in understanding how to better treat health care issues that present more often in veterans than the general US population.

As a Veteran Service Officer, I have had the opportunity to speak with many veterans across Nebraska regarding VA health care. The good, the bad, and the ugly of VA health care explained from veterans and their spouses/caregivers regarding their individual personal experiences. As a veteran I have been participating in VA health care for over 30 years and I have had many similar experiences as other veterans with whom I discuss this topic (good, bad, and ugly), in recent years I've had many more of the good experiences with the VA health care system than any other. Some veterans have informed me they had a terrible experience 20 or more years ago at the VA and have never considered using VA health care again. If one takes the time to reflect on different experiences throughout one's life, there are likely times in which we've each had a poor experience with a company or person that made us question why we would want to do business or be around such a person. Often one experience is just that and not the whole picture, or the future of such relationships. I encourage veterans who meet the eligibility requirements to enroll in VA health care and begin using the benefits they earned while serving our great Nation. For veterans who receive VA disability compensation (10% or above) and are currently enrolled in VA health care are eligible for no cost hearing aids and glasses. I can attest the VA health care system has significantly improved over the last 30 years and has expanded avenues for veterans to access health care to include "Care in the Community." The VA health care system through eBenefits provides for a Veteran to access their medical records, communication with medical providers, and prescription refills. We as Nebraska veterans are very fortunate in having quality VA health care facilities across our great State along with medical providers who participate in the Care in the Community program. If you have not using VA health care or have not considered doing so, I encourage you to contact your County Veteran Service Officer (CVSO) or VA eligibility at 1-877-222-VETS (8387) to apply for enrollment.



### (New Thing)

On Saturday, 22 May 2021, many Nebraska Legionnaires, and community persons observed the naming of our state's Highway (Hwy) 20 as NE Medal of Honor (MoH) Hwy. It came about because concerned individuals, like Daryl Harrison, American Legion NE Area A Vice Commander, and others, walked 432 miles from Wyoming border to South Sioux City to draw attention to a

few American service persons who gave their all-in sacrifice for their country during times of strife in many foreign scenarios.

But the question begged to be asked is: why aren't there more MoH persons who served, or are serving, our nation during our trials of strength? Remember when Abraham, our human spiritual father of faith, led a rescue effort to free his nephew, Lot, from the hands of the enemies of Sodom and Gomorrah (Genesis 14: 8-16)? There are untold examples of heroic efforts in Holy Scripture that would have earned various persons the MoH, but is this noble



award simply about getting medals, or focused upon human valor in rare times? What's wrong with anyone stepping up to fight for Jesus amid this country's seeming fall from grace and mercy (Galatians 5:4)?

When followers of God fall into Apostacy (2 Thessalonians 2:3), which is Greek for the counterfeiting of God's Gospel, they become caught up more in the world's fleshly attractions, rather than pursuing God's holiness (i.e., separate lifestyle unto the Lord) as noted in Romans 6:19. Apostacy is due to sin, followed by God's eternal damnation (2 Peter 2:3). Only Jesus may save such a one in spiritual peril (Ephesians 1:13).

Yet, all is not lost. The Coming Light of Jesus (Matthew 26:64) will dawn upon humankind after our brief suffering under the Coming Darkness prescribed by Satan's Anti-Christ reign with His second coming (1 Thessalonians 5:23). ### American Legion Department of Nebraska History Word Search

### July/August 1931 (90 years ago)

- Boasting of the 103 <u>MEMBERS</u> he has signed up for the American Legion this year, South Omaha Post No. 331 puts forward John <u>KRAJCEK</u> as the prize "Go-Getter" in Nebraska Legion circles this year.
- For the first time in history, the American Legion has reached the <u>MILLION</u> mark in its national membership, the goal being reached on July 3, one day ahead of the date which had been set.
- Representing himself as W. Bowen of <u>PLATTSMOUTH</u> and using an American Legion membership card as identification, a man was successful in putting over a <u>FORGED</u> cashier's check for \$100 drawn on the Farmer's State Bank of Plattsmouth at Davenport, Iowa this month. He passed the forged check and obtained an automobile from a Davenport Legion member who relied on the identification made thru Bowen's supposed Legion membership card.

### July/August 1941 (80 years ago)

- One of the outstanding features of the 1941 American Legion Department Convention <u>PARADE</u> in <u>HASTINGS</u> will be the <u>MOUNTED</u> Color Guards of the <u>LEXINGTON</u>, <u>COZAD</u>, <u>GOTHENBURG</u>, <u>SUMNER</u>, and <u>THEDFORD</u> Posts. These mounted color guards, in uniform with matched <u>HORSES</u>, will be something new in Nebraska Legion convention activities and are expected to spotlight the parade.
- "12 members have signed up for 1942," writes <u>PUBLICITY</u> Chairman F.M. Jones of <u>WINSIDE</u> Post No. 252 after reporting elections of new officers. "We have 13 <u>BACHELORS</u> in our post," he continues. Whether there is any connection between the two statements, he did not say.



I was running errands the other day when I ran into the former Ashland Mayor Paul Lienke. We were talking about his late wife Jeanie, who used to do a lot for us at Ashland Legion Post 129. Paul mentioned that Jeanie was buried in her hometown in Minnesota.

It came up that Jeanie's uncle Lloyd was aboard the USS Oklahoma when it went down December 7, 1941. To identify remains, scientists from DPAA used dental and anthropological analysis. Additionally, scientists from the Armed Forces Medical Examiner System at Offutt AFB, Nebraska used mitochondrial DNA and Y chromosome DNA supplied by family. Jeanie as well as other family members were proud and happy to help. Navy Seaman 2nd Class Lloyd R Timm was 19 years old when he passed. His remains were identified September 27, 2019; and he was buried May 25, 2020, in Wabasha, Minnesota, next to his Niece, Jeanie Lienke.

The Oklahoma, moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft December 7, 1941. The Oklahoma sustained multiple torpedo hits, which caused it to capsize quickly. The attack resulted in the deaths of 429 crewman.

From December 1941 to June 1944, Navy personnel recovered the remains of the deceased crew, which were subsequently interred in the Halawa and Nu'uanu Cemeteries. In September 1947, tasked with recovering and identifying fallen U.S. personnel in the Pacific Theater, members of the American Graves Registration Service (AGRS) disinterred the remains of U.S. casualties from the two cemeteries and transferred them to the Central identification Laboratory at Schofield Barracks. The laboratory staff was only able to confirm the identifications of 35 men from the USS Oklahoma at that time. The AGRS subsequently buried the unidentified remains in Honolulu, in 46 lots at the National Memorial Cemetery of the Pacific, known as the Punchbowl. In October 1949, a military board classified those who could not be identified as non-recoverable.

A single casket of USS Oklahoma Unknowns was exhumed in 2003 and showed evidence of extensive commingling. The remaining USS Oklahoma Unknowns were later exhumed between June and November 2015 so all remains could be analyzed at one time. Since then, DPAA anthropologists and odontologists, located primarily at Offutt Air Force Base, Nebraska, have worked to sort and analyze over 13,000 bones and associate them to missing Sailors and Marines. Genealogists from the Navy and Marine Corps Casualty Offices conducted research to find family members so that DNA testing could be conducted by scientists at the Armed Forces Medical Examiner System, all of which were critical components in the identification process.

As of June 1, 2021, 338 individuals from the USS Oklahoma have been identified, and they represent the first successful completion of a project of such complexity. Even more remarkable than the success of this project are all the families who were able to receive the remains of their loved ones.

National has continued to work on known issues and this has already proven to be a great tool for our membership.

The Sons of The American Legion continue to do great work across Nebraska. The Ashland Squadron 129 hosted their first annual charity golf tournament in June to benefit the Ashland American Legion Post and A Soldier's Child Foundation. The Gretna Squadron 216 hosted a Texas Hold'em Tournament in June to assist the Gretna American Legion, veterans, and their community. Sons members are often vital pieces of their Post Honor Guards around the state. Sons were active at Memorial Day ceremonies from Gering to Papillion, Osmond to Ohiowa, and everywhere in between.





Grand Island has a proud history of honoring and caring for its veterans beginning in 1887 with the establishment of the Nebraska Soldiers and Sailors Home. When the home moved to Kearney two years ago the City of Grand Island took over responsibility for looking after Veterans Memorial Cemetery. The Hall County Hero Flight Association is now leading a community effort to expand and upgrade the cemetery located at the southwest corner of the 600-acre Veteran's Home property.

The group is seeking state and federal designation for the cemetery. State cemeteries have eligibility like the Department of Veterans Affairs national cemeteries; however, residency requirements may also be included. Even though they may have been established or improved with Government funds through VA's Veterans Cemetery Grants Program, State Veterans Cemeteries are run solely by the state.

Last year the Nebraska Legislature unanimously approved LB 911 paving the way for development of the cemetery and the City of Grand Island lent support with a pledge of the additional acreage needed for the expansion.

The larger cemetery would serve veterans and their families for decades to come. The Nebraska State Veterans Cemetery will accept veterans from across Nebraska and the nation and provide for the internment of spouses. The state designation also requires that the grooming and ongoing maintenance and care of the grave sites, facilities, and grounds must comply with highest federal cemetery standards.

With that mission completed fundraising is now focused on securing the \$750,000 in local matching funds required for the \$7.5 million cemetery development cost. So far \$168,000 has been raised and the official fundraising effort was launched May 11th. Donations may be made to: The Hall County Hero Flight Association, 131 South Locust, Grand Island, NE 68801. The Veterans Cemetery Committee is led by Hero Flight Chairman, Don Shuda, and includes Don Smith, Vice Chair, Jay Vavricek, Pam Lancaster, Mike Ponte, Dan Naranjo, and other members of the community.

Please keep in mind that the DMS-acquired members in Post 500 remain a good source of members for your local posts and will also be receiving renewal notices, and those members may be inclined to renew and transfer into a local post if they receive some personal contact NOW.

Renewal dues for Post 500 are established at no less than the most expensive dues in the department, and that alone may well be a good enough incentive for those Post 500 members to transfer and renew into your post!!! Especially those members who joined Post 500 in just the last year. They just recently took the initiative to join. It's early in the renewal period. Your post's lower dues may help. Belonging to a local post should also be attractive.

Please process your regular renewals as soon as you start receiving them. Establish some kind of regular schedule for transmitting them, and don't hold on to them forever and a day!! There is an incentive for the individual "regular" Legionnaire who pays his or her dues early, a \$150 worth of incentive. Any member whose dues are paid AND transmitted (postmarked) to Headquarters by September 7th shall be in a drawing for \$150. Legionnaires, pay your dues promptly. 





Family (noun) 4. a: a group of people united by certain convictions or a common affiliation: FELLOWSHIP.

Help us grow our family stronger this year. Here is who we can ask to be members. Membership in the American Legion Auxiliary shall be

1) grandmothers, mothers, sisters, spouses, and direct and adopted female descendants of members of The American Legion;

2) grandmothers, mothers. sisters, spouses, and direct and adopted female descendants of all men and women who served in either of the following periods:

April 6, 1917, to November 11, 1918 and any time after December 7, 1941 who, being a citizen of the United States at the time of their entry therein served on active duty in the Armed Forces of any of the governments associated with the United States during either eligibility periods and died in the line of duty

3) grandmothers, mothers, sisters, spouses, and direct and adopted female descendants of all men and women who were in the Armed Forces of the United States during either of the following periods: April 6, 1917, to November 11, 1918; and any time after December 7, 1941 who served on active duty in the Armed Forces of the United States during either eligibility periods and died in the line of duty or after honorable discharge; and

4) those women who of their own right are eligible for membership in The American Legion.

Keep looking for more details to come on new and exciting family awards for the 2022 membership year. The first Renewal Notice is scheduled to be mailed to all Senior members on September 1st.

Music is energy. Energy is life. Is it no wonder that music is the only true universal language which can communicate to the masses, the newborns, the demented, and the dying?


