During the ceremony, guests were able to see the formation of troops, the presentation of honorees & colors, and the presentation of over 20 different types of scholarships. Guests were able to mingle after the ceremony and Suchy was able to chat with other Legion members, VFW members, and members of the local Forty and Eight organization. Suchy said he enjoyed the ceremony and seeing the students who will benefit from the Edgar J. Boschult Memorial Scholarship.

The American Legion, Department of Nebraska, selected four recipients of the 2022 Edgar J. Boschult Memorial Scholarship.

The scholarship is awarded to full-time students in the University of Nebraska system that are enrolled in military science courses or to honorably discharged veterans attending the University of Nebraska full-time.

The Edgar J. Boschult Scholarship was created in 1947 in memory of Edgar J. Boschult. Boschult was a veteran of World War I and Past Department Commander of the Nebraska American Legion. Boschult returned to serve his country in World War II and was killed in action on November 8, 1944.

The recipients of \$500 Scholarships are Grant Bowden, Lincoln, NE UNL (Air Force ROTC); Raen Lubben, Geneva, Illinois UNL (Air Force ROTC); Emma Brennan, Cedar Crest, NM UNL (Navy ROTC); Aiden Knopik, Lincoln, NE UNL (Air Force ROTC).



June 1942 (80 years ago)

• The year 1942 now ranks fourth highest in <u>MEMBERSHIP</u> in the 23-year history of the Nebraska American Legion. On June 15, the Department had 19,483 members.

• Robert <u>ACKERMAN</u> of Sydney, a nominee of the '<u>FEDERALIST</u>' party, was elected <u>GOVERNOR</u> of Cornhusker Boys State in the election held at the ag college in Lincoln on May 25. Ackerman is from a family that has been active in Legion and Auxiliary work. His sister, Joline, was a candidate for Girls State Governor just a year ago.

• <u>LINCOLN</u> Post No. 3 furnished about 60 members for duty during a <u>FLOOD</u> on May 11, in response to a police radio call. The men did rescue work, assisted in traffic direction, and performed other <u>EMERGENCY</u> aid. On May 15-17, various groups of Legionnaires went to homes of elderly people, most of whom had sons in the service, and helped in <u>SHOVELING</u> mud from homes and otherwise cleaning up.

June 1952 (70 years ago)

• The number 1 story appearing in this issue covers the preliminary work being done by Lincoln Post No. 3 in preparing for the annual Department <u>CONVENTION</u> to be held in Lincoln from July 20 to 22. Your individual presence at the <u>BUSINESS</u> sessions and participation in other convention activities such as the <u>BARBEQUE</u> and <u>PARADE</u> will measure the <u>SUCCESS</u> or failure of the 34th Department Convention. Conventions afford every member an opportunity to be seen and heard, either personally or through a post's <u>DELEGATION</u>, on any and all matters dealing with the Legion's programs. If your post is not represented at the convention, it is waiving these rights and privileges which rightfully belong to it.

• Warren <u>WOOD</u>, editor and publisher of the <u>GEHRING</u> Courier, has officially announced his <u>CANDIDACY</u> for the office of Department Commander. Endorsed by his home post in Gehring, Legionnaire Wood has received similar endorsements from posts at Bayard, Scottsbluff, and Mitchell as well as the Garden County American Legion organization.



Sergeant Gerald M. Biber

At various times during the 1950s and early 1960s, Special Forces advisors were forced to pose as members of the US Embassy Program Evaluation Offices, or the Combined Studies Group (CSG) in Vietnam. Either of these euphemisms strictly translated Central Intelligence Agency (CIA). Most CIA documents from Laos and Cambodia remain classified today.

CPT Walter H. Moon, Battalion Commander; SFC John M. Bischoff, team medic; SGT O. Roger Ballenger, demolitions sergeant; and Sergeant Gerald M. Biber, a radio operator from Benkelman, Nebraska; were assigned to Company B, 7th Special Forces Group, 1st Special Forces Command, and were advisors to the 6th Battaillo d'infanterie (Lao).

On April 22, 1961, the team was on a mission near Phou Tesao in the rugged jungle-covered mountains approximately 15 miles North-Northwest of Vang Vieng. The 6th was ambushed by a heavy and accurate enemy artillery barrage. The communists rapidly flanked them. The team radioed that the battalion was completely cut off, the perimeter defenses were collapsing, and Pathet Lao were quickly overrunning their positions. Shortly afterward, CPT Moon was taken as a prisoner.

SGT Ballenger, SFC Bischoff, SGT Biber, and some Royal Lao soldiers jumped aboard an armored car that was heading south on Route 13 to breakout. According to Lao survivors, they crouched behind the turret, but the car came under a heavy grenade attack. Bischoff fired a machine gun from the vehicle until he was shot through the neck and killed. SGT Biber, who had already been wounded, was "thought" to have been killed by stick grenades thrown against the armored car. The vehicle halted and its crew was captured. SGT Ballenger escaped through the jungle and linked up with a small group of Royal Lao soldiers, who were all captured seven days later. Ballenger was held in a massive cave complex at Sam Neua, which also served as the Pathet Lao headquarters. On August 15, 1962, after Geneva Agreements on Laos was signed, Ballenger was released to American control.

CPT Moon tried to escape twice during his confinement, and on the last attempt was wounded in the chest and head. After several months of persecution, CPT Moon was reportedly executed in his prison quarters. The Pathet Lao have consistently denied knowledge of Walter Moon, Gerald Biber, or John Bischoff.

Whether or not Gerald Biber survived the ambush on April 22, 1961, is unknown. Biber was among nearly 600 Americans who disappeared in Laos. Many of them were known to be alive on the ground. Laotians admitted "tens of tens" of American Prisoners of War, but these men were never negotiated for through the Paris Peace Accords. Laos and Cambodia were not a party to that agreement.

If dead, SGT Gerald Biber has a right to have his remains returned to his family, friends, and country. If he survived, his fate like that of other Americans who remain unaccounted for in Southeast Asia could be quite different.

If you have not already done so, please get your SDR submitted ASAP. Second, the Consolidated Squadron Report (CSR) is the most critical document our Squadrons can complete. The information provides a picture of the activities, volunteer hours, and donations provided by your Squadron. It allows for the national organization to provide an impact report of the Sons of The American Legion nationally. You should be reporting your Squadron activity from June 1st to May 31st each year. The CSR is due to Detachment headquarters on July 1. You can complete the CSR via MySAL, mail a paper copy to the Detachment P.O. Box 5205 or email to Sandy at actsecylegion@windstream.net. Third, remember to complete and submit your Squadron Officer Report after your annual elections. Please submit a report whether you hold elections or not. We are in desperate need of valid contact information for Squadron leadership across the state. The Officer Report can be mailed or emailed to the Detachment.

It has been an honor to serve the Detachment of Nebraska as your Commander. I have received the endorsement of the Benson American Legion and Benson Sons of The American Legion as a candidate for the high office of Commander once again for the 2022-23 program year. We are the largest Detachment in the Midwest Region, and it is time we become the example of success for the entire nation. For his Eagle Scout project, Adam designed and constructed a World War II D-Day memorial called Liberation Pointe to "honor the sacrifices of D-Day and WWII veterans," he wrote, "and to make sure that America's future generations do not forget what these men and women did for our country and for the world." The memorial is located on the grounds of the U.S. Army Heritage and Education Center in Carlisle, PA.

When Are VA Service-connected **Disability Ratings Protected?**

Recently a Veteran asked me how she would know if her service-connected disability compensation ratings were protected. A friend had informed her the Veterans Benefits Administration (VBA) has rules regarding protected disability ratings. Her question is one that I am usually asked about two or three times per year and I'm sure there are veterans who have never heard of a protected disability rating. This led me to believe a protected rating discussion would make a great article for this edition of Straight Talk. The rules she had heard about are referred to as the VA's 5-year, 10-year, and 20-year rule.

The Veterans Administration (VA); specifically, 38 CFR Chapter 1 Part 3 outlines the rules for the preservation of disability ratings preventing static ratings from being reduced under certain conditions. One important aspect to remember is that no disability rating should be considered for reduction due to "Schedule of Rating Disabilities" changes unless medical evidence establishes that the disability to be evaluated has actually improved (§ 3.951 (a)).

VA's 5-year rule protects veterans from unfair reductions in disability benefits. According to VA, a stabilized rating is considered a protected disability rating. Normally if a veteran has maintained the same disability rating for 5 years the VA will no longer require reexaminations for that specific disability. Furthermore, after five years, a disability rating can only be reduced if VA obtains medical evidence indicating the veteran's condition is substantially improving overtime on a sustained basis. To consider reducing a veteran's disability rating after 5 years VBA must provide an explanation as to why VBA is reasonably sure the veteran's condition will continue to show sustained improvement (§ 3.3237).

VA's 10-year rule states a service-connected disability rating that has been in effect for 10 or more years will not be severed except upon a showing that the original grant was based on fraud, or it is clearly shown from military records that the person concerned did not have the requisite service or character of discharge (§ 3.957).

VA's 20-year rule protects service-connected ratings that have been rated at or above a certain disability rating for 20 years or more and are considered continuous. According to the VA 20-year rule, VBA is not allowed to reduce a continuous rating below its original disability rating unless the rating was based on fraud (\S 3.951(b)).

If a veteran is assigned a 100 percent rating, VA should not consider reducing the rating unless material evidence shows a significant improvement in the veteran's ability to function on a day-to-day basis. If VA grants a veteran Permanent and Total disability (P&T), the veteran's service-connected disabilities are considered to be total (rated 100 percent disabling) and permanent (zero or close to zero chance of improvement). If VA determines a veteran's condition is permanent and total, they are protected from the possibility of a reduction and will continue to receive disability compensation at the 100 percent rate for the rest of their life.

I recently came across a video of a veteran being pushed in a wheelchair, and he sees an American flag on the ground that has fallen from the pole to which it was attached, he has the person who is pushing him take him over to the downed flag and he picks it up. Together they folded it in the proper triangle fold, and they sat it on a table, which was on the porch. Such reverence this man had for the flag that all veterans have fought under.

Since 9-11, there has been a rise in the number of flags flown at residences. On the two-block street that I live on, there are eighteen homes. Among those eighteen homes, ten homes have flag poles flying the red, white, and blue flying in their front yards. We get comments from people who visit saying how nice it looks to have so many flags flying in one area.

The American Legion has a program giving instruction to students about respect for the flag and the proper way to fold the flag. We need to continue instructing people about the etiquette of the flag, so it is never lost.

Another thought is that the hundred days of summer start Memorial Day weekend and continue until Labor Day. During that time families will go on vacation but remember that we should not take a vacation from our faith. Look for your faith denomination's house of worship and take the time to attend services. It's always enjoyable to worship with new people and see their traditions and different styles of the liturgy. It's always amazing to meet new people that have the same desire to serve the Lord.

My challenge for you this month is to instruct or inform people that are unaware of the etiquette of the flag.
