It is time for the 8822B updates. The Department still files your E990 with the IRS, but the correct/current responsible persons information is needed.

The ALAMIS user fees will need to be paid by December 15th for the 2023 year. There is no need to be concerned about this now. Two Unit members can sign up to use ALAMIS. Beginning with the 2023 year (now) your Unit membership chairperson can pay your Unit members' dues online. You need ALAMIS Full access and a credit or debit card. If you have interested members just send a request email to the Department Secretary with a current email address and you will be set up as a user. Remember there are three user types: 1 – Unit View – You can see your members information. 2- Unit Write – You can update members personal information. 3 – Unit Full – You have access to Unit Write and the ability to mark your members payments as soon as you receive them. If you choose Unit Full you are required to attend a brief instructional session.

Please track everything you and your unit members volunteer to do, their donations of time, miles, and dollars throughout the year. Start now by staying connected with all your members. Our members are the best volunteers in every community. Start reporting now so the year-end reports will be more accurate than previous years. I will be "counting" on you.

Welcome Members,

Our biggest struggle continues to be **collecting membership dues**. Our membership card is current from January 1 through December 31st; thereafter, it is expired. We all need our new ALA membership card on or before January 1st to maintain our "good standing" membership. Without close and prudent attention to paying our dues in a timely manner we are leaving our Districts and others on a slippery slope of declining Units. Now is the time we need to halt our losses. I compare payment of my annual dues as I do my house or auto insurance. It comes once-a-year, write the check, send it off and be a member in "good standing." Ladies and gentlemen we do not need a paper notice from the National organization to know we have this annual obligation that was earned for us by a beloved Veteran. The amount of our membership dues cannot compare to the sacrifices our beloved Veteran(s) made to allow us the privilege to be a member of the ALA. Your Unit, your District and your Department will be greatly appreciative. I know I will be! If need be, pay your 2022 and 2023 dues today.

As you send in your dues please keep your personal data updated. If you have a change in your name, address, phone number and/or email address, your Unit, your District and your Department need those changes. Simply complete a "Member Data Form" and send it to the ALA Department, P O Box 5227, Lincoln NE 68505-0227 or scan and email to neaux@windstream.net

Those members who hold a State Life Membership (SLM), please be aware that even though you paid your dues for life a long time ago, the Department is obligated to pay your National per capita dues each year. Why you may ask? Because the SLM process developed by Nebraska and another two or three Departments is not recognized by the National organization. Thus, at present time the Department is paying \$12.00 annually for each of our current SLM members into National. Thus causing the Department to be operating at a deficit. As an SLM member please consider sending a \$12.00 check to the Department to assist in the annual payment. With less than 1,000 SLM members it is costing the Department \$1,200 for every 100 SLM members. Units that have SLM members are also encouraged to send in a donation to the Permanent Membership/General Fund. I bought into the SLM process decades ago and I switched to PUFL a few years back. So it can be done.

You may have heard that National is proposing a \$6.00 dues increase for its portion of our Unit dues. Should that proposal be accepted at the National Convention, August 26 – September 1, 2022 then

that \$12.00 will increase to \$18.00 in the 2024 Membership Campaign year beginning in July 2023. Putting the Department in a greater deficit.

The Paid Up For Life (PUFL) membership process is a National one. If you feel you can afford to join this process now is the time to get that done before June 2023. The PUFL form will be in this newsletter. Find your age across the top of the chart and find your current Unit dues down the left column and where those two lines meet would be your PUFL payment due to National. All paperwork must go through the Department for verification purposes. So if you want to pay once and be done, PUFL is your method. Also it is important to know that as the current National per capita dues share in Department is \$12.00 that amount would be locked in and the National organization cannot come back to the Department for any additional dues from here on out. This past year I paid for my daughter and three granddaughters to be PUFL members and I do not regret the investment. They are all locked in and never need to worry of forgetting to pay their dues. It is the least I could do for my loved ones because my beloved Veteran(s) gave me that privilege first.

Membership is the foundation of any organization and the accomplishment it achieves. No member is ever expected to do it all, to make it happen by oneself, but to have the membership to participate in any way they are able to do so. Every member has talents and skills that can make a definitive contribution to your local Legion Family. Please be sure you are demonstrating the same. We never turn a volunteer away. We should never set aside a different idea or opinion – that is how we grow and flourish.

We all have pride of and more importantly appreciation of our beloved Veteran(s) who gave us the privilege of being an ALA member. We need to know our "WHY" and be able to tell that personal story. Start today and create a one-paragraph personal "WHY" story so you can share it with others. I am sure we would find some amazing "WHY" stories we never knew. This is my challenge to each member, do the "WHY" paragraph and send it to me via regular mail or email. I really want to know your "WHY." I would love to create a "WHY" booklet.

Unit Membership Clerk & District Presidents: You should have a yellow form to complete and get sent back to me. Please get that done today. Thank you to those Units that have sent in their yellow form from the membership card packet. Much appreciated.

American Legion Auxiliary Department Convention Department Executive Meeting June 23, 2022 Ramada Inn, Columbus, Nebraska

President Barbie Meyer called the Department Executive meeting to order at 1 pm.

Chaplain Pat Wiseman opened with a prayer. Jacki O'Neill led the Pledge of Allegiance. President Meyer welcomed all that were present.

The DEC meeting minutes from January 21, 2022, were presented. Vice President Vicki Ozenbaugh moved to dispense with the reading since they were given out prior to the meeting. It was seconded and the minutes were approved.

The DEC met with The American Legion to discuss a new the prospect of obtaining a new building in Lincoln. Mike Sheridan, a member of The American Legion Executive Committee moved to continue this communication and look forward to this building.

Crys Bauermeister, District 2 President moved that the Auxiliary put the same motion forward as the Legion did. Motion was seconded and carried.

The DEC returned to the meeting in progress.

Resolutions or recommendations from the District Presidents were requested. District 4 President Bonita Dickinson presented and moved acceptance of changes to the Uniform District Constitution. Motion was seconded and tabled

President Meyer asked the District Presidents if they had any units turning in their charters. They reported they had not been notified of any.

District 10 President, Tina Nelson said it would be easier to find minutes and finance reports if they were on colored paper. She moved that each individual section be on different colored paper. Motion was seconded. President Meyer called for the vote. One no vote.

Finance Chair Vicki Cyboron reported on the finance June 4 and June 6 meeting. Minutes of the meeting had been mailed to the DEC. and copies were available. Committee recommendations and resolutions followed:

By direction of the committee the following motion s were made.

Changes to the new Employee Handbook:

Cyboron moved that Juneteenth and the day before New Year's be added to the Paid Holiday list. Motion carried.

Cyboron moved that Part-time employee be eligible to receive holiday pay based on their standard work schedule. Motion carried.

Cyboron moved that absences caused by the closing of the office, upon the determination of the Department Adjutant and Department Secretary, will be paid absences for all employees based upon scheduled work hours. Motion carried.

Cyboron moved that vacation leave accrue on a monthly basis, e.g., during the first year of employment 3.33 hours/month will accrue. Vacation leave cannot be taken until the end of the six months of employment has been completed. Paid leave will not be allowed in advance of the six-month period nor before leave has been earned. Saturdays, Sundays, and Holidays falling within vacation periods will not count against vacation time. Up to 40 hours of vacation leave can be carried forward as of the anniversary of the hire date. Vacation will be counted in hours. It may be taken by hour, by day or by week(s). Employees must receive advance approval for vacation time from the Department Secretary. The Department Secretary must receive advance approval for vacation time from the Department President and Finance Chairman. Vacation requests that exceed two consecutive days must be approved four (4) weeks in advance and should be scheduled as to ensure the Department business can be conducted properly during the employee's absence.

District President 13 Amanda Washburn moved to amend the motion by adding instances of extenuating circumstances can be approved by the Department President and the finance chairman for vacation use.

President Meyer called for a vote on the amendment. Amendment carried.

The motion final sentence was amended to state: Vacation requests that exceed two consecutive days must be approved four (4) weeks in advance and should be scheduled as to ensure the Department business can be conducted properly during the employee's absence. Instances of extenuating circumstances can be approved by the Department President and the finance chairman for vacation use. Motion was carried

Cyboron moved to add "Paid" to the header <u>Sick Leave</u>. Motion carried.

The budgets were reviewed next.

Cyboron moved to accept \$6,375 as the budget for Children and Youth 2022-23. Motion carried.

Cyboron moved to accept \$45,580 as the VA&R budget for 2022-2023. Motion carried.

Cyboron moved to transfer \$55,250 from US Bank to Morgan Stanley in July. Motion carried.

General Budget:

Cyboron moved to accept \$188,450 for the 2022-23 General Fund Budget. Motion carried.

Cyboron moved to accept payment in the amount of \$200 per delegate to National Convention. Motion carried.

Standing Rules:

Cyboron moved adoption of an amendment to Standing Rule VA&R #8 to increase the amount given to Veterans who reside in the Nebraska Veterans Homes or who are patients in the VA Medical Centers for Veteran's Dollar Days from \$5 to \$10. Motion carried.

Cyboron then called upon Audit Committee Chair Barbara Washburn for a report on the Internal Audit. Washburn reviewed Audit Committee recommendations and Finance Committee responses.

Advisory Chair Kathy Mazur was picking up the National President. Committee member Beverly Neel reported on the June 4 Advisory Committee meeting. Minutes were mailed to the DEC and were available.

Historian Angie Foster led the committee to update the employee handbook. An annotated version of the updated handbook had been mailed to the DEC and copies were available.

Resolutions Committee Chair Donna Hatfield was called upon for any updates. There were no resolutions from the committee.

Parliamentarian, Lynne Wild was called upon to explain the process for consideration of the revision to the Department Standing Rules. "The revisions will be considered seriatim, which is Section by Section, but the reading of each section is not required. Ten (10) minutes of discussion will be allowed per Section, followed by a vote to adopt the revision as presented/amended. Only Sections that were modified in the Phase 1 revision are open for amendment. These Sections are listed on the Supporting Rationale paperwork."

Constitution and Bylaws Chair, Barbara Washburn addressed the DEC.

By direction of the committee, Washburn moved adoption of the proposed revision to the Standing Rules.

Section N - Membership

- Removed historical comment in #1a
- Removed duplicate paragraph in #5
- Made paragraph 7 gender-neutral and changed chairman to chairmen
- Per current Constitution Article VI-Finance, modification of dues is discussed on the convention

Section O - National

- Clarify that a \$100 donation will be presented during the National President's official visit
- Make #2a gender-neutral

Section - Conferences and Conventions

- Added a new paragraph at the beginning of the section establishing deadlines for submission and distribution of amendments and one-time resolutions
- Replaced "2 delegates-at-large" with "2 delegates"
- Removed capitalization and quotes around Member and Guest
- Added "units of the Department of Nebraska" for clarity of guest attendees
- Added a new paragraph for Risk and Compliance Committee reimbursement
- Deleted item #1 about Past Department Presidents being registered as delegates. The
 Constitution states that they are delegates-at-large in their units. Also their registration fees are
 waived by virtue of the fact that they are voice members of the DEC.

- Changed Department Chairmen to Committee Chairmen (per anticipated change to the bylaws)

- Changed committeewoman to committeeperson

Motion carried.

By direction of the committee, Washburn moved to amend Standing Rule Q – Membership, number 2 to increase senior dues by \$2. The annual dues to the Department shall be \$12.25 per Senior member and \$1.25 per Junior member effective with payment of the 2024 dues. Motion carried.

There will be a phase 2 next year.

ALAMIS FULL USER OPTION

National Membership Team has opened the option for any units to pay dues online to ALAMIS upon department approval! This level of ALAMIS access will be known as UNIT FULL.

Unit full capabilities:

- All the capabilities of Unit Write access PLUS:
- Pay membership dues through ALAMIS. Units will pay both the department and national portion of dues for members. The department dues will then be remitted back to departments on the same schedule as online and by phone dues. A separate report will be included that shows which units paid dues and which members were paid.
- Rejoin former members within their unit. ALL transfer requests of current members, expired members or former members will still need to be processed by the department.
- Enter new members and pay their dues. Note: If you require certain documentation on new members to still be sent to your department, advise your units accordingly.

There will be requirements to have Unit Full access:

- 1. Membership dues must be paid using a VISA or Mastercard (credit or debit).
- 2. All Unit Full users must attend a 30-minute virtual training session. Currently, we are planning on doing 3 trainings a month on different dates and at different times to accommodate the most people.
 - a. Unit Full Users will receive an email with the month's training schedule to register for a training once a request is submitted to the ALAMIS Help Desk. Users will not be granted access until after they have attended a virtual training.

From July 2022-December 2022 ALA NHQ will not be charging new UNIT FULL access users a user fee. Any Unit Full user who still has UNIT FULL access in January 2023 will be charged their annual user fee for the 2023 calendar year. The 2023 UNIT FULL user fee will be \$20.00 per user for the year.



DEFENSE OF POW/MIA ACCOUNTING AGENCY

The Defense of POW/MIA Accounting Agency (DPAA) worldwide mission is to provide the fullest possible accounting of the approximately 81,000 missing Americans from the Nation's past conflicts to their families and the Nation.

Section 523 of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 amended Title 10, U.S. Code § 1501a to authorize the Secretary of Defense to accept and use gifts of money, property, or services made on the condition that the gift be used for the purpose of facilitating accounting for missing persons pursuant to Title 10, U.S. Code § 1501(a). This authority has been delegated to the Director, DPAA.

MEDAL OF HONOR FOUNDATION

The Medal of Honor is the highest award for valor in action against an enemy force which can be bestowed upon an individual serving in the Armed Services of the United States. The Medal is generally presented to recipients by the President of the United States.

Some 3,454 Americans have received the Medal of Honor since it was first introduced in the 1860s. Many Medal of Honor recipients considered their award just being able to come home.

Nebraska has 70 Medal of Honor recipients. There are 30.000 Veterans in Nebraska. We work with active military and 30,000 Veterans in Nebraska and Veterans Groups such as Veterans of Foreign Wars (VFW), The American Legion, Disabled American Veterans (DAV), American Veterans (AMVETS), National Guard and other Veteran groups.

Phase 3 is just beginning, which is to "Ever Honor" the thirty-five Medal of Honor veterans buried in Nebraska. The plan is to purchase a wreath, decorate it with Medal of Honor flags, and display it. Complete details have not yet been finalized.
