

#### December 1931 (60 years ago)

When Legionnaires of Nebraska chose Joe HANEY of South Omaha as their junior vice **COMMANDER** this year, they didn't realize what a man they were picking but Joe demonstrated his championship qualities at the annual Thanksgiving Pancake Breakfast held by Martin Graves Post in Bellevue. Joe tied for first place with a record of 33 PANCAKES down and none up.

**RABBITS** in the LINCOLN, STRATTON, and BEATRICE vicinities will do well to take a holiday vacation and go visiting relatives in Australia for the Legion Posts in these places are planning to stage rabbit hunts to secure meat for needy families in Lincoln.

#### December 1951 (70 years ago)

National recognition for nine members of the American Legion from Nebraska was given through APPOINTMENTS at the recent meeting of the National Executive Committee of the Legion in **INDIANAPOLIS**. Henry H. **DUDLEY**, a member of Omaha Post 1 and former Department Adjutant of the Legion in Nebraska, was reappointed as National **ADJUTANT**, the highest executive office in the Legion.

American Legion posts and Auxiliary units are again participating in the GIFTS for **YANKS** program in Nebraska. This was once a national program which saw gifts distributed to all hospitalized soldiers during WW II. Nebraska has continued the program and now all hospitalized vets in the three veterans' hospitals and other state hospitals.

FAIRBURY Post 24 and its members are showing increased activities in the Sons of the American Legion SOUADRON. The men are aiding the boys in every way possible and are teaching them proper use of firearms and allowing them to shoot in the Legion rifle range. The post sponsored an **ARMISTICE** Day program in the forenoon then held a banquet and dance in the evening.

Nebraska American Legion stands **<u>READY</u>** to again serve the Nation, now at war, and in any possible way. This is shown by reports received from various posts throughout the state and by inquiries pouring into Department headquarters wanting to know what posts and members can do to help. Department Headquarters is prepared to keep local posts notified as rapidly as calls for **SERVICE** are made from the various government agencies.



Michael J. Bosiljevac was born October 9, 1945, in Omaha, Nebraska. He attended Creighton Prep high school and was commissioned through the U.S. Air Force Academy. He then received an Air Force Institute of Technology assignment to the University of Minnesota, where he received his master's degree in 1969. He went through undergraduate Navigator Training and Electronic Warfare Training. Bosiljevac next attended F-105G Wild Weasel upgrade training and was assigned to the 17th Wild Weasel Squadron of the 388th Tactical Fighter Wing at Korat Royal Thai AFB, Thailand.

While flying a mission over North Vietnam on September 29, 1972, he and his pilot, LtCol James W O'Neil were forced to eject. Bosiljevac was listed as MIA and reclassified to KIA in 1978. Officially he was captured but died in captivity. Major Bosiljevac's remains were returned to the United States on September 24, 1987. He was the subject of a TV movie in 1988, We Can Keep You Forever.

O'Neil and Bosiljevac were flying an F105G which was shot down by a Soviet Surface to Air missile. Both Bosiljevac and O'Neil ejected successfully, and landed 23 miles southwest of Hanoi. Radio Hanoi/Moscow/Cuba reported the capture of both pilots alive on September 29, 1972. O'Neil was subsequently transferred to Hoa Lo and repatriated March 29, 1973.

Upon his release, O'Neil stated that he had observed Bosiljevac in the parachute. On about the 5th day of confinement, he asked about Bosiljevac, and was told, "He is alive, well, uninjured, and luckier than you."

Inquiries from U.S. as well as family met with little response. The Socialist Republic of Vietnam (SRV) wrote to the family and claimed to have "no knowledge of Michael J Bosiljevac," yet on September 21, 1987, SRV provided his name, and his remains were returned to US control on September 24, 1987.

Bosiljeva was shot down at age 27, but it appeared he was closer to 33 years old when he passed away. Officially, as of 1978, Bosiljevac was a dead man, and no longer a "controversial" problem for either this country, or Vietnam.

Bosiljevac was a prize intelligence/technical catch for the Soviets. After receiving his B.S. degree, he received a Fellowship from the Atomic Energy Commission to finance his Master of Science Degree in nuclear engineering from the University of Minnesota. In 1968 he was assigned to the U.S. plutonium production plant in Aiken, South Carolina, and involved with the only "K" atomic reactor.

Soviet and Asian Communist regimes view POW/MIAs, not as a problem of humanitarian concern, but: (1) as leverage for political bargaining, (2) as an involuntary source of technical assistance, (3) as forced labor; (4) to obtain hard cash and needed goods, and (5) to turn them into human guinea pigs.



It is likely that Bosiljevac fell into at least two of these five categories. A Senate report added that Communists POW/MIAs as commodities began with Vladimir Lenin.

Adjutants, it is your job to get membership processed as you receive it. Do not hold on to memberships and risk costing your fellow members their benefits. We also have many Squadrons who are doing an outstanding job with membership and should be commended. Membership is the lifeblood of our organization, and it is the responsibility of every member!

The National Organization has reported that they will have the "renew online" option available to every member starting

January 1, 2022. They will utilize the Squadron Data Report (SDR) that was submitted this past May/June. Nebraska had very few Squadrons submit this form, and this will become very problematic. The National Organization will charge each member whatever rate was reported by your Squadron Adjutant on the SDR. Your Squadron may be shorted dues if you have not provided an updated form. Adjutants must correct this immediately!

Senior Vice Commander Eldon Kramer invited me to Gering to attend their flag education program on November 5, 2021. It was an honor to attend the program for the 5th graders of Gering Public Schools. The Gering American Legion Family Honor Guard did an outstanding job teaching flag etiquette. They covered how to raise and lower the flag, the meaning of the 13 folds, and how to fold the flag. Every 5th grader received their own 3X5 flag to practice folding and to take home with them. They also recognized a group of younger Gering boys who stopped their football practice after hearing the National Anthem being played at a nearby baseball game. Each were presented a flag to recognize them for their outstanding display of respect for the flag and the anthem. I decided to take my kids with me, and they loved walking around watching the other kids learn how to fold flags. My kids were also presented flags. ### Membership Minute Steve Bartos, Membership Chairman

December 2021. For the most part, we've survived another year of the pandemic. There were disruptions, of course, but things have improved and our activities have started getting back on track. Let's hope that the improvements continue.

I'm glad to report that Nebraska met and exceeded the 65% goal on the Veterans Day target date, by several percentage points. And our renewal rate was over 70%. Those are both good signs, but we must keep our feet on the gas and be a little more relentless in our effort to win the Big 12 competition again this year.

Commander Benes has made a pledge of 91.15% of the goal by the March 2022 target date. We must reach at least that number or be disqualified from the competition. Three departments in our category have pledged more and five have pledged less. Because the two highest pledges were aggressive (94.25% and 94.00%), Nebraska has a good chance of winning first or second place if we can get our numbers up in the 92-93% range.

### District 11 S.A.L Membership Award Nathan Deke

The 7th annual Membership award will be presented at the District 11 Convention to the squadron having the Highest Membership Percentage out of the 21 squadrons in District 11 on December 31, 2021, for the 2022 membership year.

District 11 Convention is scheduled to be held in Crete, on Saturday, March 26, 2022. The Squadron Commander and Adjutant should both receive a letter of notification if their Squadron is the recipient of this award in January.

The following Squadrons have received this honor in the past: Milligan, Exeter, Geneva, Friend, and McCool Junction. McCool Junction received the plaque for having the highest percent of 118.75 with three more members than they had in 2020. Exeter had a plate engraved on their plaque for having an increase of eight members and 108.42%. They were the only Squadron in District 11 having over 100% membership turned in out of the 23 Squadrons in District 11 on December 31, 2020.

I wish I did not have to get into this, yes two SAL charters were pulled from Squadrons for inactivity, not responding, and no membership for multiple years. Unfortunately, there were eight Squadrons including these two had no membership turned in on the December 31, 2020, Membership Report that we used to determine the winner of the 2021 award plaque. We would like to thank and very much appreciate District 11 American Legion for the financing of this membership project. Our goal of this award is to promote timely membership turn in and increase the membership of all branches of The American Legion Family as well. I am sure many of you are aware that when one member passes away, their shoes are not easy to fill, so if you know eligible members for one branch of the Legion Family pass it on to get them involved. Please remember that you are eligible for membership both Sons and Junior Auxiliary Memberships on date of birth. It is a true fact that the Sons, Junior Auxiliary, and Auxiliary have members with more years of continuous membership than their age is. When your child, grandchild, niece, nephew or whatever the case may be, when they are at a young age, they are not capable to join on their own. So, if you know of a youngster, or someone, that you would like to see be awarded with a 50, 60, 70, or 80+ year Continuous-Membership Certificate someday, please remember shopping does not get much easier than purchasing them a membership.

For us, that's aggressive, too!!! But let's do it!!! Let's shoot for 93%. If the three departments who have pledged more than we did all fail, we must make sure we get to the 91.15% mark.

I had a sense that we were slower this year in receiving the first batch of dues you all submitted. But have caught up to where we usually are at this time of year, in the top 10 or so departments. Not sure the reason for that. Troubles with the new MyLegion switchover, perhaps? I know that there were at least some posts that had dues notices that went out to their members with some errors on them.

Perhaps it's a little earlier than you usually do it, but let's think about starting to check your rosters and delinquent lists and getting every 2021 member caught up for 2022. Maybe you have some members who were somehow removed from the list of renewal notices that went out from Indianapolis by some kind of glitch in the system and we don't even know it.

Remember that you can still use MyLegion to access a list of folks who are former, existing, or current members of Post 500. I remain convinced that Post 500 is a terrific source of Legionnaires who we somehow couldn't or didn't try to identify and are now sitting there just waiting to be contacted and asked to move into YOUR local post.

Please be reminded that December 8, 2021, is the cutoff date for removing names from January 7, 2022, renewal notice from National Headquarters.

On behalf of myself and the Department Membership Committee, I certainly wish you the Merriest of Christmases and the Happiest of New Year'! I hope to see some of you at the Mid-Year Conference.

### VA Acknowledges Backlog of Claims at VBA

As of second week in October 2021, the Veterans Benefit Administration (VBA) confirmed there were over 204,000 claims pending more than 125 days (VBA goal is to complete decisions in an average of 125 days). VBA is projecting over 260,000 claims will exceed 125 days "pending" in the next few weeks resulting in an increased backlog by over 50,000 claims by November 2021. VBA identified more than 70,000 claims alone stemming from the presumptive relationship between Agent Orange and Parkinsonism, bladder cancer, and hypothyroidism.



Beginning in March of 2020, the Federal Records Centers closed except for responding to emergency requests for records, this combined with the inability to schedule Compensation and Pension exams contributed to and to some extent is still contributing to the large backlog of pending claims. Veterans may be better able to have their claims processed sooner if their claim is fully developed, meaning to have the claim ready to process upon submission to VBA, this includes submitting a medical opinion and Disability Benefits Questionnaire completed by a private medical provider. To learn more about submitting a fully developed claim I recommend discussing this option with your local County Veteran Service Officer (CVSO). Although VBA has indicated they will be hiring and training 2,000 new

employees to assist in reducing the current backlog of claims for Compensation and Pension, it appears VBA may be on track to still have a backlog of claims for the next three years. VBA has also been authorizing overtime and according to recent reports the backlog has actually reduced by more than 14,000 claims since August 2021; however, based on their own data this appears to be a short-lived reduction. To learn more about the current data regarding VBA claims you may visit the Veterans Benefits Administration Reports website at https://www.benefits.va.gov/reports/detailed\_ claims\_data.asp. This website provides several points of data of interest with regard to VBA claims. VA extends the presumptive period for Persian Gulf War Veterans

The United States Department of Veterans Affairs has extended the presumptive period from Dec. 31, 2021, to Dec. 31, 2026, for qualifying chronic disabilities rated 10% or more resulting from undiagnosed illnesses in Persian Gulf War Veterans. Currently the presumptive list for Veterans of the Persian Gulf War are certain medically unexplained illnesses related to Persian Gulf War service without regard to cause, including, chronic fatigue syndrome, fibromyalgia, and functional gastrointestinal disorders. Also included are undiagnosed illnesses with symptoms that may include but are not limited to abnormal weight loss, cardiovascular disease, muscle and joint pain, headache, menstrual disorders, neurological and psychological problems, skin conditions, respiratory disorders, and sleep disturbances. If you have any of the conditions or symptoms listed above and served on active duty on or after August 2, 1990, in the Gulf War Theater of military operations, I encourage you to contact a CVSO to discuss filing a claim for benefits for which you may be entitled.

Through email exchange with the committee, we identified several areas of concern. Most of those issues, if not all, issued by The American Legion has little means of influencing. Veteran Rehabilitation and Employability Programs are well established, administrated,

and evaluated at state and federal levels. Leaving the question, what should the VR&EC address that can have a real and measurable positive impact in supporting Nebraska Veterans?

Let us give credit where credit is due while remembering that sometimes you cannot see the forest for the trees. I emailed our Department Commander Dan Benes. I just was not happy. A true and needy issue was not showing up on the radar. Commander Benes had been attending and reading about the status of our Nebraska Veterans Homes. Some could say it was a stretch to categorize this as an issue of the VR&EC. But sometimes an issue is in such immediate need of being addressed you must take that stretch as a leader to ensure the problem is acted upon ASAP. Hats off to Commander Benes, we did not miss the boat.

This is one of those issues. We the Legionnaires of Nebraska and our Legion Family must help in any way we can to alleviate the staffing problems of Nebraska Veterans Homes. There is a way for Legionnaires, Auxiliary, Sons of the American Legion, and Legion Riders to bring to the table what is needed to make a difference as quickly as possible.

John Hilgert, Nebraska Dept. Of Veterans Affairs Director has told us about the staffing problems of our Nebraska Homes. It has not improved since our Annual Convention. This problem has resulted in Nebraska Homes are no longer receiving residents. That means that our Nebraska Veterans in need of care and eligible for care in a Nebraska Home must go somewhere else. If they can find somewhere else! I have arranged for Director Hilgert to attend the Mid-Year Convention at Columbus in January to present to us where this problem is and the vehicles by which his department is trying to solve the situation.

In the meantime, I am working to fully develop The Legion's answer. We are in direct contact with the Nebraska Veterans' Affairs. The groundwork is being laid. Please keep an eye out for communications from your District Commanders and other Department offices regarding this matter.

These are the times I know why I am a member of the Legionnaire Family. These are the times we all come together as a family to help our fellow veterans that cannot help themselves.

### **CONSTITUTION UPDATES** PART 3- MORE TO FOLLOW

Section 1: (Amendment 1B) The Department of Nebraska American Legion Auxiliary Bylaws shall be automatically updated when changes are made to the National Organization governing document; thus, no formal resolution shall be required to make said changes. Updates shall be effective immediately.

The Department of Nebraska governing document shall be in compliance with the National Organization and shall not set forth any change that would be greater than that provided through the National Organization.

The Department Executive Committee shall review all changes to ensure they have been properly updated

Notification of automatic updates shall be placed in The American Legion Auxiliary Department of Nebraska Star publication. (6/26/2021 Lincoln)

Section 2. (Amendment 4B) The Bylaws may be amended at any Department Convention by a two-thirds vote of the Department Convention delegates, provided the proposed amendments shall have been submitted through the Department Secretary to the Units and members of the Department

Executive Committee by distributing same to them at least twenty (20) days prior to the convening of the next Department Convention; and provided further that all proposed amendments shall be read at a regular meeting of the Department Convention except when Department Convention delegates will have approved suspending the reading of a specific proposal. Units shall be responsible for distributing the proposed amendments to their delegates to the Department Convention. (6/26/2021 Lincoln NE)

Section 3. Amendments proposed after distribution by the Department Secretary may be adopted by a two-thirds vote of the Department Convention delegates, provided they have been read at one meeting of the session prior to taking the vote. (6/26/2021 Lincoln NE)

Section 4. An amendment not having been previously read or distributed may be adopted by the unanimous vote of the Department Convention delegates. (6/26/2021 Lincoln NE)

Section 5. Each proposed amendment shall be in writing and shall be signed by the member or members proposing it.

We have made it easier for everyone by providing links on the Department website to sample Uniform Unit Constitution, Bylaws, and Standing Rules. The Constitution and Bylaws sections were updated

I have a little quiz for everyone those documents. The Standing Rules section contains examples of items that a unit might document for its members. Every unit will likely have different standing rules, which is as it should be as every unit is unique.

> It is critical that every unit update its governing documents this year to reflect membership eligibility changes and the provisions for holding electronic meetings. Those items are covered in the "Uniform' document.

> District Presidents will be receiving copies of this updated document, so please contact yours to receive a paper copy if you aren't able to download an electronic copy. I would love to be able to report 100% of units have updated their governing documents. I will also be working with counties and districts to revise their governing documents.

Quilts of Valor were presented to three Crete veterans on October 5th at Veterans and Friends. Recipients of the quilts were (1 to r): Harold Clark, Dale Rigby, and Wally Wild.

Harold Clark enlisted in the National Guard in El Campo, TX in 1954 as an Administrative Assistant. In 1958, he switched to the Regular Army and received training at Fort Carson, CO and Selfridge Air Force Base in Flint, MI. In 1959, Harold was shipped to Germany where he received top secret clearance to work in discreet missile and radar sites and received special training at the NCO Academy in Bad Toelz. He returned to the states in 1962 and was stationed at the Crete Missile Site until June 1965 when he was honorably discharged.

Dale Rigby joined the U.S. Navy in 1957 at the age of 17. He completed boot camp at the Great Lakes Naval Academy in 1958. That same year, he began serving on the USS Intrepid CVA 11. He

was the Captain's Yeoman for two years. In addition, when the sailors were in general quarters, his job was to report to a 5" gun and help with ammunition. His time at sea was spent in the Mediterranean Sea, in the Caribbean Sea, and in Guantanamo Bay. Rigby was released from active duty and honorably discharged on Sept. 21, 1960. He completed his reserve obligation and was released in March 1963.

Wally Wild joined the Army after high school in 1953. After completing basic training, he was deployed to Manheim, Germany where his unit served as members of the Early Warning Radar team. Wally spent his entire active duty in Germany.

Presenting the quilts were American Legion Auxiliary Unit 147 officers Shirley Mariska, Diana Pomajzl, and Gerry Johnson. Paula Valenta introduced the veterans and read their military achievements.
