In 2016 the first Veteran Treatment Court (VTC) was established in Nebraska, specifically Douglas County. This new program was brought in from Buffalo, New York to help Nebraska veterans transition back into civilian life. Judge Robert Russell started the program in Buffalo in 2008 from the cases he saw in the Drug and Mental Health courts affecting veterans. These veterans were trying to cope with no longer having the military structure that they had when they were serving our great country. After Judge Russell started his VTC Program, another similar program was created in 2010, Justice for Vets (JFV) which helps with the rollouts of VTC programs. This non-profit is dedicated to transforming the way the justice system identifies, assesses, and treats our veterans, leading the national effort to put a VTC in reach of every veteran in need. In doing so, we keep veterans out of jail and prison, preventing the loss of one of our nation's greatest assets to our families and communities, and connect them with the benefits and treatment they have earned. JFV has over 250 VTC, trained over 3,000 court staff, and conducted over 40 volunteer veteran mentor boot camp trainings. These Veteran Treatment Courts give veterans a second chance to establish a substance-free lifestyle. They receive the necessary skills to help them with their sobriety. The VTC is made up of District Judges, County Attorneys, Public Defenders, Probation Officers, the police, mental health, and substance abuse counselors. The Veterans Affairs shares their staff and fellow veterans who help mentor the VTC participants. This program lasts 18-24 months depending on each case. It is an intensive program with weekly testing and veterans must either find a job or go to college, and they must meet their financial and family responsibilities. Veterans receive Department of Veterans

Affairs and State counseling to address their physical and mental health needs, all while saving the tax-payers hundreds of dollars. In short, VTC is designed to help justice-involved veterans develop life habits and skills which enable them to live as law-abiding, productive citizens.

A fellow veteran and a Lincoln Attorney, Jim Cada, was one of the driving forces to get the VTC established in Nebraska. The Lancaster County Veteran Treatment Court (LCVTC) was established in April of 2017, followed by a VTC in Central Nebraska in 2021 with the help of Judge Ryan Carson. Jerry Cummings, an LCVTC mentor, said "These veterans are truly remarkable, it's wonderful to see them grow as individuals and repair their relationships with family and friends as they go through the treatment process." He added that he's also enjoyed building personal relationships with his fellow mentors, about half of whom are Vietnam veterans.

On November 22, 2021, John Arias, Jerry Cummings, Jason Lybarger, Burdette Burkhart, and others presented Governor Pete Ricketts with a Lancaster County Veterans Treatment Court Mentor Coin in appreciation of his unwavering support for Nebraska veterans. Our Department American Legion Rider Liaison, John Arias, is very involved with Nebraska's VTC, mentoring multiple veterans. When asked about his reasoning for volunteering, Arias said, "To mentor veterans and help them get back on their feet. Mentoring veterans is not a yearly or monthly commitment, it usually involves daily or weekly contact. I used to drive to Lincoln from Wood River every week to sit in court with my veteran mentee; it was at least a four-hour, weekly commitment, not to mention the hours talking on the phone or texting each day." Arias's reasoning sounds similar to Theordore Roosevelt Jr.'s reasoning for creating The American Legion in the first place. Every veteran and civilian benefits from having a support system.

Along with the great people involved with the program, there are also the judges that work with this program to help those in their communities. "The judges set the tone for this program and we're lucky to have Judges Robert R. Otte and John A. Colborn. These men are fair, engaging with the vets, consistent in their application of punishments and rewards. They are patient and sincere. They treat everyone with respect," said Cummings. The LCVTC also honored the Honorary Chief Justice Michael Heavican at a secondary coin ceremony. Heavican has helped the program and those involved with it to be able to stay on task and implement more change for our veterans. For many people, this system helps them get back on track to a more fulfilling life, maybe a new beginning.

January/February 1942 (80 years ago)

- <u>HUBBLE</u> Post No. 317 designated four of its members for appointments as deputy <u>SHERIFFS</u> under the county sheriff. The post also has a committee to cooperate with the <u>FBI</u> office.
- Purchase of one <u>**DEFENSE BOND**</u> each month out of the proceeds earned by the organization marks the first step in the <u>**WAR**</u>-time program established by John Farley Post No. 86 of **ATKINSON**.
- Post No. 43 of <u>WAYNE</u> has donated \$25 to the Red Cross and has pledged to buy defense <u>STAMPS</u> every time it meets. The post buys \$1 worth of stamps and this is offered as a prize to some members who have bought at least 25 cents in stamps.

January/February 1952 (70 years ago)

- Nearly 300 American Legion Posts and Auxiliary Units in the Department of Nebraska contributed gifts or money for the "<u>GIFTS</u> for <u>YANKS</u> Who Gave" program this year. Over 1,000 packages and over \$1,000 were sent in to make a happier <u>CHRISTMAS</u> for hospitalized Veterans.
- One hundred fifty members of Hay Springs Post turned out on the evening of January 16 to greet Department Commander Peter <u>MARCHETTI</u> and enjoy a deer <u>BARBEQUE</u> prepared and served by Vice Commander Don Strotheide and the members of his losing team in the 1952 membership drive.

January/February 1972 (50 years ago)

- Funeral services were held Tuesday, December 21 for Frank B. O'Connell, 79, Lincoln, who passed away after a lingering illness. Col. O'Connell was named the first Department of Nebraska <u>ADJUTANT</u> in 1919, a position he held for seven years. A <u>CHARTER</u> member of the organization, he also served as Commander of Lincoln Post 3 and later served as Department <u>HISTORIAN</u> for several years.
- Two bills, H.R. 11651 and 11652, relating to improving veterans' **PENSION** rates and providing for a 10 percent increase in the monthly dependency and indemnity compensation rates, have been signed into law by President **NIXON**. The two bills are the direct result of a resolution originating in the Department Rehab and Employment Committee. The resolution was adopted at Department Convention at North Platte and sent to National Convention in Houston for further approval.



One Aircraft, Two Nebraska Marines:

Captain Doyle Robert Sprick entered the U.S. Marine Corps from Fort Calhoun and Second Lieutenant Delmar George Booze entered the U.S. Marine Corps from Omaha. Both were members of the Marine Attack Fighter Squadron 314, Marine Air Group 11, 1st Marine Air Wing. Sprick was the pilot and Booze was the bombardier/navigator aboard their McDonnell Douglas F4-B Phantom II.

The F4-B Phantom used by the Air Force, Marines, and Navy air wings served a multitude of functions, including fighter/bomber, interceptor, photo/electronic surveillance, and reconnaissance. The two-man aircraft was extremely maneuverable and handled well at low and high altitudes. Most pilots considered it one of the "hottest" planes around.

On January 24, 1966, Doyle R Sprick, pilot, and Delmar G Booze, radar intercept officer, comprised the crew of an F4-B that departed Da Nang Air Base in a flight of F4-B Phantoms on a strike mission into enemy-held territory northwest of Da Nang. The crew of another aircraft in the flight consisted of Capt. Albert Pitt of Hampstead, NY and Lawrence N. Helper of Logan, Ohio.

At 1005 hours, both F4-B Phantoms rolled in to attack an enemy target hidden in the lush, jungle-covered foothills rising out of the coastal plains. After a successful drop, they both pulled off target and were on their way back to Da Nang Air Base. That was the last radio transmission from either aircraft reported.

Extensive visual and electronic search and rescue efforts were initiated for the fighters that were believed to have been downed by enemy ground fire. Because the area of loss was under total enemy control at the time, no ground search was possible. When no wreckage was found for either aircraft and no contact with either aircrew could be established, all four men were declared Missing in Action (MIA) and are memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific.


In 1969 a ranking communist member provided extensive, detailed information pertaining to a specific Viet Cong ran Prisoner of War (POW) camp located near the city of Hue in which large numbers of American POWs were held. The member also reviewed photographs of POW/MIAs to assist US officials in identifying any prisoners held in that camp.

On April 11, 1969, he positively identified Albert Pitt as having been one of 22 POWs held there but was not able to provide information about Helber, Booze, or Sprick. None of the families of those men listed as possible POWs were ever told of this report until it was declassified 17 years later.

The military is called upon to fly and fight in many dangerous circumstances, and they are prepared to be wounded, killed, or captured. It probably never occurs to them that they could be abandoned by the country they so proudly serve. To quote my good friend Danny 'Greasy' Belcher, whom I served with at Fort Knox and Vietnam,

"Definition of G.I. - Gone Indefinitely."

Happy New Year!!

I hope everyone enjoyed the holidays and is ready to embark on a new year. We haven't achieved the "normality" I hoped for a year ago, but I think we're making a little progress pandemic-wise. Let us hope.

I'm not sure what the real cause might be, but Nebraska is struggling to meet our target membership percentages. I'm happy to report, however, that we just snuck by and achieved the 75% target on December 15th. We made it by 198 members.

Are our Legionnaires just not so eager to maintain their memberships as they have been in the past? Or are they paying their dues and then not having them transmitted to Lincoln by the local posts? Either scenario results in us lagging behind in the race to achieve 100%.

It's December as I write this article, and we have posts, some large posts, who have transmitted less than 25% of their memberships. I find it hard to believe that the low numbers in those posts aren't the result of dues not being transmitted.

I've contacted the district commanders and asked them to contact the posts with such low numbers to see what the problem might be. I hope they've done it, but there hasn't been much movement in some of the posts who are farthest behind. Perhaps a poke with a sharp stick from above wasn't as effective as a poke from the individual post members.

Please. Do me a favor. Do Commander Benes a favor. Do the Nebraska American Legion a favor. The most recent Nebraska membership analysis is posted on the home page of the Department of Nebraska website. Let us take a look at it and see where your post stands. Every post should have been at 75% of the goal on December 8th. The next target percentage is 80% by January 20th (just prior to the Mid-Year Conference). 85% will be the goal on February 9th.

If your post is lagging, especially if they are lagging by a worrisome percentage, talk to your post adjutant or post commander. Find out if the low numbers are truly a "renewal" problem or more of an "administrative" problem. In either case, perhaps something can be done to help resolve the shortfall of paid memberships. Unfortunately for some of our loyal Legionnaires who have paid, they might be receiving unnecessary renewal notices if their memberships have not been processed.

If and when you determine that your post really does have a "renewal" problem, keep in mind that the "easy" renewals have paid. The "tougher" ones are still out there! The direct renewal notices have done some good work, but it's now up to the membership go-getters in each post to finish the job. I'm looking forward to the Mid-Year Conference in Columbus. Let us hope that we can build some enthusiasm in our membership team, which includes all of us, and stay on track for meeting our goals.

He attended New York State's American Legion College when denied entrance to National American Legion College. He had input in writing a resolution so that Vietnam veterans could independently attend the National American Legion College. Vietnam veterans can now attend the National American Legion College. He attended this past November.

At the National American Legion College, he was part of a group that developed a resolution urging training be made available from the Blue Hat up in suicide prevention. Be The One. That resolution will be before the Department Convention and will be considered by Departments nationwide.

Using the GI Bill, Daryl holds a bachelor's degree from the University of Nebraska along with a Master's, and Specialist's Degrees from Wayne State College in Education Leadership.

Harrison serves as President of the Nebraska Medal of Honor Foundation and was instrumental in honoring those Nebraskans who have received the Congressional Medal of Honor by walking across Nebraska with a group of the greatest Legion Family members he will probably ever know. He doubled down on American Legion Past National Commander James W. This being my first article after being appointed Chaplain for the Nebraska American Legion, I must say, it was an honor to be chosen. I hope I will be able to give you some spiritual food in my column and a challenge that we may be able to continue our service to God and Country.

I would like to introduce myself and let you know a little about me. I was raised in Farwell, Nebraska, and was given the name Alexander, which lasted until I went to high school in Saint Paul. I don't know what happened, either Alexander was too long for some or had too many letters to fill in for the number of blocks on a standardized test, but from then on, I was always called Alex. After graduating I attended Conception Seminary College, in Conception, Missouri, and St. Thomas School of Theology in Denver, Colorado. I was ordained as a priest in 1980 for the Diocese of Grand Island, and I served for twelve years in parishes before being given permission to enter the United States Navy. I spent 20 years serving in both the Navy and Marine Corps. After retiring from the Navy, I spent eight years back in the diocese serving in parishes before retiring from active ministry in July 2020 after 40 years of ministry. I continue to supply help for parishes in the diocese.

As we began a new year, it is a good time to take a reflection on who we are and where we want to go. I'm not talking about trips, but our relationship with our God, country, and ourselves. New Year's is a time when many people make promises to themselves such as going on a diet, starting an exercise regiment, being more active in society, spending time daily in prayer, or even being more consistent with our weekend attendance at services.

VA and BVA Acknowledge Delays in Mailing Veterans Notification Letters



2021, November Veterans Benefits Administration (VBA) announced the extension response periods of 90-calendar days for claimants who received letters dated between July 13, 2021, and December 31, 2021. The extension is being provided due to delays in printing

services at the vendor contracted by the Government Publishing Office (GPO). The importance of this extension is paramount to veterans in this group as veterans who do not respond to the time-limited notifications face denial for the election of benefits or services. Late arriving mail from the VBA has resulted in some veterans missing VBA scheduled compensation and pension exams, which has resulted in the VBA denying the veteran's claim for benefits due to missing the scheduled medical exam. If you are a veteran who has received a letter for a scheduled medical exam that has passed the date for the scheduled exam for compensation or pension, please reach out to your County Veteran Service Officer (CVSO) as they can assist in contacting VBA to ensure the claim is not denied for failure to participate in the exam(s) as scheduled. Your CVSO can assist in rescheduling an exam if the date scheduled is conflicting with your schedule.

As the Board of Veterans' Appeals (BVA) also uses the same mailing service through the GPO, BVA is experiencing similar delays in their letters being mailed to veterans. BVA has issued a statement that they are "closely monitoring the backlog at GPO and will continue putting new and improved processes in place to ensure Veterans are receiving notice of their Board decisions in a timely fashion." For veterans who have an upcoming hearing before a Veterans Law Judge, BVA is calling, emailing, and sending letters to every Veteran who has a hearing scheduled. If you receive notice of a hearing, please reach out to your CVSO or the State Service Office (SSO). The SSO may be contacted by calling 402-420-4021 or by email at ndva.sso@nebraska. gov. Veteran Service Officers at the SSO do have access to "Caseflow" (BVA database currently used for tracking hearings) and can confirm the status of an appeal at BVA.

Virtual Claims Clinic at Local Veterans Administration Regional Office

December 1 – 3, 2021, the Lincoln Regional Office (VARO) in conjunction with the St. Paul VA Pension Management Center held a virtual claims clinic (VCC). A VCC allows veteran representatives (State Veteran Service Officers and Nebraska CVSOs) to submit requests to VBA regarding specific veteran claims that have exceeded 125 days for review, this allows for a rating of claims if ready as well as scheduling exams (specifics on what types of claims eligible for submission is available through your CVSO or the SSO). A total of 76 disability/pension claims were identified as meeting the criteria for submission and by the end of the clinic, Nebraska Veterans received over \$550,000 in retro payments, with some retro payments still pending.

YIKES! IT'S 2022!!



2022 has arrived!

A simple question --- Are you a current member? In simpler terms, have you paid your 2022 dues or are you a delinquent member? If you do not have in your possession a 2022 membership card, you are a delinquent member. No voting rights, no benefits, and unable to hold an office at any level --- unit, county, or department. If you are one of the 3,179 unpaid members (as of December 10, 2021), please get your dues to your membership chairman. (And, on a sadder note, there are 883 unpaid for 2020.)

Here is something units might consider within the next three years. Paying your own unit's memberships online.

Currently, there are three units in Nebraska trying this pilot program. They are Gering, Papillion, and St. Paul. Two basic components: a bankcard to make the payments online and a yearly fee (set by National) which includes access to ALAMIS (the American Legion Auxiliary Management Information System). Why go this route? It saves time and provides a more "real-time" accounting of your paid members.

Regular renewals can be entered immediately by your unit's membership chairman (or whomever you appoint to manage the submissions) once dues are received from your members. No need to mail the transmittal form and unit check to headquarters for entry by Lisa or Roxanne. This means no more "but we have this many paid" when checking the membership reports and finding they don't match your records because your paperwork and payments are in the mail and then must be entered when headquarters receives them.

Even with this new process, there are certain items that must be mailed to headquarters: death notifications, new members' applications, unit to unit transfers, and out-of-state transfers.

So, a new streamlining way for membership! Let's keep an open mind about this change. Also, please note that this may not be beneficial for all units, especially those with smaller membership numbers.

Another reason for "YIKES, it's 2022" is that it means my time is quickly approaching for me to be the next Department President. Part of my duties is to fill the chairmanships. This is quite a task, and I hope to have representation from all over Nebraska. Don't be surprised if I contact YOU!!

CONSTITUTION UPDATES PART 4- MORE TO FOLLOW

Uniform District Constitution:

Constitution, Article IV Officers

Section 1: The officers of the District shall be District President and District Vice President. The District President and the District Vice President shall be elected annually at the District Convention by the duly elected and accredited delegation attending said Convention.

The District Secretary and/or Treasurer, Parliamentarian, Chaplain and/or Historian shall be appointed by the District President.

Any member who is in good standing and present at the District Convention shall be eligible for election to office.

The District President and District Vice President may serve two (2) consecutive one year terms. After having served two (2) consecutive terms in each office, they shall be ineligible for an elective office until two (2) terms have elapsed. (6/24/2021)

Section 2: The duties of the officers of the District organization shall be such as are provided by customary parliamentary authority, additional responsibilities and guidelines of District officers shall be placed in the District Bylaws and/ or Standing Rules. (6/24/2021)

Section 4: The District Executive Committee (DEC) shall be comprised of the following: District President, District Vice President, District Secretary and/or Treasurer, District Chaplain, and/or District Historian, Junior Past District President, District Parliamentarian and the County Presidents of the District.

County officers shall be elected at County Conventions. In the event a County President is not elected or is unable to serve, the District President shall have the authority to appoint a County Representative.

It shall be the duty of these officers to act as representatives of the District in all matters referred to them by the District President (6/24/2021)

Constitution Article V Conventions

Section 2: Convention: In the event a declared emergency, the District President has the authority with the approval of the District Executive Committee to convene and conduct by electronic and/or virtual media the District Fall Conference and the District Spring Convention with the endorsement of The District American Legion. (6/24/2021 Lincoln)

Section 3: District Meetings: In the event of a declared emergency, the District President shall have the authority to convene and conduct District Executive Committee meeting(s) by electronic and/or virtual media. All resulting business decisions shall be deemed valid. Other electronic or virtual media Committee meeting(s) must be approved by the District President and the District Executive Committee. (6/24/2021 Lincoln)

Section 4: The District Executive Committee, as the governing body of the District shall be notified of the emergency and date and time of said electronic and/or virtual media Conference and/or Convention, extending the notice to Department and all Units in the District. (06/25/2021 Lincoln NE)

All business decisions resulting from electronic and/or virtual media meetings shall be deemed valid. (6/24/2021 Lincoln)

Constitution Article VII Amendments

Section 2: To be in compliance with the National Organization and the Department of Nebraska governing documents the Uniform District Constitution shall automatically be amended/updated to adhere to National and Department updates; thus, no formal resolution or amendment shall be required to make said changes. Updates shall be effective immediately.

The Uniform District Constitution governing document shall be in compliance with the National Organization and the Department of Nebraska governing documents and shall not set forth any change that would be greater than that provided through the National Organization.

The Department Executive Committee shall review all automatic updated entries at the annual Department Convention to ensure revisions have been properly updated. (6/24/2021 Lincoln)

Section 3: The District Presidents shall be notified of automatic updates made to the Uniform District Constitution; in turn the District President shall communicate automatic updates to District Units, thereby instituting the necessary updates at all levels of the Department of Nebraska Auxiliary.

Notification of automatic updated entries shall be placed in The American Legion Auxiliary Department of Nebraska Star publication. (6/24/2021 Lincoln)


