Hello Members,

Last month I sent out the IRS 8822b form. Units are responsible for communicating to Department their responsible party and that person's mailing address. Typically, the responsible party is your Treasurer or President. This information is provided to the IRS and is required to maintain your tax-exempt status. It is also the basis for filing your annual E990 tax return. Department maintains a binder of submitted forms. Only updates need to be submitted. If you are uncertain if your information is current, just submit another form. If you have questions, you can contact me anytime for assistance. The list I inherited shows that 14 units file their own E990 tax form. If you are one of those units, please confirm that on the form you received and return to Department via mail or email. I want to confirm that all units are up to date before tax returns are due after the first of the year.

Each unit received donation forms and there are more coming. *Our veterans appreciate your generosity*. I have a special request for each unit — please try to get your donations into headquarters by the 1st week of October. Our volunteer financial advisor has been performing all the bookkeeping duties. She is a "snowbird," and will be away six months. That means I get the bookkeeping title. Let's let her know we appreciate her and give her all the donations before she leaves.

The question of who the County Officers are and what are the dates for County events has been asked. My research shows that our records need updating. If you have County meetings, please let Department know so we can inform our Department and District Officers. They would welcome an invite to your County and Unit events.

Hello Members,

This month we are going to dedicate our message to those Unit members who invested in the State Life Membership (SLM) program; which is NOT recognized by the National organization.

Members, many of you will recall that years ago (June 24, 1976 through July 1, 1998) the Department established a dues program for members to pay up for life and be done with paying annual dues. Remember, this was a Department-established program; not a National program. Many Auxiliary members took the Department up on this wonderful offer and signed up. I know when I joined the SLM program my total Unit dues were \$8. Those funds ran out a long time ago. I am now invested in the National Paid-Up-For-Life (PUFL) program.

Being invested in the National Paid-Up-For-Life program at this time, means that National's \$12.00 share of my total Unit dues can never go up. My portion of National dues of \$12.00 is locked in for the rest of my life.

As of 2023 (this membership year) Department's share of your Unit Senior dues is \$10.25. National's share of your Unit Senior dues is \$12.00. So very soon the total share that the Department will not receive annually from each of the just under 1,000 State Lifetime Members (SLM) is \$22.25. This means a deficit close to \$22,250 for the Department of Nebraska annually. ($$22.25 \times 1000 = $22,250$)

PLEASE KEEP IN MIND THAT FOR THE 2024 MEMBERSHIP CAMPAIGN, THE DEPARTMENT'S SHARE OF YOUR UNIT DUES WILL BE \$12.25 as a \$2.00 increase in the Department's share was approved BY THE Convention body at the 2022 Department Convention in Columbus NE.

At the 2022 National Convention in Milwaukee WI the National organization will propose a \$6.00 dues increase for Senior members. If National's \$6 dues raise is approved for year 2024, the Department of Nebraska will be responsible to transmit \$18.00 per SLM to the National organization; putting the Department with a larger deficit.

So where does the Department find the funding for your Senior per capita dues? It is taken from the General Fund; thus, taking away funding from other segments of our work for Veterans, military, family, children, youth and our communities. Membership dues are the foundation of a solid budget which covers expenses from wages, to utilities, supplies, and much more.

THIS DOES NOT AFFECT ANY UNIT MEMBER WHO SIGNED UP FOR THE NATIONAL PUFL PROGRAM. YOUR DEPARTMENT AND NATIONAL PER CAPITA DUES ARE LOCKED IN. (Application attached.)

Units with SLM members and SLM members also, would you please consider making a donation into the Department to help meet this financial shortfall? Your investment in the Department and its programs is greatly appreciated. \$10.25 Department and \$12 National share of your dues = \$22.25. Donations may be sent to:
