Vincent J. "Jim" Troiola (pronounced Tree-Ola) was elected national commander of the nation's largest veteran service organization on Sept. 1, 2022, in Milwaukee during The American Legion's 103rd national convention. His theme as national commander is "V.E.T.S., Veterans, Education, Teamwork, and Sponsor."

A life member of American Legion Post 1682 in Rockland County, N.Y, he served in the U.S. Navy and Navy Reserves from 1969 to 1974. He completed a tour aboard the USS Nitro, an auxiliary ammunition ship with the Sixth Fleet. He was honorably discharged as a boatswain's mate third class. He is also a member of Sons of The American Legion Squadron 1682 based on the World War II service of Jim's father.

Jim spent his entire working career in the automotive service industry, where he began as a parts manager at

a local Chevrolet dealership and went to serve in many capacities of management. At the time of his retirement in 2017, he was director of service and parts at a New York Metro Mercedes Benz dealership. After a brief time at home, he began an entirely new career as a school bus driver for the Falmouth School District and part-time motor coach operator.

Camp Lejeune Lawsuits: What To Make of the Advertisements by Law Firms.

First and foremost, I am always concerned when an advertisement is made to veterans by a for-profit organization. I recommend using caution whenever you receive information that seems too good to be true or the advertisement is telling you that there is limited time to apply for the benefits. I believe one needs to reach out to local veteran's service organizations and or speak with a veteran service officer who is following what the Veterans Administration is doing or not doing and what advice may be available to veterans. I have seen ads by "pro-veteran law firms" that do not even have the dates of eligibility correct, which should sound the alarm, that may not be the best law firm to consider for counsel.

Most veteran service organizations are recommending not officially sign anything regarding lawsuits until VA clarifies how the settlements will affect service-connected benefits and care. Though filing with the/a lawsuit may be the right choice for some veterans, it is too early in the process to sign with an attorney concerning Camp LeJeune lawsuits. Talk with a veteran service officer about filing a disability claim and also obtaining healthcare if you as a veteran are not currently receiving VA healthcare. The service officer will also be able to advise you as to if you are eligible for a disability claim or if members of your family may be eligible for medical care reimbursement.

How does a veteran know if their eligible under the Camp Lejeune presumptive claim process for a disability compensation claim or VA healthcare? First, the veteran must have served at Camp Lejeune between August 1, 1953, and December 31, 1987, for at least 30 days. Second, the veteran must have a character of service of honorable or general under honorable conditions. Third, the veteran must be diagnosed with one of the eight presumptive conditions for those stationed at Camp Lejeune. The current eight presumptive conditions are adult leukemia, aplastic anemia and other myelodysplastic syndromes, bladder cancer, kidney cancer, liver cancer, multiple myeloma, non-Hodgkin's lymphoma, and Parkinson's disease. Family members of veterans who lived in base housing for at least 30 days between August 1, 1953, and December 31, 1987, may be eligible for healthcare reimbursement for healthcare expenses for 15 specific illnesses or conditions. The 15 conditions currently covered under Public Law 112-154 are bladder cancer, breast cancer, esophageal cancer, female infertility, hepatic steatosis, kidney cancer, leukemia, lung cancer, miscarriage, multiple myeloma, myelodysplastic syndromes, neurobehavioral effects, non-Hodgkin's lymphoma, renal toxicity, and scleroderma. Service officers will never have all the answers to what is going on with the VA; however, they assist you in finding the answer. It is up to you to ask the questions.

An Air Force Tradition

Frank Albrecht was the youngest of nine children raised in the Valparaiso area. During his senior year of high school, his father (Floyd Albrecht a Korean Veteran) said, "Frank if you are going to college you may want to check into the National Guard, cause I ain't paying for it." He was a good father and a hard-working provider for his family. His father served in the Army-Airborne before it was renamed the Air Force in 1947.

Albrecht joined the 155th in Lincoln and he soon grew to love the mission and his colleagues. The patriotic part of him came out and he never looked back. He started out as a Fuel System Mechanic on the RF-4C Phantoms. After 7 or 8 years he switched to working on the KC-135's which led to a

worldwide mission. He went on to become a First Sergeant and finished his career as a Human Resources Advisor. A simple farm kid made it to an E9 Chief Master Sergeant and said, "Even a blind sow finds an acorn once in a while." He was deployed a handful of times, some of his memorable times were at Andersen Air Force Base Guam. After serving his country for 29 years he retired in 2015.

While serving the Albrechts (Frank and Jody) had three boys, Easton the eldest, Grant, and Mitch the youngest. Those boys had always liked the uniforms they saw their dad in, along with the many stories they heard about serving. Around the time Easton was in his junior year, he shared that he wanted to join the Air Guard. Albrecht was so proud of his son's decision; he watched Easton keep his word. Easton was able to get one of his desired roles and became a Crew Chief in the 155th. When Grant was wrestling at Chadron State, he realized he wanted to be closer to home. He considered walking on the University of Nebraska-Lincoln wrestling team. During that time, he talked to his father about the pros and cons of joining the Air Guard with his brother. Grant decided to join and interviewed for a Boom Operator position. Albrecht helped prepare him for his interview and may have helped with getting the position. During the summer of 2022, Easton and Grant were deployed to Qatar for two months.

Albrecht was happy to have two of his cubs in the Air Guard. The two shared stories with their father about basic training and tech schools. During

this time Mitch took interest in joining, there was no need for arm twisting. Mitch was offered a slot as a Boom Operator and will finish his training this October. Albrecht beams with pride having all three of his cubs in the Air Guard, following in his footsteps. The Albrecht cubs all live in Lincoln and attend the University. The brothers are great friends and rely on each other for support. Their bond had strengthened over the years through sports but serving together has solidified that bond. Albrecht has so much joy when he gets to hear about what his three cubs have been up to. The four Albrechts all belong to Valparaiso Post 371.



Larry Gene Kier from Omaha was assigned to A Company, 2d Battalion, 501st Infantry, 101st Airborne Division. On May 6, 1970, Kier's Company was assigned to defend an ammunition storage facility near Henderson Hill Artillery Fire Support Base in the forested hills on the south side of Highway 9, coordinates 163840N 1065600E (YD081411), 18 miles South of the demilitarized zone, Quang Tri Province, South Vietnam.

At roughly 0500 hours, North Vietnamese regulars (NVA) overran a guard station and American defensive positions. US troops stationed in the main part of the base were loaded on helicopters and transported to the ammo dump to aid its defenses. During the brutal battle that began in the predawn and continued for hours, the napalm stores and over 1,000 rounds of 155mm artillery shells "cooked off." Private First Class (PFC) Kier was last seen running toward a barricade close to the storage area and was believed to safely reach a firing position.

PFC Kier moved from the barricade to a bunker with two other soldiers. Shortly, NVA soldiers threw a satchel charge against the bunker. When it exploded, one of the Americans was killed and a second soldier wounded. The wounded soldier was rescued but was unable to accurately report what happened to PFC Kier. The ammunition storage area was located within 20 meters of the bunker. Later that day, American forces regained control of Henderson Hill and the adjacent ammunition dump.

The next day Search and Recovery (SAR) began the grizzly task of collecting bodies of the dead and separating the American bodies from the enemies. While the team found no trace of Kier, they did find five other soldiers who were believed killed during the fierce fighting. All five men had been seriously wounded but were alive. In addition to the wounded, SAR recovered the remains of 33 soldiers killed in the battle. At that time, Kier was reported as Missing in Action.

After Operation Homecoming in 1973, all returned POWs were debriefed about other prisoners. One of the returnees reported that he thought Kier was the prisoner he saw the day prior to release. That man was being held in isolation in Building 33 at the prison camp known as the Hanoi Hilton.

The Joint Task Force for Full Accounting traveled to Quang Tri Province to investigate the loss of PFC Kier on September 11, 1993, January 29, 1996, and January 27, 1998. Remains of two femur sections matched the DNA sample provided by the Kier family, as well as other artifacts including dog tags for Kier, a zippo lighter, a toothbrush, and a razor.

Promoted while missing, Staff Sergeant Kier is memorialized in the Courts of the Missing at the National Memorial Cemetery of the Pacific. His remains were buried in Owingsville, Kentucky, on April 2, 2002, 30 some years after he was killed in Vietnam.

October 1932 (90 years ago)

- A <u>MEMBERSHIP</u> meeting will be held in Lincoln on Saturday, November 12th. At that time, it is believed that 10,000 members can be reported. A banquet will be held in the evening other events of the day include an executive committee meeting in the morning followed by attendance at the Nebraska-Pittsburgh <u>FOOTBALL</u> game in the afternoon. A big block of seats will be reserved for Legionnaires. Ticket prices are \$2.50 plus tax.
- Any Legion member in Nebraska who has an argument with the Missus about going to a Legion meeting, or any wife of a Legion member who wants to make sure her husband goes to the meeting he says he is going to, can well envy Mr. and Mrs. Frank <u>MCNEELEY</u> of <u>NORFOLK</u>. The McNeeleys are one of several pairs in Nebraska where both husband and wife served during the war.
- One of the ceremonies at the recent national convention in Portland was the planting of a <u>TREE</u> in <u>SOIL</u> brought from the Nebraska City home of J. Sterling <u>MORTON</u>. Mrs. Lottie Rosencrans, Department <u>AUXILIARY</u> President, took with her to the national convention some soil from around a tree at the Morton home which had been planted by President <u>CLEVELAND</u>.

October 1942 (80 years ago)

- <u>SCOTTSBLUFF</u> Post 5 recently voted that <u>DUES</u> of members in the armed services be paid by the post. It is estimated that about 12 members are now in the service.
- The American Legion <u>BILL</u> for the amendment of its 1919 charter to open membership to veterans of the second world war has cleared the first hurdle. On October 14, the House passed **SPRINGER** Bill (H.R. 7675) and sent it to the Senate.
- The <u>SEVENTH</u> District continues in the lead on 1943 membership standings, with more than three-fourths of its <u>OUOTA</u> already in.



This is a painless way to contact your representatives to share The American Legion legislative agenda and request their action on specific priorities. VoterVoice was instrumental in the passage of the PACT Act after The American Legion Family flooded their representatives with email through the website. The VoterVoice program sends emails on your behalf without the need to come up with the wording yourself. Getting members registered is a priority of the Legislative Committee of the Detachment of Nebraska. Feel free to reach out to me with any questions you may have.

The Detachment is focusing on renewals for the 2023 membership year. We reached nearly 93% in renewals for the 2022 membership year and will continue to process through the end of 2022. We have yet to reach 100% in membership but could easily push past that mark with additional renewals. We ask for your assistance in retaining members. Nebraska was well represented at the National Finals with three contestants participating in the Sporter category. Austin Rahmig (Gering) with the Western Nebraska Shooting Sports Club qualified 7th in the Nation and was invited to attend the National Finals where he shot a score of 2,283.9 placing him in third place. Why Nebraska American Legion Baseball Is Special Jody Moeller, Athletic Chairman

In 2025, we will be celebrating the 100th Anniversary of American Legion Baseball. I cannot imagine what the 1925 South Dakota Department Commander, Frank G. McCormick, might say a century later about the summer baseball program their department discussed and proposed via resolution to the national organization. That fall of 1925, The National American Legion convention was held in Omaha where the resolution was adopted. The very first national baseball program for high school boys had its roots here in middle America and the discussions about the early details of such an undertaking by the national organization were held on Nebraska soil.



In the 97th year of this program, Nebraska registered 273 total Junior and Senior American Legion Baseball teams in the 2022 season, the second-most teams in the country. Only Minnesota registers more teams than we do. If we were to calculate the number of teams per capita, we would be far and away number one. Nebraska can boast one of the strongest American Legion Baseball programs in the United States. The baseball here is top notch as seen by the number of Nebraska teams that have advanced to the World Series over the years. We are tied with North Carolina at 6th with the number of appearances by the state at the ALWS (22).

Summers here in Nebraska have always included American Legion Baseball games at hundreds of fields and towns around the state. Many of us, including Legionnaires, Sons, Riders, and maybe even some Auxiliary members have played or been somehow involved with American Legion Baseball and have fond memories of those days on the dirt in the heat and humidity of Nebraska.

Nebraska American Legion Baseball (NALB) conducts 49 post-season tournaments each year. Junior and Senior teams in each of Classes A, B, and C will participate in one of 42 Area Tournaments. The champions of the seven Area Tournaments for each division advance to one of nine state tournaments. Because of the number of teams, we register each year, Nebraska is one of the states that get to send two Class A Senior teams to the Regional Tournament.

As we inch closer to 100 years of American Legion Baseball, we Nebraskans can reflect proudly on the history of our program. NALB touches more youth across the state than any other American Legion youth program. When you consider that over 2,500 Nebraska youth wear our American Legion Baseball patch each year, you get an idea of the vast opportunity we have to influence young men and women who participate. We cannot forget what our program was originally intended to do, "to develop within themselves a feeling of CITIZENSHIP, SPORTSMANSHIP, LOYALTY, and TEAM SPIRIT." If you are part of this organization, it is our job to oversee and guide our coaches, sponsors, volunteers, and players toward these principles. That is what makes our program special, and anything less is to drop the ball.

Please be reminded that any Nebraska "Permanent" or "PUFL" member on the Department membership roster on January 1, 2023, shall be in a drawing for \$150.

And don't forget the POST REBATE PROGRAM. A post that signs up a new member who has never belonged to The American Legion before and has that membership transmitted to Department Headquarters by the cut-off date shall receive \$5 from Department Headquarters. The postmark date is November 9, 2022.

At the recently concluded national convention in Milwaukee, a resolution was adopted that may change the way we do membership business in the future. While the resolution did not implement any specific changes, the adoption of the resolution did amend the constitution and by-laws to allow for some changes.

One of the possible changes to be studied is rather straightforward and would be the ability to join or renew for multiple years at a time, three years or five years appear to be the likely choices.

The second change to be considered would be the creation of what has commonly been referred to as a "rolling" membership. If this idea is adopted, a new Legionnaire's membership would begin on the date he or she joins, continue for a full year, and then be renewable on the same date one year later.

I suspect that if this idea does become a reality, it will take considerable thought and study to work out the details. I envision its greatest impact to be on the way we look at and measure annual goals. They might even go away and lead to the adoption of some other performance measures.

Please use MyLegion to identify the Post 500 members who reside near you and ask them to transfer to your post. Members who "renew and transfer" at the same time can count toward your post's annual goal. My understanding is that national has a way to track and will count first-year members of Post 500 toward your post's goal if you get them transferred during that first year.

And never stop trying to sign up a new member!!!

RENEW. REINSTATE. RECRUIT. Transmit dues regularly and often. And thank you for all your efforts.

WHO NEEDS A PARLIAMENTARIAN? YOU DO!

A Parliamentarian's role is often • Someone who can remain impartial described as a "scary one," and one during a discussion which many members do not feel • Does not need to be a member of the qualified to hold. However, the president of every unit, county, and district should appoint someone to fill that role. Let's pull back the curtain and learn more about the role of a Parliamentarian.

What are the duties of a Parliamentarian?

- Advises the presiding officer and other officers, committees, and members on matters of parliamentary procedure. A Parliamentarian does not make rulings, only advises when asked
- · Utilizes Robert's Rules of Order, Newly Revised to form opinions and advice
- · Understands the governing documents of the organization
- Assists with revisions to governing documents (Constitution, Bylaws, Standing Rules)
- Assists with preparation/review of presiding officer agendas and scripts
- Remains impartial and does not make motions, participate in the discussion, or vote unless there is a ballot vote
- Who can serve as a Parliamentarian? Someone familiar with parliamentary procedure

- American Legion Auxiliary
- Does not need to be a registered parliamentarian

During meetings, the Parliamentarian should be seated adjacent to the presiding officer to unobtrusively offer help and guidance during a meeting. The presiding officer is not required to follow the advice of the Parliamentarian. However, in most cases, the advice was requested because the presiding officer was unsure of how to rule.

Many members are qualified to serve in this role based on their extensive experience in our organization --- and their knowledge of parliamentary procedure. I am happy to assist in any way that I can, and the National Parliamentarian for the American Legion Auxiliary is also available as a resource.

> Gene joined the Marine Corps in 1962 and was sent to Marine Corps Recruit Depot in San Diego. While at Camp Pendleton, he was stationed at San Mateo with the 1st Marine Division 3rd Battalion. He spent most of 1962 there but also went through the Panama Canal to Cuba, Jamaica, Puerto Rico, and Guantanamo Bay. When the Cuban crisis was over, he left San Diego and traveled aboard the USS Iwo Jima to Hawaii and then Okinawa where he was stationed at Camp Schwab in 1963. While stationed there, he was on float BN in the Philippines, Hong Kong, Taiwan, and Japan. The Vietnam War was starting about this time, but his overseas duty was ending. He was discharged on May 21, 1966 while at Camp Edson, which was the recruit weapons training station.
