

# Venturing Off the Beaten Path



On Wednesday, October 26, the Nebraska American Legion Department Adjutant Dave Salak presented a check for \$16,055.00 to the Nebraska Game and Parks Commission for the purchase of a new all-terrain track chair. This track chair will allow disabled veterans the mobility needed for some independent outdoor activities. Adjutant Dave has been working with National for many months to obtain this grant through the Operation Comfort Warriors program and it finally paid off. Many thanks to Doug Chace at National and Jeffrey Fields at Nebraska Game and Parks for working with the Nebraska American Legion to make this gift happen.

Operation Comfort Warriors is a National program that provides grants for wounded, injured, and ill military service members and veterans. These grants provide for items that are considered non-essential and not on government budget line items. The items provide for the rehabilitation and quality of life for these wounded warriors. Items can be for adaptive sports, physical therapy, and therapeutic recreation. Nebraska Posts have donated an untold amount of money to the OCW program since its inception. We also have one civilian donor, Nebraska Antique Farming Association, who have donated over \$50K over the past nine years to the OCW program through their Tractor Relay Across Nebraska.

Adjutant Salak stated, "We are excited to team up with Nebraska Game and Parks in this endeavor. I am a hunter and I know there are plenty of others who enjoy the outdoors as well. This track-chair is going to give disabled veterans the kind of mobility and independence they need to go out and enjoy the outdoors." Game and Parks currently has two of the track wheelchairs at Ponca State Park. The chairs provide people the freedom of mobility to hunt, fish, view nature and enjoy the outdoors in all types of terrain. 

What do all the dates of the PACT Act mean to Veterans with regard to eligibility for VA Health Care?

Several veterans have asked me about dates regarding the VA health care "Phase in enrollment" for veterans included in the PACT Act.

The VA has provided many informational documents which speak of three categories of veterans, these three categories are specific to VA health care eligibility, not for a veteran filing a disability compensation claim (for disability claims, speak with a veteran service officer).

The categories for VA health care eligibility created by the PACT Act are as follows.

Category 1: Veterans are who participated in a toxic exposure risk activity as defined by law while serving on active duty, active duty for training, or inactive duty training.

Category 2: Veterans who were assigned to a duty station in certain locations during specific periods of time, to include the airspace above the identified locations. To meet the criteria for category 2, veterans must have served in Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, or the United Arab Emirates on or after August 2, 1990. Or served in Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, Uzbekistan, or any other country determined relevant by VA on or after September 11, 2001.

Category 3: Veterans who deployed in support of Operation Enduring Freedom, Operation Freedom's Sentinel, Operation Iraqi Freedom, Operation New Dawn, Operation Inherent Resolve, or Resolute Support Mission.

Important dates for veterans regarding PACT Act VA Health Care Eligibility.

October 1, 2022: Presumptions of service connection take effect for Veterans who served in Vietnam (1/9/62 - 5/7/75), Thailand (1/9/62 - 6/30/76), Laos (12/1/65 - 9/30/69), specific provinces in Cambodia (4/16/69 - 4/30/69), Guam or American Samoa to include territorial waters (1/9/62 - 7/31/80), or the Johnston Atoll (1/1/72 - 9/30/77). Veterans who served at any of these locations and who are terminally ill, homeless, under extreme financial hardship, or art over 85 years old also receive VA health care eligibility immediately.

October 1, 2022 – October 1, 2023: 1-year period for Veterans who served on active duty in a theater of combat operations during a period of war after the Persian Gulf War or in combat against a hostile force during a period of hostilities after 11/11/1998, and who were discharged or released between 9/11/2001 - 10/01/2013.

November 8, 2022: VA incorporates toxic exposure screening for veterans enrolled in VA health care.

October 1, 2024: Enrollment for health care for Categories 1 and 2 veterans who were released from service August 2, 1990 – September 11, 2001.

October 1, 2026: Enrollment for health care for Categories 1 and 2 veterans who were released from service September 12, 2001 – December 31, 2006.

Frustrated by a problem in negotiating a peace settlement, pressured by Congress and the public wanting an end to American Vietnam. Involvement in President Nixon ordered the most concentrated air offensive of the war; known as Linebacker II; in December 1972.



During the offensive, sometimes

called the Christmas Bombings, 40,000 tons of bombs were dropped primarily over the area between Hanoi and Haiphong. Despite press accounts to the contrary, the Christmas Bombings were the most precise the world had seen. Pilots involved in the immense series of strikes generally agree that the strikes against anti-aircraft and strategic targets was so successful that the U.S., had it desired, could have taken the entire country of Vietnam by inserting an average Boy Scout Troop in Hanoi and marching them southward.

Captain Donovan Keith Walters entered the U.S. Airforce from Lebanon, Red Willow County, Nebraska, a low population county in south west Nebraska, Red Willow County families suffered more than their share with three POW/MIAs from three towns; McCook, Lebanon, and Danbury.

Walters was a member of the 325th Bombardment Squadron. On December 21, 1972, he co-piloted a B-52G Stratofortress (tail number 58-0198, call sign Olive 1); that took off from Guam on a bombing mission over North Vietnam.

The crew consisted of James Y Nagahiro, Pilot; Lynn R Beens; Charles J Bebus, Keith R Heggen, Edward H Johnson, Robert R Lynn, and Walters. The aircraft was outfitted as were other B52 models, equipped with .50 caliber M-3 guns and 27-750 pound bombs. The aircraft had completed its mission, but was hit by a surface to air missile (SAM) in the tail section shortly after turning toward the safety of Thailand. Enemy presence in the area prevented search efforts on the ground.

The fate of the crew is varied. Nagahiro, Beens and Heggen were captured, and Heggen died in captivity. Until his release, the U.S. did not know Nagahiro had been captured. After their release in 1973, Nagahiro and Beens were able to fill in further information on the missing crew members. Nagahiro related that he saw Donovan Walters eject from the plane and heard four others go out behind him. Beens stated that he saw Walters identification card in a stack of cards on a desk at Hoa Lo (Hanoi Hilton) prison. Nagahiro saw Johnson's name written on a pad at the prison.

Vietnamese returned the remains of Heggen in 1974, and consistently denied knowledge of any of the rest of the crew. In October 1988, Vietnamese "discovered" remains of Walters, and three members of his crew, Bebus, Johnson and Lynn; and returned them to U.S. Control. If the US had negotiated more aggressively, would Bebus, Johnson, Lynn and Walters possibly have come home alive? For 16 years, they may have been alive; but were political prisoners of a communist nation.

Captain Walters is memorialized on the Courts of the Missing at the National Cemetery of the Pacific.

#### December 1982 (40 years ago)

- It was a historic and memorable experience for the approximately 60 Nebraskans who attended the National <u>SALUTE</u> to <u>VIETNAM</u> veterans and the dedication of the new Vietnam Veterans <u>MEMORIAL</u> in Washington, DC, Nov 10-14. It became a homecoming reunion of sorts, one with spontaneous emotions of <u>BROTHERHOOD</u>, <u>PATRIOTISM</u> and <u>REFLECTIONS</u> of those who died or are missing in Vietnam.
- Considerable concern over job-related stress and heart problems is being expressed nationally by many firefighters and law enforcement people. <u>LINCOLN</u> Post 3 responded by donating \$2,116 to purchase an electro-<u>CARDIOGRAPH</u>. Trained personnel in both the Lincoln Fire and Police Departments are now using the instrument to detect hypertension and heart problems in employees.

#### December 1992 (30 years ago)

- Governor Ben Nelson has awarded a \$900 <u>GRANT</u> which will aid a <u>DRILL</u> team program that was formed by American Legion Post 30 in Omaha. The program will serve Omaha's inner-city youth.
- <u>MILLARD</u> Legionnaires wish to thank all who made their first <u>FINGERPRINTING</u> session a great success. Sixty-one children participated in the Oct. 6 event.
- National Historian Delfo Barabani has announced the results of the 1992 National Department and Post History Contests. Among those entries receiving recognition was <u>NELSON</u> Post 187.

A quick reminder of the items that should be completed for a new Charter: 1. Ten new members (dual members are included) must be identified. The ten members required for the application cannot be transfer members from another Squadron. 2. A minimum of a Squadron Commander and Adjutant must be identified. 3. It is helpful to have a meeting with a member of the Detachment leadership team to provide an overview of the process and next steps. 4. The SAL Squadron Charter Application and initial Squadron Data Report (SDR) must be submitted to the Department of Nebraska. Please reach out to any member of the Detachment leadership team to inquire about starting your own Squadron today!

All Sons of The American Legion members must renew by 12/31/2022 to stay current. You are current if your membership card says 2023. We have numerous Squadrons across the state who have not reported any membership for 2023 even though the renewal period started five months ago! It is the job of the Adjutant to get membership processed as they receive it. They do a disservice to their fellow members by holding onto membership and risk costing them their benefits. We also have many Squadrons who are doing an outstanding job with membership and should be commended. ## **Membership Minute**

As we settle into the winter months, we probably face what is the more difficult part of our annual membership campaign. The PUFL and Department Life Members are all renewed, and so is that group of loyal Legionnaires who tend to pay their dues promptly upon receipt of the first --- or maybe second --- renewal notices. Those who remain unpaid sometimes seem like the toughest to renew.

The special prize we established this year for the Early Bird drawing appears to have done some good. Paid regular memberships on the Early Bird drawing dates in 2021 and 2020 were down from the previous year's number. Paid regular memberships on the drawing date this year were UP from last year. A positive and welcome trend, I hope.

Nebraska met and exceeded its 65% goal on the November 9th target date, and I'm grateful for that. We need to keep building momentum.

Another renewal notice from Indianapolis was scheduled to be mailed November 10-18, and we can look ahead to the 75% target on December 14th. With every post doing its part, I'm optimistic that we can achieve the number we need ---- and MORE. We've finally moved up into the top 10 in the national standings and want to stay there.

Keep in mind that some target dates are USUALLY, BU NOT ALWAYS followed closely by a "cut off date." That's the date when the remaining list of delinquent members is scheduled for another renewal notice. Occasionally, however, national elects to process the list before a target date. Clearly, it should be apparent that prompt and regular submittal of dues to department headquarters throughout the year is a must so that paid members don't receive an unnecessary renewal notice.

At the fall meetings in Indianapolis, Commander Suchy pledged a membership of 91.60% of goal for the Big 12 competition in March. We are competing against 17 other departments in Category 5, and Nebraska has "bid" the 5th highest pledge in that category. We can't control what the other departments do, but nothing will matter if we fail to make the 91.60%. Whatever we can get above that amount increases our chances of overtaking one of the four departments who have bid more ---- but then fail to make their pledge.

I continue promoting that each post monitors the members in Post 500 to renew and/or transfer known Legionnaires into your local posts. I recently prepared and sent out some prospect lists to a few posts and hope to hear some good feedback on the success of that effort. Every post has the capability to generate the prospect lists just as I did. Don't be afraid to contact me if you need assistance.

On behalf of myself and the Department Membership Committee, I certainly wish you the Merriest of Christmases and the Happiest of New Years! I hope to see some of you at the Mid-Year Conference.





have occurred, especially for the PACT Act.

But what about going forward? In October, National TAL Commander Jim Troiola stated that the Legion Family's key legislative priority is getting Congress to pass the Major Richard Star Act to support combat-injured veterans. Major Star deployed to Afghanistan, Iraq, and Kuwait with the U.S. Army Reserves. When he contracted Stage 4 lung cancer as a result of burn pits and other damaging environmental conditions overseas, he also encountered an unexpected financial surprise. The major learned that - because he hadn't reached 20 years of military service - his disability pay from the Department of Veterans Affairs would be deducted out of his retirement pay from the Department of Defense. TAL's position is that the Major Richard Star Act would end this unjust "tax" on medically retired veterans being subjected to an offset in their retirement pay for every dollar of VA disability received. TAL states that these medically retired veterans are the ONLY class of employees forbidden from receiving their full retirement pay and their disability compensation.

History Books should be forwarded to your District. Contact your District President for the exact deadline for your contest.
