

# American Legion Legislative Priorities



Each year, The American Legion selects about a dozen priority items to present to Congress that impact active duty military, veterans, National Guard, Reservists, and their families. These priorities are chosen based off of the positions and views of its 1.6 million members. This year, the eleven priorities are Mental Health and Suicide Prevention, VA Healthcare Modernization, PACT Act Implementation and Oversight, Protecting Veterans from Predatory Actors, Concurrent Receipt, Guard and Reserve GI Bill Parity, GI Bill for Honorable Service, Support our Afghan Allies, Military Quality of Life, Pay the Coast Guard, and Protect the American Flag. In order to support these priorities and lobby the members of Congress, members from all 55 American Legion Departments make their way to Washington DC every year to participate in the Washington Conference. During this conference, The American Legion Family members visit with their elected officials to see how they plan on voting on the priorities and why they feel the way they do about them. Nebraska will have more than fifteen members attending the conference and visiting with the elected officials.

In Nebraska, the Nebraska Veterans Council (NVC) hosts its own version of Washington Conference at the state level. The NVC choses four or five bills that they will support or oppose, and they invite the Senators who submitted the bill to come and speak to the

group. The priority bills chosen this year were LB 4 having to do with extending the current homestead exemption credit renewal to every five years for permanently disabled veterans; LB 10 having to do with a vehicle exemption for disabled veterans; LB 80 which appropriates funds to complete the State Veterans Cemetery in Grand Island; LB 126 having to do with a homestead exemption credit for disabled veterans; and LB 274, which the NVC opposed, was allowing those who have a Disabled American Veteran license plate to park in handicap parking spots. The day served as an avenue for the Veteran Service Organization members to talk to their State Senators and see how he or she is planning to vote. This year, 117 people from all Veteran Service Organizations in Nebraska attended Legislative Day. State Senators Rita Sanders, Carol Blood, Raymond Aguilar, Jen Day, and Rick Holdcroft spoke to the group and informed them on the different bills that they have proposed for the legislative session. Following the session, members from all organizations were encouraged to go and talk to their own State Senator to see how they stood on the priority bills. Thank you to everyone who attended and made the day a success.



#### March 1943 (90 years ago)

- Boys State in Nebraska is out for the period of the war. The special committee appointed to determine the advisability of continuing **CORNHUSKER** Boys State during the war period has reluctantly concluded that it is impossible to do so. The program will be continued when the war has successfully terminated.
- Marcus Adair of <u>ELGIN</u> was the first veteran of World War II whose card was received at Department Headquarters. A member of <u>ANTELOPE</u> Post 172 in Neligh, he is now employed at the Veterans Hospital in Lincoln.
- Randall Biart, Department Chairman of Child Welfare, warned that today American is facing the greatest wave of <u>JUVENILE</u> delinquency in its history and supported that statement with concrete reports from Nebraska and other states. He warned that one of the most potent influences toward delinquency is employment of <u>MOTHERS</u> of school children outside the home and particularly in war industries.

#### March 1953 (80 years ago)

- The 1953 Department of Nebraska <u>MEMBERSHIP</u> is close to the 50,000 mark. This leaves a margin of some 11,000 between the present total and the quota set by Department officials.
- <u>OMAHA</u> Post 1, in cooperation with WOW-TV, is currently producing a weekly show titled "Your <u>WITNESS</u>" which spotlights timely local and national topics. The show features a panel of experts quizzing another expert on a certain subject. Topics include Nebraska highways, Omaha's parking situation, are we eating too much, state government, and the new substitution rule in college <u>FOOTBALL</u>.

#### March 1963 (70 years ago)

• Veterans of the <u>CIVIL</u> War were honored guests at the annual Washington Day <u>BANQUET</u> of Stellges-Baker Post in <u>TRENTON</u>. This year the three surviving members of the local post, Clark Marsh, George Benjamin and Sam Lawrence were all present. The guest enjoyed a three-course <u>TURKEY</u> dinner.



#### What is the COMPACT Act of 2020?

The Veterans Comprehensive Prevention, Access to Care and Treatment (COMPACT) Act of 2020, section 201, requires the United States Department of Veterans Affairs (USDVA) to directly furnish, pay for, or reimburse emergent suicide care for eligible individuals in acute suicide crisis. This includes transportation costs associated with suicide care, at USDVA health care facilities as well as non-USDVA health care facilities.

Eligible Veterans may receive up to 30 days of inpatient or crisis residential care related to the acute suicide crisis (this period may be extended if deemed clinically necessary). Up to 90 days of outpatient care related to the acute suicide crisis, which includes both medical and mental health care (this period can be extended if deemed clinically necessary). Prescription medications that are related to your acute suicide crisis. Emergency transportation (ambulance and air ambulance) required to receive emergent suicide care. Emergent suicide care and associated emergency transportation must be provided at no cost and there will not be copayments or bills for eligible veterans. USDVA will determine eligibility for other USDVA services and benefits if individuals receiving emergent suicide care are not enrolled or registered with USDVA. USDVA will refer eligible individuals for appropriate services for which they are otherwise eligible, including social work.

Eligibility is met under the COMPACT Act if a Veteran meets any of the below criteria, regardless if the Veteran is enrolled in USDVA health care.

- 1. Is a former member of the armed forces who was discharged or released from active duty under conditions other than dishonorable after more than 24 months of active service.
- 2. Is a former member of the armed forces, including reserve service members, who served more than 100 days under a combat exclusion or in support of a contingency operation either directly or by operating an unmanned aerial vehicle from another location who were discharged or released under a condition that is other than dishonorable.
- 3. Is a former member of the armed forces who was the victim of a physical assault of a sexual nature, a battery of a sexual nature, or sexual harassment while serving in the armed forces.

As with any unscheduled out-of-network for USDVA health care or non-USDVA emergency room visit(s), it is a best practice for the Veteran, or a loved one, or another trusted person to contact the USDVA to ensure the emergency care is being reported to the USDVA within 72 hours of the start of emergent care. If a community provider fails to notify USDVA of the veteran being treated within 72 hours, the USDVA may decline to pay the medical bills and the veteran may be billed by the provider. I encourage all veterans and those that care for veterans to have the "Reporting Emergency Care to USDVA" phone number (844-724-7842) saved in their cell phones. A veteran may also report the unscheduled non-USDVA medical treatment online at https://emergencycarereporting.communitycare.va.gov/#/request.

As Spring approaches, our membership effort appears to be experiencing its unwelcome --- but not unusual --- slow down. After placing among the "Top 10" departments over the last few months, we have now recently dropped into the "Second 10." We need every post to make the effort to clean up their delinquent list.

All is not lost. There is reason to be encouraged. Last year, we failed to meet the 85% Target Date Goal in February. This year, however, we achieved the goal on February 15th --- exceeding it by 2 members. My thanks to everyone who helped make that happen!!

Next up is the 90% target date on March 15th, and another direct renewal notice from national was scheduled to be mailed about March 1. (The early January notice, however, was late getting out).

For those unpaid members with email addresses shown in their MyLegion data, send them an email reminder. Drop them a postcard, give them a call, or pay them a visit. Any and every effort helps.

The 90% Target Date goal on March 15th also coincides with the "Big 12" competition. Winning or finishing in second place is not easy, and Nebraska is competing against 17 other departments in Category V. Departments in each category are ranked according to their per cent of goal on March 15th --- but any department not reaching the percentage they pledged last fall is disqualified. While we may have departments in our category doing a little better than we are, they might not meet their pledge. As a result, we just need to renew or recruit and transmit every single member we can by the 15th of March. Nebraska has pledged that we will have 91.60% of our goal by that date.

I probably sound like a broken record, but I continue to encourage everyone to use MyLegion to help manage your membership AND search for new members to transfer from Post 500, our headquarters holding post. Adjutant Salak sent out about 900 letters from Department Headquarters in early January to all of the Post 500 members who had not yet renewed their dues for 2023 and encouraged them to do so. But, please know that he ALSO recommended to them that they transfer their membership to a local post --- and gave them some good reasons why.

Please follow up on Adjutant Dave's letter. Determine who the Post 500 members are who live near you and then contact them. I know that some posts are doing that ---- and some of these Post 500 members are transferring to a local post and renewing at the same time. It doesn't hurt to also check with those headquarters post members who have already renewed for 2023. Some of those will transfer, too.

As for the Membership Committee, Committeeman Doug Vance (Area A) resigned in January. Committeeman Richard Baxter (Area D) has been ill and is convalescing at a care facility in Kearney. Please keep PDC Baxter in your thoughts.

# Contentious Department Executive Committee Meeting in Norfolk By Department Adjutant Dave Salak

On Friday, January 13, 2023, the Department Executive Committee (DEC) met and first on the agenda was the matter of a Nebraska Pardons Board hearing. At that hearing, several members of the Nebraska American Legion attended to support a fellow Legionnaire seeking a pardon. However, those Legionnaires did so wearing their Nebraska cover and it is this specific action that didn't sit well with several members of the DEC. The majority of the DEC did not have an issue with these members supporting another veteran/Legionnaire but they did take issue with them wearing their Nebraska Legion hats during the hearing.

As a result, a motion was made to censure the individuals in question and for them to issue a public apology via the Nebraska Legionnaire. This public apology is listed herein.



Daniel Wayne "Danny" Thomas was born September 4, 1946, at McCook in Red Willow County. He attended grade school in Danbury and graduated valedictorian of his class from Beaver Valley High School in Lebanon in 1964. He graduated from McCook Junior College and the University of Nebraska. Danny enlisted in the U.S. Air Force as a candidate for pilot training in the spring of 1968.

Danny Thomas was a Forward Air Controller assigned to the 23d Tactical Air Support Squadron at Nakhon Phanom RTAFB Thailand. Their missions were quite sensitive and highly classified. On July 6, 1971, Army Captain Donald G "Butch" Carr was aboard the Air Force OV10A Bronco aircraft flown by Thomas, when the aircraft disappeared 1.5 miles inside Laos, west of Ben Het. The aircraft had been on a visual reconnaissance mission over central Laos when it was lost. Thomas' plane was detailed out of the 23d Tactical Aerial Surveillance Squadron, tail number 67-14634.

The Bronco was among the aircraft most feared by the Viet Cong and NVA forces, because whenever the Bronco appeared overhead, an air strike seemed certain to follow. The glassed-in cabin could become uncomfortably warm, but it did provide great visibility. The two-man crew had armor protection and could use machine guns and bombs to attack; as well as rockets to mark targets for fighter bombers. This versatility enabled the plane to fly armed reconnaissance missions as well as forward air controllers.

At 1530 hours, Thomas radioed to the Army support facility that he was in his target area, but that he was unable to observe because of weather conditions. This was his last known radio contact. A ground reconnaissance team later reported hearing an impact or explosion at 1600 hours in their vicinity, but they did not report seeing the aircraft. Thomas and Carr were due to depart the area at 1700 hours, and should have radioed then. Search efforts were conducted through July 10, with no results.

A source reported that in July 1971, he had seen an American POW in that area. The source learned from a guard that the POW was a pilot of an OV10 that had been downed a week before. This information was thought to possibly correlate to either Carr or Thomas.

On March 7, 2017, DPAA released an announcement that Captain Daniel W. Thomas, USAF, listed as MIA had been accounted for. Remains were recovered by a Vietnamese Unilateral Recovery Team in August 2014, and identified in August 2015; as well as remains of Donald G. Carr, US Army. Analysis of aircraft wreckage and life support items indicated both aircrew members were in the aircraft at the time of impact.

Danny's remains were returned to his family, and they were buried in a private family service in the Danbury-Marion Cemetery November 27, 2017. Daniel W. Thomas was posthumously awarded a Distinguished Flying Cross, Purple Heart, and other medals. Captain Thomas is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific.



Through all this "ALA Madness," I am grateful to serve as your Department President and thank all the dependable Nebraska Auxiliary members. You are the best!

### **LEGISLATIVE DAY**

Greetings from the Nebraska State Capitol! Department President Vicki Ozenbaugh, Historian Amanda Washburn, and several other ALA members attended the Nebraska Veterans Council Legislative Day on February 3. We heard from Nebraska Governor Jim Pillen; State Senators Raymond Aguilar, Carol Blood, Jen Day, Rick Holdcroft, and Rita Sanders; Nebraska Department of Veterans Affairs Director John Hilgert; and Deputy Director Levi Bennett.

The group was encouraged to visit our state senators in order to voice our support for the following legislation:

- LB4 (Senator Sanders): Alters timing of homestead exemption applications, allowing permanently disabled veterans to apply every five years, rather than annually – Referred to Revenue Committee;
- LB10 (Senator Blood): Updates definition of disabled and blind veterans to conform with U.S. Code in state statutes providing for motor vehicle and mobile home tax exemptions Referred to Revenue Committee;
- LB80 (Senator Aguilar): Appropriates \$8 million to Nebraska Department of Veterans Affairs for construction and improvements to Veterans Cemetery in Grand Island – Referred to Appropriations Committee: and
- LB126 (Senator Day): Changes provisions relating to homestead exemptions for disabled veterans and their spouses to include partial, stepped-up exemptions for veterans who are between 10 and

100 percent disabled – Referred to Revenue Committee.

As members of Legislative District 32, Department President Vicki, Past Department Commander Lyle Bartels, and I --- together with three members of the Sons of American Legion, visited our state senator, Tom Brandt. Senator Brandt indicated his support for all four pieces of legislation.

Department President Vicki brought up LB771 (Senator Sanders), which would provide grants to postsecondary institutions to establish internships and academic course programming to assist the U.S. Defense POW/MIA Accounting Agency with their work in providing the fullest possible accounting for missing personnel from past conflicts to their families and the nation. Senator Brandt indicated his support for this bill as well.

Senator Day mentioned in her speech, and Senator Brandt reiterated in his office, that at present, the most important issue is for any bills being supported by the American Legion Family to demonstrate enough backing so as to get out of the committee stage. The Senators recommended that if the above bills are important to us, we MUST voice our support through mail or phone calls – or even testifying in support at the committee hearing.

Did You Know? Approximately 81,000 service members (POW/ MIAs) remain unaccounted for,

with nearly 71,000 from WWII. This year's special focus of the National Security program is to raise awareness of POW/MIAs, provide ideas to become more aware of POW/MIAs, and assist with spreading that information throughout our communities.

A great place to start is the Defense POW/MIA Accounting Agency (DPAA) website, https://www.dpaa.mil, which shares a vast amount of information. The DPAA's mission is to provide the fullest possible accounting for missing

personnel from past conflicts to their families and the nation. The website contains a full listing of POW/MIAs, both accounted for and unaccounted for, searchable by conflict, state, and branch of service. Recovery efforts are chronicled, complete with service profiles of those identified. Remains identification can only succeed through the matching of service records and DNA. Now is the critical time for all families of POW/MIAs, and especially those from WWII, to search for their loved ones and provide DNA to assist in identifying remains,

In your communities, you can proudly fly the POW/MIA flag, drape a POW/MIA chair with the POW/MIA flag while reading the POW/MIA resolution, or plan a special

ceremony of remembrance on POW/MIA Recognition Day, September 16th. White Table ceremonies can be conducted with the help of the book, "America's White Table," by Margot Raven. This resource helps to explain the significance of each item on the white table as a remembrance of those who are unable to dine with us.

The DPAA's motto states, "Fulfilling Our Nation's Promise." The American Legion Family can help fulfill that promise and raise awareness of those who did not return from battle. We ask for your support in this vital endeavor.

Let us remember and never forget their sacrifices.

# WHAT NOW FOR NEBRASKA **STATE LIFE MEMBERS (SLM)???**

For those Unit members who have the only voice in how we bought into the State Life Member address National's question. (SLM) program between 1976 to It is an individual, voluntary 1998, please read carefully and respond accordingly to myself as the Department Membership Chair.

The National organization does not recognize our Department's SLM program; thus, the Department is required to pay into National annually its portion of per capita dues. For the current 2023 membership year that is \$12 per SLM. Beginning July 1, 2023, the Department will need to send \$18 per SLM member to National because of the \$6 dues increase approved at the 2022 National Convention.

Presently, the National organization has received applications from our SLMs for the Paid Up For Life (PUFL) memberships, which is the National version of our SLM. National's question is "Does the Department intend to have SLMs become PUFL members and eliminate our Department **SLM membership plan"?** At this point, there is no discussion to that effect; nor plans to do so. Those Unit members having SLM membership

decision of each SLM to determine whether to stay a SLM and do nothing **or** make an \$18 donation to the Department annually or switch back to a regular dues-paying Unit member with annual dues or buy into the PUFL program.

What would a PUFL membership provide for the Department that our SLM membership does not? It provides the funding for the Department to meet its obligation to pay National's per capita dues. Thus, the Department would not need to dip into the General Fund to cover that cost. Those of us who bought into the SLM program should understand that those dues have long ago been spent and there are no funds to cover the nearly 725 (plus or minus) SLMs annual payments into National.

Each SLM has to decide how would you like to proceed:

(1) Stay as a SLM and do nothing;

(2) Stay as a SLM and make an annual donation of \$18.00 to the Department;

(3) Switch back to a regular dues-paying member with annual

(4) Buy into the PUFL program, which will be a lump-sum payment based on your current Unit dues rate and your age.

In order to avoid the dues increase in 2024, any SLM wanting to buy into a PUFL membership are encouraged to complete that process by May 31, 2023 to ensure the process is complete before July 1, 2023 on the Unit, Department and National

Please consider your preference as a SLM and let me know by April 1, 2023. Thank you for your years as an ALA member and for being a SLM. Unfortunately, times have changed, and we need to consider ways to help meet the Department's financial responsibility for National per capita dues concerning SLMs.
