

#### SENIOR UNIT HISTORY BOOK RULES

(History April 1, 2022, to March 31, 2023)

#### District winner must be submitted to the Department Historian by June 1

Cover (10 points): Units may use a three-ring binder or three ring folder that can hold 8 ½ X 11 paper for their entry. In the center of the first sheet should be a color American Legion Auxiliary Emblem (any size) and the words "History Book."

Title Page (25 points): Listed on the second page should be the Unit name, Unit number, Unit town, the District number, name of the Unit Historian, and History Book Year 2022 to 2023.

Content (60 points): The history narrative needs to be a minimum of five paragraphs and should start with the installation of officers and the close of your administrative year in chronological order. Within the narrative should be the unit officers, chairman, and other events or activities. Any font can be used, and it can be typed or handwritten.

Unit Historian Signature (5 points): Please have the Unit Historian sign the last page of the narrative.

Bonus Points: A Unit can earn one extra bonus point for including 3 photos of Unit Members participating in Unit Activities or one Unit Event Invitation or Program.

#### SENIOR UNIT NARRATIVE HISTORY RULES

(History April 1, 2023 to March 31, 2024)

#### Submissions must be set to the Department Historian by June 1

Title Page (30 points): Listed on the first page should be Unit name, Unit number, Unit town, the District number, name of the Unit Historian, and Narrative History Year 2022 to 2023.

Content (60 points): The history narrative needs to be a minimum of five paragraphs and should start with the installation of officers and the close of your administrative year in chronological order. Within the narrative should be the unit officers, chairman, and other events or activities. Any font can be used, and it can be typed or handwritten.

Unit Historian Signature (10 points): Please have the Unit Historian sign the last page of the narrative.

#### **DUTIES OF THE UNIT CHAPLAIN AND SUGGESTED ACTIVITIES**

The chaplain should attend all meetings and have an opening and closing prayer at each meeting. These prayers may come from the American Legion Auxiliary Chaplains Prayer Book or may be others that the chaplain has found or written on their own.

The chaplain should be involved in many activities, such as:

- 1. Reporting the names of members who are ill at meetings and presenting cards for members to sign to mail to them.
- 2. Sending a sympathy card to the family, and, if possible, visiting the funeral home when a member passes away. The chaplain may also be assigned to ask the family if they wish to have a funeral dinner.
- 3. Being in charge of any religious services the unit may have, such as draping the charter or performing memorial services.
- 4. Visiting members and veterans in nursing homes and hospitals.
- 5. Visiting members and veterans who are shut-in at home.
- 6. Keeping in contact with all Gold Star Mothers and remembering them during all holidays.
- 7. Sending cards to members and their family members.
- 8. Making a prayer and devotional book.

9. Encouraging members to send prayers and devotional thoughts so that she can use them to make a prayer book.

#### **HOW DO YOU MAKE A UNIT PRAYER BOOK? \*\***

The unit chaplain does not make a unit prayer book alone. The publication is a collection of prayers, devotional thoughts, and poems that mean something special to the unit members. The chaplain and members may write their own prayers or devotional thoughts for the book. All members should be asked to give the unit chaplain something for the prayer book.

The chaplain may want to type the material she receives. She may want to add pictures that go along with the prayer, devotional thought, or poem.

A great resource for the prayer book is a church bulletin. Many churches use bulletins that have a picture on the cover with a devotional thought or bible verse. Ask unit members to save these for you.

Making a prayer book is a very delightful job. You will likely receive beautiful prayers, devotional thoughts, and poems from many different people. Be sure to enjoy every minute of it.

#### **DEPARTMENT CHAPLAIN DUTIES**

- It shall be the duty of the Department Chaplain to serve as spiritual leader of the Department and to offer prayer at the opening of each day's business at Department meetings and conduct all religious services.
- The Department Chaplain shall serve as Gold Star Chair and prepare a Gold Star Recognition during Department Convention.
- The Department Chaplain shall prepare a suitable Christmas Candle Lighting Ceremony for Unit distribution by October 15th of each year.
- The Department Chaplain shall establish guidelines for judging Prayer Books and prepare Citations of Award to be given in recognition of the winning Prayer Books.
- The Department Chaplain will encourage members to send prayers, poems, and devotions to be places in the prayer book for Department President, Lisa Moore.

#### **GUIDELINES FOR SENIOR PRAYER BOOK**

A prayer book is not made by the Unit Chaplain alone. It is a collection of prayers, devotional thoughts by all that has meaning to each Unit member. They may be original, or they can be found by other sources if cited.

As your elected National Executive Committee (NEC) Member, I am Nebraska's representative of the governing body of the American Legion Auxiliary with fiduciary, policy, and strategic responsibility for the organization. My term begins at the close of the 2023 National Convention and ends at the adjournment of the 2024 National Convention. The National Executive Committee is comprised of the National President, National Vice President, the five National Division Vice Presidents, National Chaplain, National Historian, and one NEC member from each Department. The National Secretary and National Treasurer, when not in employee paid status, serve with all rights including the right to vote. Nebraska's Past National President Carol VanKirk is a member for life, with all rights except the right to vote.

Nebraska's NEC alternate is President Lisa Moore. She will serve only in the absence of myself.

The National Constitution, Bylaws, and Standing Rules (CBSR) clearly defines the NEC's role per Constitution Article V, Bylaws Article VI, and Standing Rules V. Throughout the CBSR the NEC has specific responsibilities.

I have been appointed to a three-member sub-committee to review the minutes of the NEC meetings.

Per our CBSR, I will be the Distinguished Guest Committee Chair when a National officer pays an official visit to Nebraska. The 2023 – 2024 National President is scheduled to visit Nebraska August 3-5, 2024. Standing Rule M – Reimbursements states:

13. National Officer Visits a. When the National President or Northwestern Division National Vice President visits Nebraska outside of the Department Convention or Mid-Year Conference, the Distinguished Guest Chairman and the Department President can submit a voucher for the standard mileage and any expenses pertaining to the dignitaries visit. The Department Secretary will coordinate with the Distinguished Guest Chairman and Department President to make room reservations for the National guest, Distinguished Guest Chairman, and Department President. Expenses to be taken from Conferences and Convention, General Fund.

- Deadline date (your Unit deadline).
- Department (see below) and Unit awards (if your Unit provides awards).

All Unit winning essays must be to Tina Nelson by March 15, 2024

Help judge the contest.

Contact your local essay winners and their families. Invite them to join you at a meeting and have them read their winning essay or they could be part of your Veterans Day or Memorial Day program by reading their essay.

Make sure to share winners on social media (tag me Tina Renee Nelson) and other local media outlets.

#### Department awards are issued per Standing Rules, Section F

A \$25 cash award will be given for first place in each class for the Americanism Essay Contest. A \$15 cash award will be given for second place in each class for the Americanism Essay Contest. A \$10 cash award will be given for third place in each class for the Americanism Essay Contest. Monetary awards shall be taken from the Histories and Awards, General Fund.

AEF funds may be used to provide emergency assistance to eligible Auxiliary members who have been devastated by disaster, including flood, hurricane, tornado, earthquake, fire, or another catastrophe. These members will be considered for essential emergency expenditures up to three weeks after the incident or disaster. Grant funds may also be awarded to eligible members only for past/overdue expenses related to retaining their primary and/or loss of income due to medical and/or employment reasons.

Have you noticed the word ELIGIBLE is present in all these grants? To apply for these grants, you must have paid your current dues and the immediate past two years' dues. This is why it is important to keep your dues current and the Membership Chair of your unit send in dues promptly. Have you paid your 2024 dues?

The job of each Auxiliary member is to promote awareness and knowledge and to support the AEF program. There is no budget line for the AEF program. It is important that all levels of our organization maintain up-to-date governing documents. Having the Constitution, Bylaws and Standing Rules current reduces conflicts and ensures success for our organization.

There have been some revisions over the past few years to both National and Department governing documents. Units, Counties, and Districts should review their governing documents annually to see that they are revised and comply with the National and Department governing documents. Standing Rules also need to be reviewed and amended as necessary.

Uniform Unit Constitution and Bylaws and Uniform District Constitution and Bylaws will be available on the Department website. An example of a Unit Constitution may also be found in the Unit Guide Book available from Emblem Sales.

I am a 66-year member of St. Edward Unit 226. I belong to help support veterans and youth programs --- and to honor my father and husband, both of whom served our country in the Army.

Per our Constitution regarding County Government,

There shall be a County Government Committee as directed by the Articles of Incorporation for Cornhusker Boys' and Girls' County Government, Inc., Section VIII, 'The corporation shall be managed by a board of directors, consisting of the following: (1) The Commander of The American Legion, Department of Nebraska, to serve during the term of office; (2) The President of the American Legion Auxiliary, Department of Nebraska, to serve during the term of office; (3) The Adjutant of The American Legion, Department of Nebraska, to serve during the term of office; (4) The Secretary of the American Legion Auxiliary, Department of Nebraska, to serve during the term of office; (5) The members of the Americanism Committee of The American Legion, Department of Nebraska; (6) Five members of the American Legion Auxiliary, Department of Nebraska, other than its President and Secretary, to be appointed by the Department Executive Committee thereof, one to be appointed each year for a term of five years, and as the terms of office expire, successors shall be appointed in like manner for like terms. Vacancies in office shall be filled by the Department Executive Committee for the unexpired term. The regular annual meeting of the Cornhusker Boys' and Girls' County Government corporation shall be held in conjunction with the Americanism Committee meeting just prior to the Department Convention of The American Legion.

Chief Justice Robert G. Simmons of the Nebraska Supreme Court started County Government Day. He heard a Boys State Citizen saying that if he could not win a state office, he would just have to run for one of the old county offices. Realizing what an important part of the government puzzle your counties are, he made it his mission to create a program that would educate our youth about county government and just how important it is to every county. Each count sets up their own program according to the count situation. Local high school students learn about each county office/position and the duties and responsibilities of each office. Programs may include speakers, question and answer sessions, jeopardy games, essays, visits to the county offices and court, or other educational activities. Lunch is usually served to those participating.

It is important to contact the schools in your county early with the date and program details.

If you wish to start a County Government Program in your county or assist with one county, contact your District Commander and District President. The purpose of the Finance Committee is to oversee the general financial policy of the American Legion Auxiliary and to prepare and monitor the annual budget and its expenditures.

It is the responsibility of the Finance Committee to ensure that proper internal controls are designed, implemented, and maintained. An adequate budget ensures there will be funds earmarked for all purposes necessary to participate in the various Auxiliary programs throughout the year. Since the American Legion Auxiliary is a membership organization, we rely on member dues to cover our expenses. The Finance Committee will discuss various ways to raise additional funds and to lower the dependence on dues and/or reserves alone to meet our obligations.

The Finance Committee will make recommendations to the governing body, and that body is responsible for the actual policy decision. The finance committee also must present clear, timely and accurate information regarding the financial status of the organization at each of their meetings.

The Department Finance Committee meets in December prior to Mid-Year Conference and in late May or Early June prior to Department Convention. The December meeting is sometimes facilitated by Zoom due to distance and weather concerns.

Per the Department's Bylaws, Article VII Finance:

- **Section 1.** All persons handling funds of the Department shall be bonded by a reputable, solvent bonding and surety company; or shall be covered by fidelity-crime insurance in an adequate amount as determined by the Department Risk and Compliance Committee and the Department Finance Committee with approval of the Department Executive Committee.
  - a. Bond Review: Department bonds shall be reviewed by the Department Risk and Compliance Committee and the Department Finance Committee, with approval by the Department Executive Committee every two (2) years
  - b. Retaining of Bonds: Bonds and Surety records and documents shall be retained for the life of the bond plus 6 years.
  - c. Bond Claims: Bond claims from the Department shall be retained for 10 years.

Section 2. The revenue of the American Legion Auxiliary Department of Nebraska shall be derived from annual membership in a per capita amount established by the Department Convention Delegates, and from such other sources as may be approved 2023 – 2024 ABC Book – Department of Nebraska

by the Department Executive Committee. Modification to the Department per capita dues for members shall require a two-thirds (2/3) vote in the affirmative by the Department Convention Delegates. Dues shall be payable in the amounts as provided in Standing Rules Section Q - Membership. A member's status is dependent upon timely payment of dues. Dues for each Senior member shall include subscriptions to National's American Legion Auxiliary magazine and to department's newspaper The Star. A portion of each members' dues shall be set aside for the National Convention Delegates' Fund; the balance to be used for the General Fund. If it becomes necessary, a portion of the balance in the National Convention Delegates' Fund may be transferred to supplement the Department Convention Fund upon the recommendation of the Department Finance Committee and approval of the Department Executive Committee. (6-24-2018 Kearney NE)

Section 3. Department and National dues shall be payable immediately following Department Convention and become delinquent January 31st. After that date, Units not having forwarded current dues of at least ten (10) Senior members to Department Headquarters shall not be considered in good standing until such dues are paid. A member failing to pay such annual dues by January 31st shall be classed as delinquent and shall be suspended from all membership privileges. Payment of back dues after suspension shall reinstate such member to active membership. Any member delinquent to December 31st of the year of delinquency shall automatically be dropped from the rolls and may not thereafter be reinstated without the payment of all past dues or by reestablishing eligibility and making application as a new member.

**Section 4.** The Department Secretary-Treasurer's books shall be audited on a schedule as determined by the Department Executive Committee or as ordered by the Department Convention delegates. This audit may be completed externally by a professional auditing firm or it may be completed internally by the Department Risk and Compliance Committee.

**Section 5.** The fiscal year of the Department shall be August 1st to July 31st.

# Junior members--What can you do? Promote and encourage Junior participation in the PATCH PROGRAM. Ideas:

- 2. Give Junior members the opportunity to work on requirements for patches at Unit/Post functions.

## What is the Patch Program?

American Legion Auxiliary Junior members and Sons of The American Legion youth members can be active participants of the organization with the Patch Program. Regardless of where one lives, and whether she/he belongs to an active Junior group or squadron, Junior Auxiliary members and SAL youth members can serve their communities and veterans, and learn about patriotism, health, fitness, and leadership through this program. <a href="Examples would be ALA programs--Poppy">Examples would be ALA programs--Poppy</a>, Leadership, Americanism, Veterans Affairs & Rehabilitation, Digital Media, and more.

Each sheet explains the criteria and what must be accomplished to earn a specific patch. When the activities are completed (and most are quite easy; you're probably already doing these, an adult or Senior member must sign the form to verify that the Junior or SAL youth has met the patch criteria. Then this form is mailed to the department chairperson (see address above).

There are three levels of patch criteria:

- Red—Level 1: Kindergarten through 3rd grade
- Gold—Level 2: 4th grade through 8th grade
- Blue—Level 3: 9th grade through 12th grade (or 18 years old)

Build your Junior Activities program one member at a time by giving Junior members a voice and an opportunity to participate.

#### Ideas:

- 1. Encourage your Juniors to invite their friends to attend ALA functions and volunteering opportunities, even if they are not eligible to join.
- 2. Even if you have only one Junior member, encourage her to organize a service project that your Unit will participate in; it may attract other Juniors to join.

## **DEPARTMENT JUNIOR CONVENTION CONTEST ENTRIES**

#### **Craft Display Contest**

**Poppy Centerpiece Contest** 

The poppy centerpiece is an opportunity to reflect the Honorary Department Junior President's project theme, "Growing with Our Veterans." See guidelines in the Poppy section on page 65.

Entries will be judged at the Department Junior Convention. They must be in place for judging 45 minutes prior to the beginning of the Convention meeting. Only one poppy Centerpiece per Junior group will be allowed for this contest.

Poppy Craft Contest (This replaces the former Poppy Corsage Contest)

As the ALA website states, "Connecting the visual image of the poppy with the sacrifice made by our veterans has been an important goal of the American Legion Auxiliary Poppy Program since its inception in 1921." Creating poppy crafts to decorate the Legion Post, to share with a VA Hospital, VA Home or nursing home or designing a window display are just a few of the many places Juniors can distribute and display their poppy crafts.

Entries will be judged at the Department Junior Convention. They must be in place for judging 45 minutes prior to the beginning of the Convention meeting. Only one poppy craft per Junior will be allowed for this contest.

Entries will be judged in the following categories:

Group I - Grade K to 3rd -- Placecard, \*Tray Favor or Card

Group II – Grade 4 to 8<sup>th</sup> -- Placecard, \*Tray Favor, Card, Tree Ornament or Centerpiece Group III – Grade 9 to 12<sup>th</sup> – Centerpiece, Wreath, Swag, Tree Ornament, or \*Corsage

\*These items qualify as one of the Poppy Patch activities.

## **Little Miss Poppy Contest**

This contest is open to Junior members 6–12 years of age who are selected by their Unit to spend the year as their Little Miss Poppy. For Department Little Miss Poppy consideration, the participant must submit a Little Miss Poppy scrapbook illustrating how she promoted the American Legion Auxiliary poppy. The Department contest will follow the National guidelines for judging.

The Department Constitution and Bylaws clearly defines the role of the PPP.

Bylaws Section S – Past Department Presidents 3-7

3. The Past Presidents Parley Chairman, upon notification of a Past Department President being hospitalized or in hospice care, shall send an appropriate gift, not to exceed \$25. The Chairman shall submit a voucher prior to fiscal year's end and said funds are to be taken from the Past Presidents Parley Courtesy Fund. (1-12-2018 Mid-Year, N Platte NE)

When there is a death of a Past Department President, the Past President's Parley Chairman shall send a card to the family. A \$25 memorial contribution of the family's choice shall also be given in lieu of sending flowers for funeral services, with said funds to be taken from the Past President's Parley Courtesy Fund. (1-12-2018 Mid-Year, N Platte NE)

- 4. A \$25 contribution shall be made to the Past Presidents Parley Scholarship Fund in memory of a deceased Past Department President with the funds to be taken from the General Fund. (1-12-2018 Mid-Year, N Platte NE)
- 5. Nurse's Scholarship Fund: a. The PPP Nurse's Scholarship(s) is/are selected and designated by the Department Advisory Committee from the nurses scholarships received from the Healthcare Professional Scholarship applications during the annual judging. The scholarship number and the amount determined by the annual contributions by the Units and at the discretion of the PPP upon review at the annual business meeting during the Mid-Year Conference. There are no separate PPP Nurse's Scholarship applications.

#### 6. Women Veterans

- a. This is formerly known as the Ex-Service Women Fund.
- b. The funds are derived from Unit contributions and are for the purpose of the gifts for women veterans who are residents of the four Nebraska Veterans Homes and the two Nebraska VA Medical Centers (VAMC). It is the duty of the Department PPP Chairman to contact the American Legion Auxiliary Representatives for the number of women veterans in their respective facilities and purchase a gift or gift card for each woman veteran twice a year, in an amount to be determined at the PPP annual business meeting. The PPP Chairman will be responsible for indicating on the gift the "to and from" and delivery or mailing of the gifts to the representative for distribution. Traditionally, these gifts are given prior to Christmas and another holiday of their choosing. The PPP Chairman will be reimbursed for the gifts and postage. A voucher with receipts needs to be submitted to the Department Secretary. The amount of gifts to be reviewed at the annual PPP meeting as compared to the account balance and documented in the meeting

minutes. The amount of the gift for 2022 was \$20.00. The amount for the 2023 gift was voted on at the annual meeting and will be \$25.00.

## 7. PPP Courtesy Fund:

- a. The Courtesy Fund is maintained by donations of \$5-\$10 annually of Past Department Presidents. It was determined that when the fund remains above \$100 donations need not be collected during the PPP annual meeting. However, individual donations are accepted at any time and deposited in the Department PPP Fund earmarked "Courtesy Fund".
  - i. The Courtesy Fund provides a memorial at the time of death of a Past Department President, as outlined in Section T Past Department Presidents #3. This donation will be sent by Department Headquarters.
  - ii. The Courtesy Fund provides for courtesy Department PPP lunch tickets for the Department President, National President, and the Northwestern Division National Vice President if in attendance.
  - iii. The Courtesy Fund provides a card and gift (the gifts are at the discretion of the PPP Chairman) sent by the Department PPP Chairman to a hospitalized or seriously ill Past Department President upon notification received from the Department Secretary. The PPP Chairman is reimbursed by a voucher submitted to the Department Secretary following the report to the members during the PPP annual meeting.
  - iv. Donations to special projects may be considered by a vote of the members attending the PPP annual meeting when the fund balance allows. (Note: per action of the 2005 meeting, special projects may be categorized as: special projects for current National Officers; support for the PPP members who hold a National Chairmanship, or for candidates for Northwestern Division or National Office.)

The Department PPP meets yearly with a luncheon during the Mid-Year Conference. As Chair, I make the arrangements. The Department President and the National President or Northwestern Division National Vice President are guests at this luncheon, with lunch tickets paid from the courtesy funds. These funds are maintained by PDP donating \$5 to \$10 annually. If the fund remains above \$100, donations need not be collected. Individual donations are accepted at any time and deposited in the Department PPP fund earmarked "Courtesy Fund."

Donations to special projects may be considered by the vote of the members attending the annual meeting when the fund balance allows. Special projects may be categorized as special projects for current National officers; support for the PPP members who hold a National Chairmanship, or for candidates for Northwestern Division or National office.

The rules for submission requirements and deadline information can be found on the National website – www.alaforveterans.org.)
- Utilizing Poppy donation collection cans

Remember that National Poppy Day is held on the Friday prior to Memorial Day. The date this year is May 24, 2024. Why not plan a special event for that day? (And then report it to me!)

## **Poppy Poster Contest Rules**

Units shall sponsor contests in local schools. When schools do not conduct activities, other youth groups — including Junior members — may participate under direct supervision of the unit.

#### **Contest Classes**

- Class I: Grades 2 and 3
- Class II: Grades 4 and 5
- Class III: Grades 6 and 7
- Class IV: Grades 8 and 9
- Class V: Grades 10 and 11
- Class VI: Grade 12
- Class VII: Students with special needs defined as:
  - a. Those in special education classes.
  - b. A student recommended for special education classes but who has not been admitted due to a waiting list or various other factors.
  - A child identified as having a disability, but not in a special education class due to lack of facilities; identification contingent upon discretion of school officials.

## Poppy Poster Requirements

- 1. Each poster shall have a fitting slogan not to exceed 10 words. Articles "a", "and," "an", "the" are not to be counted as words. The words "buddy" and "buy" cannot be used.
- 2. The words "American Legion Auxiliary" must be used in the design of the poster and will not be counted in the 10-word count.
- 3. Each poster must include a red poppy.
- 4. The department shall determine the closing date of the unit contest. The poster shall be on 11x14" poster board. (Drawing paper will not be accepted).
- 5. The United States flag may be used as long as there are no infractions of the flag code.
- 6. Posters will be judged using the following criteria:
  - 50% poster appeal (layout, message, originality)
  - 40% artistic ability (design and color)
  - 10% neatness
- 7. Media used shall be watercolors, crayons, powder or oil paint, handmade paper cutouts, ink or textures, acrylics, pencils, and markers.
- 8. Written in ink on the back of the poster (not attached) shall be the class in which the entry is submitted, the name, address, age, and grade of the contestant and the name of the department.

- 9. Submissions become property of the American Legion Auxiliary. Through submission of artwork, contestants and their legal guardians grant nonexclusive reproduction and publication rights to the works submitted and agree to have their names and artwork published for commercial use without additional compensation or permission.
- 10. The poster shall be the work of only one individual.
- 11. The label "In Memoriam" from the veteran-made poppy may not be used.

#### Poppy Poster Contest Judging and Awards

- 1. Each department shall establish its own procedure for judging.
- 2. A citation will be given for the most outstanding poster in each classification within the five divisions.
- 3. Unit members should follow deadlines and process for the department. All department entries are due to the division chairman by June 1.
- 4. While ALA representatives will do their best to return all posters, it is not guaranteed. We recommend participants take a picture or scan their poster for their records.
- 5. Submissions become property of the American Legion Auxiliary. Through submission of artwork, contestants and their legal guardians grant nonexclusive reproduction and publication rights to the works submitted and agree to have their names and artwork published for commercial use without additional compensation or permission.

#### 2023 – 2024 POPPY CENTERPIECE CONTEST

The following rules apply to both the Senior and Junior Poppy Centerpieces.

- Remove the labels from the poppies used in the centerpiece.
- SENIORS—use Department President Lisa Moore's theme—Nebraska Strong & Faithful Serving Veterans Always
- JUNIORS—use Honorary Department Junior President Samantha Stepanek's theme—Growing With Our Veterans
- Poppies must be predominant, using a sufficient number of small or large poppies, or a combination of both, to make a nice arrangement.
- The American Flag MAY NOT be used in the centerpiece.
- Centerpieces should have a maximum height of 12 inches and width of 12 inches to allow for viewing from all sides.
- **SENIOR** centerpieces are the work of a member of the Unit displaying it.
- **JUNIOR** centerpieces may submit a centerpiece created by the entire Junior group rather than an individual Junior.
- Unit name, number, and town should be securely affixed to the bottom of the centerpiece.
- Each District winning centerpiece will be eligible for the Department winning centerpiece.

Regardless of the size of your unit, you should take steps to ensure that your policies and rules are being followed. This ensures the protection of your financial accounts as well as the reputation of your unit in your community.

## What should you do annually?

- Review financial accounts: At the close of your administrative year, your unit's treasury and financial accounts should be reviewed by two people. These people should be appointed by the unit President and can be anyone other than the treasurer. It would be helpful if the treasurer could be available for questions.
  - Monetary outlays should be supported by either the Standing Rules or motions made during meetings. Invoices or vouchers are a great way to document this.
  - o Signers on financial accounts should be reviewed. Only authorized signers should remain on the signature cards, and there should be more than one person authorized to sign in the event the treasurer is unavailable.
  - o If the unit has a credit or debit card, transactions should be reviewed against bank account transactions.
- Review governing documents: The unit Constitution and Bylaws should be reviewed to ensure they follow National and Department documents. Minutes from unit meetings should be reviewed for compliance with unit Standing Rules.
- o **Review unit officers/chairmen in ALAMIS:** The listing of unit officers and chairmen within the ALAMIS system should be reviewed to ensure it is current.
- o Review bill payments: If the unit has bills to pay, ensure they are paid on a timely basis.
- o Keys/codes to meeting location: Review who has the keys/entry codes to your building. And who has the authority to give those out?
- o Insurance: Does your unit have the need to carry property insurance?

There are other items that could be reviewed, but the ones listed are a great start. How do these items help protect your unit's reputation? Embezzlement or default of payments destroys the trust that your community has placed in your unit. Even if restitution is made, the memory of the event remains and may impact membership and participation.

Risk & Compliance (formerly called Internal Audit) is important to us all and doesn't take a lot of time. Taking a little time upfront can save a lot of trouble down the road.

#### SERVICE TO VETERANS – MARY KRAUSE

I am Mary Krause. This is my first year serving as the Service to Veteran Chair. My mother signed me up as a tiny tot when I was two in 1964. My Unit is Ainsworth #79. I am eligible through my dad, Leroy Lucht. He was a lineman in WWII. I have served in the Unit and District level as President and Vice-President. I have also been on several local committees. I am proud to help and serve our Veterans.

Service to Veterans is a program to help assist veterans, service members, and their families without the structure of a VAMC. The volunteers conduct projects and work for veterans/military and/or families from their own homes or in their communities. It is very important that as a volunteer you keep record of the hours and dollars spent. These will need to be reported at the end of the year. Anything done directly for a veteran outside of a VAMC is considered Service to Veterans.

You can also count hours with work done in your home for the benefit of home bound, sick or injured service members and veterans. These activities might include sewing, mending, cleaning house and/or babysitting while a veteran attends medical appointments or rehab. You could even make quilts or make afghans for hospitalized or homeless veterans.

These hours can only be counted once and cannot be reported in other committees such as National Security or Community Service. If you are unsure which committee your hours belong to, just pick the one that makes the most sense. The main thing is to report your hours somewhere.

There are other ways to provide "Service to our Veterans." Here are a few.

- Visit with veterans. Offer to give them rides to appointments. Or just a drive in the country.
- Offer to stay with a veteran so their caretaker can have a break or get groceries.
- Treat veterans to a show or sporting event.
- Transitional housing programs have many needs. Secure donations for staple items such as laundry soap, cleaning supplies, kitchen items, new undergarments, etc.
- Donate a membership to the American Legion. Arrange an outing to a Legion meeting or special events such as a Veteran's Day dinner, memorial service, etc.

As your Service to Veterans chair, I will work with Units in assigning tray favors, centerpieces and door hangers for the VA facilities in Nebraska. When making tray favors or centerpieces, remember safety. Do not have anything sharp or edible. Your items will need to be mailed or delivered to the facility at least 2 weeks(or even a month) in advance to the month assigned.

The assignments will be posted in "The Star." If you see an empty spot, please consider filling it.
