You should be transmitting your posts membership renewals at least every two weeks to Department. Our goal is to be at 100% by December 31st. Reaching this goal will ensure we keep our members from becoming delinquent. Continue to work your membership drive hard. I would like to see our department at 80% by the end of November. Yes, it is a challenge, but I believe we can achieve this goal. Remember to be proactive in notifying your members for their dues and don't wait for national to provide membership renewal notices. Call your members or visit their houses for a personal visit. For all our members who have not paid your dues for 2024 yet, please do so. Your membership is very important to the success of our four pillars and youth programs.

Everyone should be familiar with our **Buddy Check** call program. If you have not been doing them; then I ask that you began to do so. The main reason for our **Buddy Check** phone calls is to ensure our veterans, spouses, and family members are doing well and if they need help or assistance, we are there to help them. What has come out of the **Buddy Check** initiative is a new program by our national organization called **BE THE ONE**.

Here is the catch. The American Legion National Commander in conjunction with the National Auxiliary President and the Sons National Commander have made the *BE THE ONE* not to be just a new initiative or program, but rather a new **MISSION** for all Legion, Auxiliary, and Sons members to be actively participating in. The purpose is to engage your fellow veterans, spouses, and family members like we do in a *BUDDY CHECK* program; but, to take it one step farther. Follow the acronym ALR (no not the riders). The first step is for "A" and **ASK** the individual how they are doing. Next, is step number two "L". Here **LISTEN** to what they have to say. This is the most important step. Finally, is step number three "**R**". If necessary, **REFER** the individual for help and steer them into the right direction to get help.

If we can reach just one veteran, spouse, and family member from committing suicide then our actions under this new mission will have proven to be valid and a worthwhile objective. Saving one life is very important. No, we are not trying to make anyone a counselor or professional mental health person. But, just by engaging someone who you know might be depressed or a little off their game and getting that individual help or assistance is worth all the effort we put into this mission. This is not a just a year-long mission. Consider it a new *LIFETIME MISSION*. Please, do not use the *BE THE ONE* mission for membership drives.

Last month many of you likely participated in a Veterans Day celebration or took advantage of "Veterans Day" sales at your favorite retail store. Whether you were honoring the veterans in your life or scoring a great deal, hopefully you took a moment to reflect on the true meaning of Veterans Day. I was fortunate enough to be invited to speak at this year's Veterans Day event held at South Omaha Post 331. To everyone who participated, it was an absolute HONOR to spend the evening with you – especially WWII Navy veteran Carl Schratt. As the oldest and youngest veterans in attendance, Carl and I had the pleasure of cutting the cake together!

#### **History of Veterans Day**

Veterans Day, originally known as Armistice Day, was first commemorated, by proclamation of President Woodrow Wilson, on November 11, 1919 to honor those who served in World War I. Wilson stated "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..." On that day, two minutes of silence were observed at 11am, the time when the armistice, or temporary cessation of hostilities, went into effect between Germany and the Allied Nations. This tradition continues today.

On June 4, 1926, Congress passed a resolution calling for the President of the United States to issue an annual proclamation observing the importance

of Armistice Day. Twelve years later, on May 13, 1938, Congress passed a special act making Armistice Day a federal holiday with the expressed purpose of promoting world peace and mutual understanding between nations.

Although WWI was known as the "war to end all wars," we know that was unfortunately not the case. Over 16 million people served in WWII and 5.7 million people served in the Korean War. In light of these two wars, veterans' service organizations lobbied Congress to amend the 1938 act to change Armistice Day to Veterans Day in order to honor veterans of all our wars, not just WWI. That legislation was signed by President Dwight Eisenhower on June 1, 1954.

Veterans Day is not to be confused with Memorial Day - a common misunderstanding, according to the U.S. Department of Veterans Affairs. Memorial Day (the fourth Monday in May) honors American service members who died in service to their country or because of injuries incurred during battle, while Veterans Day pays tribute to all American veterans - living or dead - but especially gives thanks to living veterans who served their country honorably during war or peacetime.

Many of these veterans continue serving their communities even after their discharge from the military. A prime example is the work being done by Legionnaires in Nebraska. Whether it's raising money for Legion programs, mentoring children through baseball or scouting programs, visiting the elderly or sick in our veterans' homes and hospitals, or honoring our fallen at graveside ceremonies, Nebraska Legionnaires contribute positively to the health and well-being of our society. So, not only on Veterans Day, but every day of the year, I'd like to say thanks to all our veterans for everything they have done, and continue to do, for our Nation.



#### Urgent Care Access for Veterans Enrolled in USDVA Health Care (VA)

We are in the flu and cold season and some options to where to receive prompt care for minor symptoms as well as obtaining the flu vaccine to fit within our busy schedules may be eluding veterans who currently use VA health care.

Veterans who are eligible for VA healthcare and have received care through the VA or a VA community provider within the previous 24 months are eligible to use the VA urgent care benefit. You may verify your eligibility by contacting your local VA medical facility should you not recall if you have received care in the past 24 months. You may also call 800-698-2411 (as with most phone calls to VA this is an arduous method).

Urgent care is for treatment of minor injuries and illnesses, such as minor skin infections, colds, and sore throats. This benefit is offered in addition to receiving care from a VA provider and offers the opportunity to be seen the same day without going to an emergency room. The urgent care provider must be part of the VA's contracted network of community providers (note urgent care does not include preventive care and dental care).

To find an available urgent care provider in your area who is in the VA's contracted network, visit the website https://www. va.gov/find-locations/ . Type in your city or zip code, choose "Urgent care" and select "Search." You may also contact your local VA team and ask that they provide you with a list of urgent care providers.

Depending on your individual eligibility and private insurance(s), the billing for urgent care should be billed by the urgent care provider to a VA Third Party Administrator. Depending on the Veteran's individual priority group assignment the VA may bill the Veteran a copayment if applicable.

Priority Groups 1-5, \$0 co-pay for first three urgent care visits (per calendar year) and \$30 co-pay for the fourth and greater visits during the same calendar year. Priority Group 6, if related to a condition covered by a special authority, \$0 co-pay for first three urgent care visits (per calendar year) and \$30 co-pay for the fourth and greater visits during the same calendar year. If the condition is not covered by a special authority the co-pay is \$30 per visit. Priority Group 7-8, co-pay is \$30 per visit. There is no co-pay for any priority group (1-8) for a visit consisting of only a flu shot. For more information on VA priority groups for health care please visit the website https://www.va.gov/health-care/eligibility/priority-groups/.

#### **Flu Shot Access for Veterans**

Veterans who are enrolled in VHA health care and have received care through the VA or a VA community provider within the previous 24 months are eligible to receive the flu vaccine from the VA or local provider in the VA's community care network at no-cost to the veteran. To locate a no-cost flue shot near you, you may use the same VA locator ( https://www. va.gov/find-locations/ ).

Lieutenant Junior Grade Michael Steele Confer entered the U.S. Navy from McCook, Nebraska and served with Attack Squadron 23 aboard the aircraft carrier USS Coral Sea.

On October 10, 1966, he piloted an A-4E Skyhawk (151150, call sign Lawcase 340) that launched from the USS Coral Sea on a nighttime armed reconnaissance mission against targets in North Vietnam. After the target was illuminated with flares, LTJG Confer radioed to his flight leader that he was rolling in for a rocket run. He launched his rockets at the target, and the flight lead saw the rockets impact; he also saw another larger flash. When he could not contact his wingman, his lead realized the larger explosion was Confer's aircraft impacting the ground. There was no evidence that Confer ejected from his aircraft before impact. An extensive search was conducted, but LTJG Confer could not be recovered. Further attempts to locate or identify his remains have been unsuccessful. His remains have not been repatriated.

The official Navy report indicates that Confer's aircraft was likely struck by a surface to air missile and exploded, and that he was unable to eject. Confer was listed as "killed in action/body not recovered." The file is classified, and no further information is available.

Michael has three brothers, Rod, Kent, and Dr. Dennis Confer. Dennis spoke to a 2012 Memorial Day ceremony in the Culbertson cemetery. He explained that the life of a big brother is never forgotten, and that the sacrifice made by a good person and a true American service man has the power to impact the world even years later.

Dr. Confer went on to say that he had been in Hanoi on a business trip and discovered that he was 100 miles from where Mike had died. After a four-hour bus ride from the hotel in Hanoi, Dr. Confer found a witness to his brother's crash, Mr. Tran Huu Khue. Mr. Khue knew everything about Mike's crash into the Gulf. Mr. Khue's story was like the Navy's investigation, with one exception. Mr. Khue thought that Mike's plane was disabled, and that Mike was trying to keep the plane from crashing on land where villagers lived, and tried to ditch in the water, but the plane exploded before he could eject.

Vietnamese are respectful of the dead. Villagers gathered Mike's remains and buried them on a sandbar that has since washed away. Villagers recovered parts of Mike's aircraft and used the metal to make tools. Mr. Khue gave Dr Confer a small square made from the aircraft. Dennis vowed to keep it forever.

LTJG Confer is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific and inscribed on the Vietnam Memorial Wall in Washington D.C.

Mike graduated from McCook High School in 1960 and is memorialized at the school's Weiland Football Field. The memorial is decorated with a Veterans Poppy, and the sign is a quote from Michael: "Tisn't life that matters, it's the courage you bring to it."

A tremendous ride through the spring high school and summer American Legion baseball seasons came to an end in defeat for Carpet Land of Lincoln East. The "Rugs" fell 1-0 to League City, Texas ending a miraculous run.

The Lincoln East "Rugs" Baseball Team, sanctioned by Post 3 and sponsored by Carpet Land of Lincoln, fell one run short of becoming Nebraska's first American Legion World Series Champion in 84 years when Creighton Prep won the crown in 1939.

The "Rugs" reached the World Series as champions of the Central Plains region. They reached the semifinals with a win over Cedar Rapids, Iowa. The opponent, League City, Texas punched its ticket to the semifinals when Cheyenne, Wyoming beat defending champion, Troy, Alabama, leaving League City as the only unbeaten team remaining in its pool.

The "Rugs" came up short in their first ever bid in the American Legion World Series in the championship game in Shelby, North Carolina. They finished as the NSAA Class A State Champions, Class A State Legion Baseball titleholders and champs of the American Legion Central Regional with a combined 84-16 record.

Congratulations, "Rugs"! Truly, a tremendous accomplishment.

#### Veteran's Name Lives On

Merlin Elmer Palmer was born to Judson and Julia Palmer in Stamford, Nebraska on February 14<sup>th</sup>, 1893. Perhaps being born on Valentines Day gave Merlin the heart for serving his country and his passion for engineering. In 1912, Merlin moved to Wrangell, Alaska and lived with his brothers. He worked on a logging crew for some time and then bought a local restaurant with a friend of his. After six months, Merlin sold his share and headed back home.

Merlin's adventurous nature kicked in again and he headed to college in Des Moines, Iowa. It was there he discovered his natural ability in running cross-country. He won the "Abbreviated Marathon" his first year. Merlin left college with his Electrical Engineering degree and in the fall of 1917, Merlin became an electrical engineer and worked at the Alma power-plant.

When President Woodrow Wilson, asked Congress to declare war on Germany on April 2, 1917, Merlin knew what he needed to do. He joined the U.S. Marine Corps just one day before his 25<sup>th</sup> birthday.

After training at Paris Island, the young Marine boarded the transport ship, USS Henderson and headed across the Atlantic Ocean. Marines were not always well known publicly, and World War 1 transformed the Marines to well-known, battlefield warriors.

The toughest assignment, after months of battles, would be Blanc Mont Ridge. Germans occupied "pill boxes" for four years. These were sloped hills with bunkers which gave them the maximum advantage.

In December 1919, Alaska's American Legion was assembled, and they voted to name the post after Merlin. The Merlin Palmer Post No. 6 continues to provide space for large gatherings and community events. The second post name after Merlin is in Stamford. Merlin Palmer Post No. 233 is active in public service and patriotic exercises.



In 1979, Congress passed a Joint Resolution (Public Law 95-349), and President Jimmy Carter's Proclamation 4664 -- National POW-MIA Recognition Day -- made it official. The very first one was on July 18, 1979.

As Americans, we enjoy the



Shubert ALA accepted the honor of being accountable for the displaying and safekeeping of the Medal of Honor wreath on Memorial Day, Veterans Day, or any other special occasion.




