

# $American {\it Legion Legislative Priorities}$



Each year, The American Legion selects about a dozen priority items to present to Congress that impact active-duty military, veterans, and their families. These priorities are chosen based off of the positions and views of its 1.6 million members. Once released the 2024 legislative priorities can be found at www.legion.org/washingtonconference/legislativepriorities.

These priorities align with the ideals of The American Legion: Mental Health and Suicide Prevention, VA Healthcare Modernization, PACT Act Implementation and Oversight, Protecting Veterans from Predatory Actors, Military Quality of Life, and Protecting the American Flag. To support these priorities and lobby the members of Congress, members from all 55 American Legion Departments make their way to Washington DC every February to participate in the Washington Conference. During this conference, The American Legion Family members visit with their State Senators and Representatives to see how they plan on voting on the priorities and why they feel the way they do about them. Nebraska will have more than fifteen members from The American Legion Family who will be attending the Conference and will be meeting with the State's representatives.

In Nebraska, the Nebraska Veterans Council (NVC) hosts its own version of Washington Conference on the state level. The NVC is made up of members of The American Legion;

Veterans of Foreign Wars; Disabled American Veterans; Vietnam Veterans of America; American Veterans; The Military Order of the Purple Heart; Paralyzed Veterans of America; the Marine Corp League; and the County Veterans Service Officer Association of Nebraska. The NVC chose four bills that they support. They invited the Senators who submitted the bill to come and speak to the group. The priority bills chosen this year were LB 869, to change provisions relating to services of the county veterans service committees; LB 1037 is to prohibit unethical conduct and improper collection of fees relating to assistance or referrals in veteran's benefits matters; LB 126, changing provisions relating to homestead exemptions; and LB 853 having to do with a homestead exemption credit for disabled veterans.

The day served as an avenue for the Veteran Service Organization members to talk to their State Senators and see how he or she is planning to vote. Following the session, members from all organizations were encouraged to go and talk to their own State Senator to see how they stood on the priority bills. Thank you to everyone who attended and made the day a success.



#### February 1933 (91 years ago)

• <u>FRIENDSHIPS</u> ceased between the commanders and adjutants in the Department on February 1st, all the way down from Department Commander Bob Armstrong and Department Adjutant Hectic Hank Dudley down to the smallest posts for a big <u>MEMBERSHIP</u> <u>CONTEST</u> between the commanders on one side and the adjutants on the other for the entire month.

• Martin-Graves <u>BELLEVUE</u> Post is apt to lose its deserved popularity with youngsters in Sarpy County as the result of its decision to provide <u>CODLIVER</u> oil for children of unemployed.

• Shoes, stockings, and overshoes for needy <u>CHILDREN</u> were provided by <u>SPENCER</u> Post 78 because of card parties and dances, at which the sum of \$135 was raised. This amount of <u>MONEY</u> allowed the post to do some real <u>WELFARE</u> work.

#### March 1943 (91 years ago)

• Mason Colbert was the first Legionnaire of Nebraska City Post 8 to turn in a <u>SHOTGUN</u> in answer to the war department's call for such arms. A committee of Legion members had been appointed to supervise the collection of guns in the Nebraska City area. The war department is collecting good 12-guage shotguns for <u>TRAINING</u> soldiers and sailors.

• With its issue of the March 4th Douglas County <u>LEGIONNAIRE</u>, official publication of Omaha Post 1, embarked on a progressive program of enlargement which will give subscribers at least an eight-page paper each week.

• An old-fashioned box <u>SOCIAL</u> held recently by the <u>LYMAN</u> post at State Line school house was well attended despite disagreeable weather. The sale of <u>BOXES</u> brought nearly sixty dollars towards the Post's project of sending the hometown newspaper to all men in service from the community.

• A half-dozen spray <u>PUMPS</u>, acquired by <u>VALENTINE</u> Post 90 from the proceeds of salvage material gathered and sold by the post, proved of great value in fighting a large prairie fire March 3 in the south part of Cherry County. A newspaper account of the fire states that the spray pumps were of immeasurable value in holding the blaze in check until backfires could be started.



#### VA Pension Debt Notification Letters to Beneficiaries

The United States Department of Veterans Affairs (VA) recently (November 2023) released information that the VA had established debts for certain veterans and survivors who have been receiving pensions.

The debts were created as a result of discrepancies with data provided by those receiving pensions and data VA received from the Social Security Administration (SSA). The debts were a creation of the VA and SSA failing to develop a method to verify accuracy of self-reported social security income of veterans and survivors between 2011 and 2022. VA pension payments are based on income level, which is self-reported by the veteran or family member who received the payments and then verified by VA; however, the verification process did not occur for over a decade, which has resulted in overpayments to veterans and survivors who have been receiving pension payments between 2011 and 2022. VA resumed the income verification process in July 2022, which resulted in nearly 10,000 beneficiaries being identified as receiving overpayments, some overpayments spanning several years and amounting to fairly large debts. Many of these veterans and survivors are elderly, live on fixed incomes and are considered low-income (having little resources and a relatively low-income is a requirement of receiving VA pension), which means for the majority of these individuals identified as receiving overpayments have no or little means to repay the overpayments, resulting in significant financial hardships and unnecessary stress. VA has informed those identified as receiving overpayments, that they have paused the collection of all established pension debts. This does not mean the debt issue has been resolved, only that VA has decided to currently pause any collection of currently identified pension debt. If you are a veteran or survivor who is receiving pension payments from the VA and have not received information regarding the pause to collections of previously identified debt, please take the time to verify if VA created a debt on your account. I encourage all those receiving pension payments to check your VA account on VA.gov or by calling the Debt Management Center at 800-827-0648 (Monday-Friday, 7:30am to 7:00pm Eastern Time) to verify if you have a debt and if debt collections have been paused for debts created as a result of the VA/SSA verification of income failure. Staying informed is your best protection should the VA determine it is appropriate to begin collecting the debt. Should you have any concerns or questions about VA pension in general I encourage you to reach out to your county veteran service officer (CVSO). Veteran Service Officers are experienced in assisting veterans navigate VA benefits and can be an excellent source of information regarding federal, state and county veteran benefits.

If you are a wartime veteran or survivor of a wartime veteran in need of income to provide for your household, please contact your local CVSO to discuss if you may be eligible to receive VA pension benefits.





William Marshall Roark was born 23 October 1943 at Sioux City, Iowa; and grew up in Omaha. He graduated from Omaha Central High School and was the cadet colonel and commanding officer of the school's Junior ROTC. He was appointed to the U.S. Naval Academy in 1956, graduated and commissioned ensign on 8 June 1960. He attended naval flight school at Pensacola, Florida and Beeville, Texas.

Lieutenant Roark was a member of Attack Squadron 153. On the second deployment in 1965, flight crews of the Coral Sea saw the first heavy and sustained action of the Vietnam War during Operation Rolling Thunder.

On April 7, 1965, he piloted an A-4C Skyhawk, (148317, call sign Power House). LT Roark was leading a two-ship section armed reconnaissance mission in Dong Hoi, North Vietnam. His flight detected an anti aircraft artillery (AAA) site and engaged the target. Following the first attack, the site had not been destroyed. During his second attack, the Skyhawk was shot down and crashed off the coast of Dong Hoi. LT Roark ejected prior to the crash but was killed by enemy fire while parachuting to the sea. It was not possible to recover his body at the time of loss. Vietnamese government eventually repatriated human remains that U.S. analysts were able to identify as LT Roark.

On March 31, 1977, the Central identification Laboratory identified the remains of Lieutenant William Marshall Roark. Some reports state: "REMAINS NOT RETURNED AS REPORTED 03/18/77, CACCF CRASH/PILOT/BODY RECOVERED." Roark is listed as remains returned by the DoD 1996 list. Further information is classified, and not available.

LT William Marshall Roark was posthumously awarded the Purple Heart and Distinguished Flying Cross. Remains are buried at Evergreen Memorial Park Cemetery in Omaha. LT Roark is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific. His name is also inscribed along with all his fallen comrades on the Vietnam Veterans Memorial Wall in Washington, DC.

In his last letter to his wife, LT Roark wrote, "I don't want my sons to fight a war I should have fought. I wish more Americans felt that way. I will not live in a totalitarian society." "I believe in God and will resist any force that attempts to remove God from society, no matter what the name."

The first ship to be named for someone lost in the Vietnam War was the U.S.S. Roark, FF-1053 (1969 – 1991). The Roark launched 24 April 1967; by the Todd Shipyards Corp, Seattle, Washington; sponsored by Mrs. William M. Roark and Mrs. Frank F Roark; and commissioned 22 November 1969, Commander Wayne L Beech in command. The Roark was a Knox class frigate. The Roark received three battle stars for Vietnam service. February 2001 the Roark was at the shipbreakers in the Port of Brownville, Texas, awaiting the cutting torches.




A young child asked his mom, "What is a New Year's resolution?" The mother without batting an eye, responded by saying, "It is a to-do list for the first week of the new year."

Hopefully, when we commit ourselves to the Christian faith, we don't approach that commitment as a new year's resolution and abandon it in a week, a month, or several months. Rather, as Christians, the goal is that our faith becomes such a part of our identity that when we live, we live as Christ lives in us.

The name, brand mark and emblems of The American Legion are registered service marks in the U.S. Trademark Office and protected by criminal and civil provisions of federal law (18 U.S.C. S 705 and 36 U.S.C. SS 21704 and 21705). Under authority of the National Executive Committee's May 2018 Resolution #1, the National Adjutant, or his designated representative (currently only the Director of American Legion Emblem Sales), may grant permission for a limited licensed use of the name and/or emblem(s) of The American Legion for use in accordance with the NEC's May 2018 Resolution #1 and U.S. Trademark Law.

To request limited licensed use of the name, brand mark and/or emblem(s) of The American Legion, please complete this form and forward it to your Department Headquarters Adjutant. Your Department Adjutant will forward the completed form to The American Legion - Emblem Sales Division. Please note that the member, or Post, requesting the name, brand mark and/or emblem(s) use must specifically define the intended use, identify the Post and quantity desired. The limited license, if granted, will only apply to the listed manufacturer. Any name and/or emblem(s) or brand mark limited license granted is given on a one-time use for the specific quantity listed. Any additional quantity over this number will require a new request as the manufacturer is strictly prohibited from producing more items than that being authorized. This limited license requires that all items are specifically manufactured as requested and HQ may request a sample item. Please note that if this limited license request is for merchandise available through American Legion Emblem Sales, the request will be denied. If the merchandise is not available through American Legion Emblem Sales, you may receive a limited license for the merchandise manufacture. Please note that if you are denied permission, you may still be able to purchase merchandise directly from an approved American Legion licensee or their retail outlets. # **Boyd Yochum** Department of Nebraska Commander



Yes, I was in Vietnam. We were winning when I left. I was raised on a small farm near Ashland but grew up in the Army. I graduated from Ashland High School, and while in the Army I attended the University of South Vietnam, Vinh Long Campus with a dual major in Counter Insurgency and Air Cavalry Operations. After my time in the Army, I received degrees from the Lincoln School of Commerce and Doane College. I enlisted in the US Army in January 1967. As this article is being written at the conclusion of the Mid-Year Conference, I'm glad to report that Nebraska exceeded the 80% of goal needed on the January 18th Mid-Winter Target Date. In fact, we exceeded the 85% mark (February 14th target date) when we gathered in Kearney for our Mid-Year Conference. The temps may be cold, but let's stay hot on membership.

You really need to read the rest of this article. There are a few things you need to know. MOST ALL OF YOU CAN SAVE SOME REAL MONEY!!

As I reported in the last issue, the national convention increased national dues by \$5.00 effective with the first dues notices that go out this summer for 2025 dues. And a resolution will be presented at our department convention in June proposing to increase our department dues by \$5.00, effective at the same time as the national increase. The national increase is a certainty; the department dues increase is very likely.

On December 4th, the national organization implemented what I call "Phase I" of a 3-year renewal option for members who were renewing online for 2024. The option is only available for those who renew online. Post adjutants and department headquarters staff are not involved in this new option.

When choosing this option, the renewals for 2024, 2025, and 2026 are all done at the 2024 dues rate. As a result, what is most likely going to be at least a \$10.00 dues increase per year can get pushed down the road for 2 years. You can most likely save at least \$20.00 (more if your local post increases its dues for 2025 and/or 2026).

For those of you who had already renewed by December 4th, there is also some good news for you. According to the latest information I just received from the Internal Affairs Division while I was at the Mid-Year Conference, "Phase 2" of the new option went live on January 22nd. When it did, those of you who have already paid your 2024 dues are now able to renew online for an additional 3 years at the 2024 rate --- thus receiving the same benefit made available to those 2023 members who renewed initially for 3 years online.

Renewing online is quick and easy. Go to www.Legion.org and click on the "RENEW" button. Just enter your name and ID number, and a variety of options will be presented to you --- including a quote for a PUFL membership. (If your birthday isn't in the database, you will be prompted to provide it. While a PUFL membership is admittedly expensive and perhaps not for everyone, this may be a good time --- before dues go up --- to consider that option, too.)

For those of you who aren't connected online, there is a work-a-round. Pay your dues to someone who has a computer and give them your American Legion ID number. They can then access the site, enter YOUR name and ID number, and pay for you with their credit card. Have a nice February.

#### Purpose of The Member Data Form

The American Legion Member Data Form (MDF) is a multipurpose form for tracking and providing accurate information on Post members. You can download the form online on our website. With the exception of transferring members from one post to another, most MDF changes can be made through MyLegion.org.

Note: Members can be transferred online through MyLegion.org if the member is paying their dues at the time of transfer.

The MDF can be used to report deceased members, continuous years, name corrections, address changes, branch of service, war era, and others.

On the MDF, always include the nine-digit member ID number, Post number, and Department name. The signature of the authorized Post officer is required at the bottom of the form. Be sure to mail part 1-3 to Department Headquarters and keep part 4 for your Post files.

Membership transfer from one post to another is handled by completing the MDF. Always ask prospective members if they currently are or have been a member. If the veteran has a current or previous nine-digit ID number, it should be reported on the transfer. If a member signs up as a new member, a duplicate record can be created, and multiple renewal notices will be received by the member.

Recently I was asked the question, 'When members do not pay their dues, how many times should we reach out to them to see if they will renew their dues?" This unit president followed that question up by stating that their unit has tried e-mailing notices, sending letters, and making phone calls to encourage these members to pay their dues. She ended with, "We want to be assertive, of course, to get our memberships renewed, but do not want to 'harass' any member in any way."

My gut reaction was to answer her question with an abrupt "as many times as it takes." But, then I remembered that some of us live in small towns where these member(s) are our friends and neighbors, making continual "asks" difficult. Some of us live in larger areas where we may not be as well acquainted with the member(s) in question, so repeated contacts could become awkward. Some of us are extroverts who may have been labeled as pushy due to repeated requests for payment; and some of us are introverts who do not enjoy approaching the same folks over and over again to obtain their dues renewals.

At that point, I thought, "Let's

get creative. What have I heard from others about innovative ways to approach those who have yet to send in their membership renewals?" Here are some ideas I've heard in the past:

• One unit had a member who was going through some unexpected health issues and the resulting medical costs thereof. Money was a serious issue for this member at the time. But the member was very creative, so the unit voted to pay her dues renewal if she would be willing to make the tray favors for the unit that year. She was beyond grateful to be asked.

• One unit had a couple of members who had moved to nursing homes and were not able to pay their own dues. That unit voted to pay the dues for any long-term Auxiliary member (ten or more years of membership) who was no longer able to manage his/her finances.

• Another unit focused on the adult children of their members who were now in care facilities. Knowing that these children were proud of their parents' service within the Legion Family, they quietly let the children know that Legion Family grave markers are only available to members who are in

good standing at the time of their passing. The children wanted to be sure their parents' service would be remembered and took over making the dues payments.

• One unit had all their renewals in place, but could not get their unit to 100 percent in membership because that required finding two new (or rejoined) members. This unit contacted the families of those with eligible children in their households and highlighted the scholarship programs available to Junior members of the American Legion Auxiliary. The unit gained three new Junior members, lifting them to 100% status.

So, let's hear from all of you now. In what innovative ways has your unit approached those members who are slow to renew their dues? These are tidbits we all need to share with each other.

SALUTE TO SERVICEMEMBERS AWARD

• The servicemember must have

an endorsement from a member of their command group.

• The nominating forms and all supporting documentation must be completed and submitted by 4:00 pm Central Time Zone on June 1, 2024.

The nomination is completed online from the National website alaforveterans.org. From the Committee tab, select National Security, click National Security Program Awards, then under Salute to Servicemember Award, click Award Nomination Form and Information.
