"Gifts for Yanks"



The American Legion Family is grounded on four pillars: Veterans Affairs and Rehabilitation (VA&R), National Security, Children and Youth, and Americanism. These pillars are how The American Legion Family chooses the programs to support. VA&R is the largest and can be considered the most important pillar. Each December, members of the Nebraska American Legion Family join together to support and give back to the veterans in the state veterans homes and medical centers by hosting Christmas Gift Shops and Gifts for Yanks.

"Gifts for Yanks" was born out of the WWII era. During World War II, Comedian Eddie Cantor started a fundraising effort focused on providing Christmas gifts for American military members hospitalized in England because of the war. His national project was called "Give to a Yank Who Gave". Today, throughout the US, American Legion Families have adopted that idea now known as Gifts for Yanks.

In Nebraska, Legionnaires, Auxiliary members, Sons of The American Legion, our Legion Riders are co-sponsors of the Gifts for Yanks program. The donations that are received at Headquarters are redistributed in the form of \$25.00 dollars to any veteran living in a veteran's home, medical center, or regional center and \$20.00 dollars to any spouse of a veteran living in the facilities. Everyone

at the Gifts for Yanks party receives a calendar as a Christmas gift from the American Legion Family as well. A Christmas Gift Shop is held for the veterans at the medical centers. There they are able to pick out three or four gifts for their family members and the volunteers wrap these gifts for the veteran to take home with them. These items vary from toys, kitchen items, household goods, and many others. For many of the veterans and spouses in the facilities, these are the only gifts they receive throughout the holiday season.

We had a nice visit with John Folsom, who is building The Dunham House in Omaha. The Dunham House will provide combat wounded veterans with top level care and a supportive community where they can live with dignity and independence. John's Grandfather Shirley Folsom was one of the original founders of the American Legion.

Since becoming your National Historian back in August, I have been busy working with the National Headquarters staff to create a new 2025 Historians Guide. This guide, which is available at https://legionhistoryshowcase.omeka.net/exhibits/show/2025entries/2025-contest-and-showcase-info, can be used by county, area, and district historians throughout The American Legion for the development of a well-rounded history, whether the yearbook is entered into a contest or not.

As you read through the guide, you will notice one major change – there will no

longer be a post history contest at the National level. Post yearbooks (either hard copy or digital) will be entered into a National showcase. What does that mean exactly? It means that departments can send one digital post yearbook and one hard copy post yearbook to National to be on display for the entire Legion Family to see. The digital post yearbooks will be "showcased" on https://legionhistoryshowcase.omeka.net/exhibits and the hard copy yearbook will be "showcased" at the 2025 National Convention in Tampa. Please note, the hard copy yearbook and digital yearbook can be from different posts.

Although we have not had a department-sponsored yearbook contest since I have been Department Historian, I would like to change that. With that being said, I will be working with Department Headquarters staff to figure out what a contest might look like. Even if we don't have a contest in place by next summer, I would still love to be able to submit to National a digital yearbook from one post and a hard copy yearbook from another post. If you are interested in submitting your yearbook to me for consideration to the National showcase, please use the guidelines contained in the 2025 Historian's Guide to help you develop your yearbook.

To help people navigate through these guidelines and the submission process, I will be providing training at mid-year in January in Norfolk. Would love to see a big turnout!

In addition to developing new guidelines for historians, I have also been working with Department Headquarters to establish a museum in the new Headquarters building. Fortunately a lot of the legwork was already done by Executive Assistant Amanda – she organized and catalogued many of the items in the historical collection and all I had to do was go through and pick some of the neatest items for display in the display cases. On one Saturday in October, we worked to get four of the existing cases set up. There are currently two cases dedicated to WWI and two cases dedicated to WWII.

Next, we will be moving on to the Korean War, Vietnam War, and Global War on Terror (GWOT) – all of which will be displayed in beautful cases made by Past Department Commander Lyle Bartels. In the process of cataloging the items, we realized that we do not have a lot of GWOT memorabilia. I would like to encourage any GWOT-era Legionnaire, if you have any unique item from your time in service that you would like to donate for potential display in the museum, please email me a description and picture of the item to historian@nebraskalegion.net. I will work with Department Headquarters staff to see if this is something we would like to display in the museum.

Thank you for all you do in providing future generations with histories to help them remember what was done in the past and remain inspired to continue moving The American Legion forward.

Two-year review of the PACT Act regarding veteran benefits

We recently just passed the two-year anniversary of the PACT Act, August 10, 2024. In reviewing the data for the first two years of the PACT Act there is some very positive news for veterans. The first being that nearly 75% of PACT Act related claims are being granted as service-connected conditions. According to the VA, VBA had received over 1.85 million PACT Act related claims by the first week of August 2024, of which nearly 1.3 million have been completed with more than 1 million approved claims for PACT Act related conditions. The most frequent reason for a denial is "no diagnosis." The total PACT Act benefits paid to veterans and survivors has exceed 6.8 billion dollars during the first two years. The benefits to Nebraska veterans and survivors have exceed \$46 million during the same period.

During the first two years of the PACT Act the five most frequent conditions claimed being Hypertensive Vascular Disease (hypertension/high blood pressure), Allergic Rhinitis, Maxillary Sinusitis, Bronchial Asthma, and Chronic Bronchitis. I know many veterans are seeing a 0% rating for hypertension, in fact currently, according to the VA, over 82% of hypertension claims approved are being rated at 0%. A 0% rating is still valuable rating for a veteran, for being service connected for hypertension, regardless of percentage of disability assigned, opens the door for claims for secondary conditions which may be considered for further benefits, conditions associated/caused by hypertension often receive a higher disability compensation rating than hypertension. If you are service connected for hypertension and have been diagnosed with a heart disease, kidney disease, sleep apnea, peripheral artery disease (PAD), an aneurysm or have had a stroke, you should discuss this with your local accredited veteran service officer to better determine if a secondary claim to your service-connected hypertension should be submitted to VBA. Another benefit for a hypertension rating, even at 0% is that those who are not rated at 100% P&T or have not been rated at 100% P&T for 10 or more years, think Dependency and Indemnity Compensation (DIC). Hypertension is a serious condition and often is often a contributing factor to a person passing. Most medical professionals consider hypertension to be a serious condition and will list hypertension on a death certificate as a contributing factor. This is important as this does provide another condition for a surviving spouse to use when submitting a claim for DIC. One may also want to consider the option to appeal the rating of 0% for hypertension, if there is clear medical history demonstrating a diastolic pressure predominantly higher than 100 or a systolic pressure predominantly 160 or more. This argument can be made based on the requirement to take continuous medication to prevent blood pressures exceeding medically recommended values. As always working with an accredited service officer is the best method to experience success in navigating the VA benefits you have earned from service to our great Nation.

In 1969 I was a 25-year-old fighter pilot serving in Vietnam flying combat missions in the F-105. During the first four months of 1969, I was assigned to the 34th Tactical Fighter Squadron flying missions out of Korat Royal Thai Air Base. In May of that year the Squadron was converted to F-4E's because the Air Force was running out of F-105's. Also, during that period five of my fellow pilots would end up not surviving the War. In 2009 while visiting the Vietnam Wall I discovered that the remains of three of these men had been left in Southeast Asia and I decided to bring them home. In 2018, after four trips to Laos and extensive involvement with the Defense POW/MIA Accounting Agency (DPAA) we buried the remains of my good friend and roommate Lt. David Dinan at Arlington National Cemetery.

By coincidence my last two friends are Nebraska natives. Major Harold "Pappy" Kahler was born and raised in Lincoln where both of his parents were employed by the State of Nebraska working at the Governor's Mansion and Capital. He enlisted in World War II and flew as a pilot on the B-17 and B-29 as a flight instructor. He never left the states and saw no action. After the war he returned to Lincoln and joined the Nebraska Air National Guard's 173rd Fighter Squadron flying P-51's. He was activated for Korea and served stateside but again did not experience combat. He elected to stay on Active Duty following this Korean War activation. Pappy was due to retire in 1968 but elected to extend for a year so he could participate in Vietnam and serve his country in combat, the combat he had missed during his two previous wars. He was a great warrior and friend, especially to us young lieutenants. He was two decades our senior. He was very much our "pappy" and he always referred to us as his "Whippersnappers." Pappy went missing on his 81st combat mission. It was scheduled to be his final mission, and it was. We are certain that his remains are embedded on a hillside in Northern Laos.

Lt. Ronald Stafford was born and raised in Oxford, Nebraska. After entering the Air Force, he demonstrated outstanding flying skills and was assigned to one of the most dangerous missions of the Vietnam War flying combat missons in the F-105. I flew numerous combat missions with Ron and he always demonstrated a calm, courageous approach to even the most chaotic situations. He clearly displayed these traits on one occasion when he was shot down and forced to bail out of his jet in very hostile territory. He calmly communicated with the rescue helicopter while avoiding capture. The result was his successful rescue. Following his F-105 tour he returned to the states and spent a few years as a jet instructor but, missing the thrill of combat, decided to volunteer for another tour. Ron and his Weapons Systems Officer, Capt. Charles Caffarelli, went missing when their F-111 disappeared on a night bombing mission. We are certain his jet crashed in the shallow waters just off the coast of Vietnam in the Gulf of Tonkin.

Over the past 6 years I have been attempting to affect the recovery of my last two friends as well as Charles Caffarelli. During this period, I have found the task becoming more and more difficult. The primary reason for this is the focus of DPAA moving toward the recovery of World War II remains and the increased emphasis on the growth of their two state-of-the-art laboratories. I certainly applaud the recovery and identification of World War II warriors, a relatively easier job than searching for remains in the countries of Southeast Asia. DPAA's ability to recover remains from marked graves containing unidentified soldiers and returning those remains to their laboratories for identification affords them the opportunity to rack up many recoveries and supply their laboratories with many analysis opportunities.

Experience shows that Vietnam recoveries are very difficult. The climate can be very harsh and many times the terrain is treacherous. Also, there is the issue of dealing with governments that, at times, present obstacles to our efforts to recover our missing. However, the clock is ticking! It has now been a half century since these losses took place and people who are most likely to provide clues that lead to solutions--veterans and witnesses--are rapidly approaching their expiration date. Most importantly, many of the families who knew and loved the missing are still walking on this planet with us.

I am now hopeful that I can generate support within the State of Nebraska that leads to an outcry for more to be done to recover the remains of their Cornhusker warriors. A few weeks ago, I visited Omaha and the DPAA Laboratory at Offutt AFB. It is a very impressive facility and obviously well managed. I then traveled to Lincoln where I was accompanied by the Commander of the Nebraska American Legion, Boyd Yochum. We visited the leadership of the State VFW, the U. of Nebraska, Lincoln (UNL) AF ROTC, the Nebrraska Air National Guard and the UUNL DPAA Partnership Team. I was very impressed in every instance. Come on, Nebraska, "Let's get'er done!"

Department Finance Committee Tips for IRA

Qualified Charitable Distributions (QCD's) via Required Minimum Distributions (RMD's) from your IRA

Greetings from your Department Finance Committee. As I sat and thought about how I was going to write an article on QCD's via RMD's (don't we all just enjoy acronyms... NOT!) I thought, I want to make the article short, concise and to the point. I will now attempt to do just that.

A QCD is a distribution from your Individual Retirement Account (IRA) or any "never been taxed" retirement account directly to a qualified charity. The Department of Nebraska is a qualified charity. You must be age 70 ½ or older to make a QCD. The qualified charity distribution is not taxed, nor is it included in your taxable income. And the good news: You don't have to itemize your tax return to take advantage of a QCD.

Using your RMD as a charitable contribution to the Nebraska American Legion will exclude that amount from your adjusted-gross income (AGI) for the year, which means that in addition to reducing your income taxes, it could also decrease the amount of Social Security that is subject to tax and potentially lower your Medicare premiums. (You may be able to take a QCD from a Roth IRA, but there is no tax advantage.)

If this sounds like a strategy that could work for you, here are some things you need to know:

- 1. Each person can donate the full amount of his or her RMD, up to a maximum of \$105,000 annually. If you're a married couple filing jointly and you each have your own IRA, you both can use the \$105,000 QCD rule.
- 2. You should work with your IRA custodian to correctly accomplish a QCD. Be careful not to withdraw the funds or deposit the RMD into your personal account and then write a personal check. The funds must be distributed directly from the IRA custodian to the charity. (Some IRA custodians mail the check to the IRA owner; if that's the case for you, simply give the check to the charity.)
- 3. Be sure to inform your tax preparer that you did a QCD. Your IRA custodian will send you a 1099-R showing that the distribution occurred, but the amount may not be clearly identified as a QCD. Be sure the QCD is correctly listed on your tax return, or you'll lose the tax break.
- 4. It's permissible to use less than the full RMD for the charitable distribution. So, for example, if you have an RMD of \$6,000 and you want to give only \$4,000 to charity, you still need to withdraw the remaining \$2,000 and pay taxes on it.
- 5. You can make a QCD that exceeds your RMD for a given year. However, that extra distribution can't be carried over to meet the RMDs for future years.
- 6. You can distribute the money to multiple charities if you choose. The \$105,000 per person limit applies to the sum of all QCDs taken from all your IRAs in the tax year. You can make one large contribution or several smaller contributions to one or more charities.
- 7. Donors cannot receive any benefit for making a qualified distribution to a charity. So, for example, you can't use a QCD to purchase something at a charity auction or tickets to a charity event.
- 8. For a QCD to count toward your minimum annual IRA distribution, it must meet the same deadline as a normal distribution. (Usually Dec. 31.)
- 9. Not every organization or cause qualifies for a QCD. The American Legion does qualify for a QCD.


If you're already 70½ but the QCD strategy is new to you, be sure to discuss your specific situation and any questions with your financial advisor and/or your qualified tax professional. If you haven't turned 70½ yet, it's still worth having a conversation about how to prepare to take advantage of this strategy in the future.

I assume you all know where I am going with this. The American Legion Department of Nebraska is always looking for charitable donations. Our dues increase this year was to cover National dues increase as well as all expenses that continually increase. Our department is not exempt from the rising costs of doing business. When taking your RMD this year, or any year, please consider making a QCD to our department or your post to help in the financial liabilities of the Nebraska American Legion.

Again, be sure to discuss your specific situation and any questions with your financial advisor and/or your qualified tax professional concerning RMD's and QCD's.





The other unit I heard from was Bellwood Unit #327. This unit held a membership drive and ended the day with one new member signed up and four more who planned to pay their dues when they attended the next meeting of the unit. Nebraska is looking forward to adding these five new individuals to our membership roster. Way to lead, Unit #327!

If there are any other units out there who have held a membership event, be sure to let me know. I'd love to brag about your efforts in an upcoming issue of The Star.

But, what else can we boast about for the time being? Membership is all about "Leading the Way" – National President Trish Ward's theme for 2024-2025 – using the element she assigned to our Northwestern Division, namely Energy, and combining it with Creativity – which is what Department of Nebraska President Amanda Washburn is supporting through her project of the Veterans Creative Arts Festival.

So let's give a BIG SHOUT OUT to those Nebraska units who put Leadership, Energy, and Creativity together and managed to reach 100% membership by Veterans Day: Morrill Unit #10 (105.56%), Dodge Unit #122 (101.69%), and Potter Unit #291 (100.00%). Congratulations, Auxiliary units, on your impressive determination!!

And now let's check in on how our Districts are doing with their recruiting (as of this writing). This year, each District was assigned a team from the University of Nebraska Athletic Department to cheer on and encourage as we recruit in our own ranks:

· Leading the way is Nebraska Women's Volleyball, as the team has compiled a 25-1 record thus far. They

are currently ranked #2 nationally and are leading the Big Ten Conference. Take heart, District 11, for another 70 members will move you into 2nd place right alongside them.

- Women's Bowling has finished a respectable 1st, 2nd, and 3rd in their respective tournaments, defeating 57 other teams. District 12 is practically matching them strike-for-strike, as they are currently in 4th place in Nebraska with 62.47% of their memberships
- As of this writing, there are three undefeated (3-0) teams in Husker Athletics, namely Women's Basketball, Men's Basketball, and Men's Wrestling. Districts 7, 5, and 9 are in 2nd, 5th, and 10th places, respectively, with 65.45%, 62.19%, and 54.88%.
- · Women's Rifle is off to a decent 6-3 start, with two of those losses being decided by less than 20 points. The team is currently ranked #7 in the nation. Their counterpart, District 8, has been working on membership by passing the 50% mark. Just 100 more members will move your District into 7th place.
- Men's Football is still looking for that elusive sixth win to get the team into a Bowl Game (and I hope they've managed to do so by the time you read this). Their cohort, District 13, has had a bit more success, as they are currently in 3rd place with 63.40%.
- Women's Soccer had a rough year this fall, but that didn't stop District 4 from working on their membership, boosting themselves past the 50% mark with a respectable 55.63%.
- The teams representing our other five Districts have not yet started their seasons, but that hasn't stopped those Districts from working on membership. District 2 (Men's Track and Field) leads the way amongst all Nebraska Districts with a whopping 71.61%, followed by Districts 1 and 3, who are nip and tuck with 60.46% and 60.05%, respectively. Who will win their race, do you think, Women's Track and Field or Men's Baseball? Districts 10 and 6 (represented by Women's and Men's Gymnastics) are struggling a bit, but they'll find their way. In fact, District 6 needs just 10 more members to push them past the 50% mark.

We truly are making great progress, everyone! And every new and rejoined member gets the Department of Nebraska one step closer to our goal. Just remember that everything we do, every time we are out in our communities, is a "Membership Moment." So make those moments shine, and together, we will get Nebraska back to 100% membership in 2025.

- Challenge Guidelines
 - The challenge start date is November 10, 2024
 - The Legion's quarterly report and Auxiliary's membership report data will be used to calculate percentages.
 - Correspondence: The emails/lesters sent to legislators when a member goes through the Action Alert located in the Grassroots Center.
 - Correspondence Number: Each time a member sends email/letter, regardless of the number of recipients, on specific alert request will count as "1" for the department.
 - Department Membership: The number of 2025 paid members as of the end of the quarter (Membership Report nearest to quarter end).
 - The quarterly department and division winners will be determined by highest percentage calculated by Correspondence Number divided by the department membership.
 - Year-end department and division winners will be calculated by combining the total department correspondence numbers for the year divided by membership entered in the ALAMIS member database by July 26, 2025.
