August 1960 (65 years ago)

•Bill <u>ABERNATHY</u>, 17-year old from Omaha Central High School, was elected the 1960 <u>GOVERNOR</u> of Cornhusker Boys State. Following his election, Governor Abernathy announced a five-point program to be introduced to the Boys State <u>LEGISLATURE</u> including relieving farm surplus through shipments of grain to poor countries, school district reorganization, state income tax, increased industrialization of Nebraska's basic resources and a pledge to rededicate ourselves to the American way of life.

•<u>LINCOLN</u> Post 3 pulled out front of Omaha in total membership to become the largest post in the state. Whether Omaha is going to stand still for this remains to be seen.

•The <u>CHADRON</u> Legion took part in the recent dedication of a new 50 Star <u>FLAG</u> at the Chadron Post Office. Taking part in the <u>CEREMONIES</u> were the Legion, VFW, National Guard and Boy Scouts. The Boy Scout troops brought down the old flag and raised the new one at the conclusion of the short program.

September 1930 (95 years ago)

•Organization of a state vigilante or **EMERGENCY** law enforcement group is being proposed by Department Commander Marcus **POTEET** and a letter to that effect has been sent to all posts. The plan is for the Legion to offer its services to the city, county and state law enforcement bodies under certain emergency conditions. The recent series of bank holdups and other robberies in the state brought about the plan.

•A joint <u>CONVENTION</u> in 1933 of the Nebraska and Iowa Departments at Omaha and Council Bluffs is a proposal of Department Commander Poteet. Poteet expressed this desire in a speech at <u>OMAHA</u> on September 10. Such a joint convention, he claims, would bring together more than 50,000 ex-service men and former buddies from these two states.

•Past Department <u>CHAPLAIN</u> George <u>JONAITIS</u> of <u>STANTON</u> gave a quart of his blood to John Gurtner, 62, in a blood transfusion operation at a local hospital last month. Gartner, a convert of Father Jonaitis was injured in an auto accident and when his physician could not get volunteers to give their blood, he telephoned Father Jonaitis who rushed from his home to contribute the needed blood.

September 1940 (85 years ago)

•Legionnaire delegates to Department Convention at Norfolk again demonstrated the fact that the American Legion is an unselfish and patriotic organization and that members meet rather than shirk their responsibilities. A resolution was presented and adopted favoring **CONSCRIPTION**, or the registration of men, up to 65 years of age.

•Nebraska honored General John J. <u>PERSHING</u>, commander of the AEF during the World War, on occasion of his 80th birthday. A program was held in the senate chamber of the state house in Lincoln on Friday evening, September 13th. Department Commander Walter <u>ROBERTS</u> gave a short address after which a portrait of Pershing sent from Washington for the occasion was unveiled.

Honoring Nebraska Veterans: Accredited Veteran Service Officers and VA Memorial Benefits Information

Nebraska veterans have a unique advantage when it comes to accessing the benefits they've earned, thanks in part to the wide availability of American Legion-accredited veteran service officers throughout the state. These officers, often located in county offices, are specifically trained and certified to represent veterans before the U.S. Department of Veterans Affairs (VA). Their accreditation means they have undergone rigorous vetting and receive annual training through the American Legion or other VA approved training courses to stay current on policy updates and procedural changes within the VA.

While no veteran service officer can know everything, working with an accredited officer significantly improves a veteran's chances of successfully navigating the complex VA system. These professionals serve as guides, advocates, and trusted advisors in helping veterans receive the compensation, healthcare, education, and memorial benefits they have earned through their service to our nation.

One newer benefit available through the VA is the Commemorative Plaque and Urn program, introduced on June 10, 2024. This new benefit allows families of cremated veterans whose remains are not interred to honor their loved ones in a respectful and meaningful way. However, this option carries certain legal implications that must be carefully considered before deciding.

What Are the VA Plaque and Urn Benefits?

VA offers either a wall-mounted commemorative plaque or an urn designed to hold cremated remains. This program applies specifically to veterans who were cremated and whose remains are not buried or stored in a cemetery or columbarium. Importantly, families may only choose one of these two items and forfeit VA burial benefits.

Eligibility and Limitations

To be eligible, the veteran must have served honorably after April 6, 1917, or died while on active duty. Additionally, the full remains of the deceased must be in possession of the family.

However, there is a critical limitation: accepting either the plaque or the urn means the veteran becomes permanently ineligible for burial in a VA national cemetery and may limit the benefit of being interred in state veteran cemetery. This includes the loss of eligibility for a government-provided headstone, marker, niche cover, or medallion. According to VA, this decision is irreversible, even if the plaque or urn is returned later.

Alternatives for Families

For those who wish to keep future burial options open, there are other commemorative benefits available that do not affect burial eligibility. These include the **Presidential Memorial Certificate**, a paper document signed by the sitting President, and the **Veteran's Burial Flag**, which is typically presented during funeral services.

These alternatives offer meaningful ways to honor a veteran's service without sacrificing future memorial opportunities.

In conclusion, whether seeking help navigating VA benefits or choosing how to memorialize a loved one, Nebraska veterans and their families are strongly encouraged to consult with their local accredited veteran service officer. These professionals are invaluable resources, ensuring that veterans are honored and supported in every step of their journey.





I was honored to be asked to speak to the National League of POW/MIA Families at their annual meeting in Omaha this past June. This was to be held in conjunction with the DPAA Annual Report. I advised that Omaha during the College World Series could be problematic. As it turned out, the annual meeting was cancelled because of "logistical issues."

I was always taught not to speak evil of the dead, but the 1993 so called McCain Act is the problem, and that needs to be reversed. The biggest problem that the League of POW/MIA Families encounters is the fact that all POW/MIA files since World War II have been classified, and families are not able to get information on their loved ones. Using Vietnam as an example: there are files in the Department of Defense that are classified. Much of my research drafting these articles for the Legionnaire is limited because of classified files.

Operations in Laos and Cambodia were not commanded by the Department of Defense. When our American service men were sent into these countries, they were under control of the CIA and the State Department. Records and files, because of the McCain Act, are classified.

A group dedicated to finding out information on POW/MIA's, Task Force Omega, has respectfully asked President Trump to use an Executive Order to reverse the McCain act, and de-classify all records and files of POW/MIAs since The Great War, over 100 years ago, and including all conflicts and police actions the United States has been involved with.

No one that is a POW/MIA should have classified files that only ask, Why? Remaining families and the American public deserve to know what happened to their loved ones. Why is it a secret? Release the files and tell the truth. . .

The remains of Erin H Schopp from Plymouth, Nebraska were identified and accounted for by DPAA, January 24, 2025. Services were held at the Plymouth Community Center July 18, 2025. We thank all Legionnaires that were able to come out and pay tribute to our fallen soldier.

What we know: Schopp served with HQ Battery of the 59th Coast Artillery Regiment in the Philippines during World War II. Japanese forces invaded the Philippine Islands. Intense fighting continued until the surrender of the Bataan Peninsula on April 9, 1942, and of Corregidor Island on May 6, 1942. He was captured on Corregidor Island, and interned in the notorious Cabanatuan Prison Camp in Nueva Ecija Province, where he died on January 1, 1943.

At its peak, Cabanatuan held approximately 8,000 American and Filipino prisoners of war that were captured during and after the Fall of Bataan.

Conditions were poor, with food and water extremely limited, leading to widespread malnutrition, malaria and dysentery. By the time the camp was liberated in early 1945, approximately 2,800 Americans had died at Cabanatuan.

Schopp was buried, along with other Americans, in a common grave at the local Camp Cemetery. Following the war, Graves Registration personnel exhumed those buried at the cemetery and relocated remains to a temporary U.S. Military Mausoleum near Manila. Remains unable to be identified at the time were buried at the Manila American Cemetery and Memorial as unknowns.

In 2018, unidentified remains were disinterred and sent to the DPAA Laboratory for analysis and Schopp's remains were not found to be among them. In December 2020, remains from another common grave were exhumed for further study. Ultimately, the laboratory analysis established an association between one set of the unknown remains and Schopp.

The Defense POW/MIA Accounting Agency (DPAA) announced February 14, 2025 that U.S. Army Private Erwin H Schopp, 30, who was captured and died as a prisoner of war during World War II, was accounted for January 25, 2025.

2025 Junior Law Cadet



The Nebraska American Legion's 56th annual Junior Law Cadet Program was held June 23 – 26, 2025, at the Nebraska Law Enforcement Training Center in Grand Island. 18 boys and 21 girls who just finished their junior year of high school participated in this program.

Participants learned about law enforcement responsibilities and had training from representatives of various city, county, state, and federal agencies. They participated in daily calisthenics, classroom sessions, self-defense, firearms,

law enforcement driving, internet crime, and radar use. Evening classes were devoted to accident and crime investigation, fingerprinting and polygraph techniques, and other special topics.

Three young men and two young women were selected from the participants for performing above and beyond during the week. Outstanding Boy Cadet – Grant Barnes of Gretna; Outstanding Girl Cadet – Madison Reilly of Albion; Outstanding Boys Driving Ability – Caden Rainforth of Milford; Outstanding Girls Driving Ability – Adison Schuessler of Omaha; Outstanding Boys Marksmanship – Jacob Zalesky of Ashland; Outstanding Girls Marksmanship – no girl cadet due to rain at the range that day.





I am honored to have been elected Detachment Commander at the recently completed detachment convention. I have been a Nebraska resident for the majority of my life and am proud to represent our state and the men of this organization.

Make sure to turn in the Squadron Officer Reports following your local elections. It is vitally important that the detachment has the correct contact information for your elected officers. It is also not too late to submit your Consolidated Squadron Reports (CSR). If they have not been submitted yet, you have missed out on the possibility of qualifying for national awards, but the data is extremely important nonetheless.

What activities is your squadron planning for the second half of the year? Keep the Four Pillars of The American Legion in mind when planning events; Veterans Affairs and Rehabilitation, National Security, Americanism, and Children and Youth. Some ideas could be a Halloween "Trunk or Treat" for the kids in your area, hosting a Veterans Day meal to honor those that have served or something as simple as a pizza party on game day at one of our veterans homes.

Membership Minute Steve Bartos, Membership Chairman

The Department Convention is history, and we're off and running with Commander Walters in the 2026 membership year. Let's make it a good one.

There is no doubt that we had some struggles with membership for 2025. The dues increases adopted by both the national organization and the Department of Nebraska obviously had some effect. For administrative reasons, our first dues notice from Indianapolis was delayed. That, too, got us behind in the race.

Better news for this year. Dues, hopefully, will remain stable for a while. And the 2026 dues notice is not late. In fact, some Legionnaires received their renewal notices before the end of June --- and they are paying them. I thank them for that. We need to build momentum with early renewals so that we can also concentrate on recruiting.

We're going to have another Early Bird Drawing this year. Those members who pay their dues annually and those who are current with a multi-year membership and have their dues paid and received at the Department Headquarters by September 2nd will be included in the drawing. Five names will be drawn for \$200 each.

Renewing online prior to September 2nd ensures that your name will be in the drawing.

A separate drawing will be held after January 1 for all Department Life and Paid-Up-For-Life (PUFL) members.

We really need to concentrate on recruiting this year. I recently took a look at the living members in my own post for whom a birthday was included in the database. There were 779 such members, and they were distributed as follows:

Over 80 years of age --- 344 --- 44.16% 70 - 80 years of age --- 311 --- 39.92% 60 - 70 years of age --- 65 -- 8.34% 50 - 60 years of age --- 44 -- 5.65% 40 - 50 years of age --- 10 --- 1.23% Under 40 years of age --- 5 -- 0.64%

I have to confess that I was surprised at the severity of the unequal distribution of the members --but not particularly shocked since I monitor and was aware that my post lost about 70 members to
post everlasting in the last 12 months. About half of those 70 passed away after they had renewed
for the year, and about half before they had a chance to renew. Regardless, it's a significant loss
and one that cannot be solved with renewals alone.

Please do what you can to help on both fronts --- renewals and recruiting. The headquarters Post 500 remains a source of members. Just about every Legionnaire has a relative --- siblings, children, and grandchildren, perhaps ---- who is eligible to be a member. Past Department Commander Dave Bruckner is on the Department Membership Committee, and he has said more than once that he approaches prospective members with the idea that an American Legion membership is an insurance policy of sorts. A strong American Legion ensures that our veterans' benefits will always have a powerful voice defending them.



SUCCESSFUL 2025 GIRLS STATE



As I shared at the Department Convention in Columbus, I believe I started out with the same feelings most of the girls were experiencing --- a little excited, a lot of nervousness, some anxiousness, and so many mixed emotions. Even though I have attended the last three years, this year was different. Being the chair, I saw a different side of Girls State that I had not seen or been a part of before.

As a "first-time" chair, I brought a different perspective to the program and was able to try some "new" things. To summarize:

- In addition to the letter that is mailed to the schools, we utilized technology and emailed information about our program to the schools for whom we had contact information.
- Our opening ceremony included a "Flashlight Flag Ceremony." Thank you, Advisory Board, for making this possible.
- opportunity to "sponsor a snack night" on each floor. Some units chose to bring the snacks. Others donated money for snacks to be purchased. And, boy, did they donate. \$1,800 was given for this new event. Thank you to the units who made this possible.
- Additional donations were received to cover the Mercy Meals that was one of our Community Service projects. The excess snack money (we only used approximately \$900 for snacks) went towards the Mercy Meals. Also, a Venmo account was established on the



Cornhusker Girls State & Alumni Facebook page, which brought in funds for this wonderful project. The three days of packaging produced 49,261 Mercy Meals. We contracted to do 1,700. Thank you to those who donated, and thank you to the anonymous donor who covered the extra meals.

SECRETARY SCRIBBLES

Be looking for donation forms in the next newsletter around mid-August. We do have poppies and continue to receive them. This year, if you really don't need them or can do with less, this would be great. Monetary donations are happily accepted in lieu of poppy orders.

For the new 2026 membership year, you can begin submitting as soon as you have received your unit membership packet. They are all out now; so, check with your membership chairman if you have questions. You can send new applications, but I am unable to enter them into ALAMIS until September 1 and will be holding them until that date.

I have a few requests.

It is all earth-friendly to use up all those old copies of Unit Data Forms and Transmittal Sheets you have at home; but, when it comes to getting the correct information needed into the Department, only the most current forms ask for that information. We always need the personal member numbers (all nine digits) - especially if the person is transferring. Old Data Forms don't have a line for this number. It's time for old forms to go into the recycle bin.

Please throw out old forms that show an incorrect current dues amount of \$22.25. The last year for that amount was 2022, so recycle them. It confuses the preparer --and me --- if the wrong amount is submitted because that is what you are seeing on the incorrect form. This is the third year of submitting \$30.25 per Senior member, and anything else sent in will get you a phone call. Recycle those old forms.

Here are some pointers on filling out a membership application:

• They must be on the <u>current/</u> newest application form. This is the form that does NOT have GREATgranddaughter as the relationship to the veteran. "Greats" are no longer eligible (for six years now). Please do not write "Great" behind granddaughter. It is an automatic denial. A rule of thumb is - don't change or add wording to the forms.

Throw out those old forms.

 All the veteran information, including their American Legion membership ID number, must be included.

• All the correct signatures must be there. The applicant or parent/ guardian must sign the application. The POST ADJUTANT - **not** the Unit Membership Chair - must sign the veteran eligibility section. Please don't send them expecting the Department to take care of these things. You may receive it back if it is incomplete.

• The application should not be used for a previous member renewal/ rejoin. Those need to go on the Transmittal sheet with the word "rejoin" written somewhere with their name.

I think what you should get out of this is if you are unsure about something, please call us and ask the question. It saves a lot of time. Happy membership submitting!!
