## “Showing Up For Our Veterans”



For years, the Black Hills VA Hospital in Hot Springs, SD has been under fire from the Department of Veterans Affairs (VA) and they have been threatening to close it. They cite that there aren't enough veterans who use the facility, a newer facility in a bigger city would allow for more services and providers, and that there is no proof that the sereness of the hospital increases patient outcomes. Many in Nebraska and surrounding states would argue that all of these statements are false, especially the last one. If you have ever visited the VA campus there, you have seen the wild animals walking around and have felt the calmness of the environment and can see why the facility does so much good for the veterans there.

Ground was broken for the Battle Mountain Sanitarium on August 13, 1903, and the main group of buildings was completed April 1, 1907. Medicinal water from the local Mammoth Spring was supplied to all parts of the buildings and two fine plunge baths were supplied with hot and cold water. There were over 300 beds at the facility and preference was given to those military members

who were dealing with lung and respiratory difficulties. In 1930, the facility was transferred to the VA, where it still remains today. The hospital provides primary care and specialty health services, including mental health, nutrition, addiction and substance abuse treatment, kidney dialysis, traumatic brain injury (TBI), and more for veterans in the area. Many Nebraska residents use the facility and receive services there. Additionally, there is a 100 bed domiciliary that caters to those veterans specifically dealing with addiction and substance abuse and PTSD.

Each year, the Nebraska American Legion Family hosts a Christmas party for those veterans with funds for the Gifts for Yanks program. These parties include entertainment, bingo and prizes, lots of food and cookies, and fellowship shared by all. Besides this Christmas party, volunteers from the organizations also provide meals, outings to local communities, gift cards for shopping, and other items to help these veterans through their recovery.

This year Commander Walters has chosen the Hot Springs VA as her Commander's project. The funds that she raises will go towards these wonderful activities that are held and will help with items that the VA doesn't provide for these veterans. If you are interested in contributing to this great cause, you can send your donations to Department Headquarters with Commander's Project in the memo line. You can also contact Headquarters for the "wish list" of items that the facility is needing.

The idea behind the program is this, when a veteran passes away, his or her family receives a folded American flag in remembrance of the veteran. However, since the veteran has passed away, they never get to receive or see their flag. This program is designed to recognize the veteran for their service, provide them with an American flag that they can enjoy until their passing, and let them know that their service and sacrifice is not forgotten. ALR Chapter 53, along with several members from other ALR Chapters held their first ceremony on Veterans Day at The Heritage at Sagewood in Grand Island, NE. Twelve veterans were honored during the ceremony and each received a folded American flag, a set of commemorative dog tags, and a thank you card signed by all the Riders in attendance. The program is flexible and subject to the discretion of the local ALR Chapter as to where and how often they hold these events. 

## POW/MIA

Thomas Edwin Scheurich and his siblings; James, Betty and Beverly, grew up on a family farm near Norfolk, Nebraska, with their late parents Edwin and Margurite Scheurich. After graduating from Norfolk Junior College in 1953, Scheurich entered pre-flight Naval Air School in Pensacola, Florida. He was later stationed in Texas and Monterey, California where he earned his bachelor's degree.

By the time the United States became involved in the Vietnam War, Scheurich had qualified to fly the A-6 Grumman Intruder all weather night attack jet. He was 35 years old when he applied for duty in Vietnam.

Lieutenant Commander Thomas E. Scheurich was a member of Attack Squadron 35 (VA-35), Carrier Air Wing 9, USS Enterprise, Task Force 77, 7th Fleet; embarked aboard the Enterprise. On March 1, 1968, he was the pilot of an A-6A Intruder with a crew of two, along with two other aircraft; that took off from the Enterprise on a strike mission against enemy targets northeast of Haiphong, 90 miles due east of Hanoi, North Vietnam. He radioed a location report five minutes from his intended target. Soon contact with his aircraft was lost, and the Intruder went missing for unknown reasons and was presumed lost over the Gulf of Tonkin, south-southeast of Cam Pha.

The other aircraft flying the mission, jettisoned their ordinance and commenced a search of the coast and target areas, but were unable to locate the missing aircraft and its crew. A search for a crash site on land or debris in the water revealed nothing. It seemed that Lt. Cmdr. Scheurich and LTJG Richard Lannon and their Grumman A6 were simply gone.

On April 28, 1978, 10 years after his plane went down, the Navy reported Scheurich, then a Lieutenant Commander, Killed in Action. He was later posthumously promoted to the rank of Captain.

After decades of investigation into the incident, yielding no results, a Joint Field Activity recovery team found non-diagnostic aircraft wreckage, life support equipment, and possible remains at a site in Ha Long Village, Van Don District, Quang Ninh Province. Evidence from the mission was added into the DPAA laboratory system in December 2024. Based on the laboratory analysis and total circumstantial evidence, the remains were identified as those of Scheurich.

May 27, 2025, the Defense POW/MIA Accounting Agency (DPAA) announced that U.S. Navy Captain Thomas E. Scheurich, 34, killed during the Vietnam War, was accounted for April 23, 2025. At time of writing, Scheurich's interment is scheduled at Arlington National Cemetery November 14, 2025.

Thomas Edwin Scheurich, Captain U.S. Navy, made the ultimate sacrifice while serving his country in the Vietnam War; and was accounted for after 57 years missing. He is memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific. His name is inscribed along with all his fallen Comrades on the Vietnam Memorial Wall, Panel 42E, Line 24; in Washington, D.C.



## Qualified Charitable Distributions (QCD's) Via Required Minimum Distributions (RMD's) from your IRA

Greetings from your Department Finance Committee. This article was printed one year ago and is a repeat, by design. Department and the Finance Committee received numerous positive comments concerning the article and we feel it is pertinent each and every year to publish it. Charitable donations could be the lifeblood of our Department for supplemental cash flow needs in the future.

A QCD is a distribution from your Individual Retirement Account (IRA) or any "never been taxed" retirement account directly to a qualified charity. The Department of Nebraska is a qualified charity. You must be age 70 1/2 or older to make a QCD. The qualified charity distribution is not taxed, nor is it included in your taxable income. And the good news: You don't have to itemize your tax return to take advantage of a QCD.

Using your RMD as a charitable contribution to the Nebraska American Legion will exclude that amount from your adjusted-gross income (AGI) for the year, which means that in addition to reducing your income taxes, it could also decrease the amount of Social Security that is subject to tax and potentially lower your Medicare premiums. (You may be able to take a QCD from a Roth IRA, but there is no tax advantage.)

If this sounds like a strategy that could work for you, here are some things you need to know:

1. **Each person can donate the full amount of his or her RMD, up to a maximum of \$105,000 annually.** If you're a married couple filing jointly and you each have your own IRA, you both can use the \$105,000 QCD rule.

2. **You should work with your IRA custodian to correctly accomplish a QCD.** Be careful not to withdraw the funds or deposit the RMD into your personal account and then write a personal check. The funds must be distributed directly from the IRA custodian to the charity. (Some IRA custodians mail the check to the IRA owner; if that's the case for you, simply give the check to the charity.)

3. **Be sure to inform your tax preparer that you did a QCD.** Your IRA custodian will send you a 1099-R showing that the distribution occurred, but the amount may not be clearly identified as a QCD. Be sure the QCD is correctly listed on your tax return or you'll lose the tax break.

4. **It's permissible to use less than the full RMD for the charitable distribution.** So, for example, if you have an RMD of \$6,000 and you want to give only \$4,000 to charity, you still need to withdraw the remaining \$2,000 and pay taxes on it.

5. **You can make a QCD that exceeds your RMD for a given year.** However, that extra distribution can't be carried over to meet the RMDs for future years.

6. **You can distribute the money to multiple charities if you choose.** The \$105,000 per person limit applies to the sum of all QCDs taken from all your IRAs in the tax year. You can make one large contribution or several smaller contributions to one or more charities.

7. **Donors cannot receive any benefit for making a qualified distribution to a charity.** So, for example, you can't use a QCD to purchase something at a charity auction or tickets to a charity event.

8. **For a QCD to count toward your minimum annual IRA distribution, it must meet the same deadline as a normal distribution.** (Usually Dec. 31.)

9. **Not every organization or cause qualifies for a QCD.** The American Legion does qualify for a QCD.

If you're already 70 1/2 but the QCD strategy is new to you, be sure to discuss your specific situation and any questions with your financial advisor and/or your qualified tax professional. If you haven't turned 70 1/2 yet, it's still worth having a conversation about how to prepare to take advantage of this strategy in the future.

I assume you all know where I am going with this. The American Legion Department of Nebraska is always looking for charitable donations. Our dues increase this year was to cover National dues increase as well as all expenses that continually increase. Our department is not exempt from the rising costs of doing business. When taking your RMD this year, or any year, please consider making a QCD to our department or your post to help in the financial liabilities of the Nebraska American Legion.

Again, be sure to discuss your specific situation and any questions with your financial advisor and/or your qualified tax professional concerning RMD's and QCD's.

## Membership Minute

The 2026 membership year has certainly gotten off to a better start than what we experienced last year. We've achieved and surpassed the 65% target a week or two prior to the mid-November target date. I'm confident that we will achieve the 75% Pearl Harbor target scheduled for December 9th. Thanks to everyone who has been active in promoting membership, collecting dues, and getting them transmitted.

We can't fall asleep, though. Traditionally, Nebraska has performed well early in the membership campaign --- but then slows to a crawl after the first of the year. Let's not let that happen.

While we're off to a relatively good start, please keep in mind that the trend of our final membership numbers each year is downward. If we don't recruit new members or reinstate enough former members to replace those who elect not to renew or enter the Post Everlasting, there is no way we can grow. And, to remain the important voice for veterans that we are, we really do need to grow.

Do the math. Nebraska has about 100,000 veterans eligible for membership in The American Legion. The national organization reports that our "market penetration" (the percentage of eligible members on our rolls) is just under 20%. That means there are about 80,000 Nebraska veterans eligible to be Legionnaires --- but are not currently members. Our task is to find them --- or do something to help them find us ---- and then change their status from "non-member" to "member."

I certainly encourage every Post to initiate some recruiting activity to bring in new members. Be creative. Try something different. And be sure to share with us the things that prove to be productive,

While individual Posts can organize some recruiting projects, keep in mind that EVERY individual Legionnaire can also be a recruiter to help in the effort. Don't be shy. Be proactive. If you have a relative, friend, or coworker who is a veteran, be sure to ask them to join us

Reinstatements are as good as "new" when it comes to growing our numbers. The good thing is that potential reinstatements are easier to find. Post Adjutants can easily use MyLegion to search Post records according to their "last paid year" of membership and create contact lists of former members. These lists can then be used by recruiters to touch base with the former members and invite them to rejoin The American Legion.

The Post Adjutant can also use MyLegion to identify the Legionnaires in your area who joined The American Legion as new members online or responded to a solicitation from the national headquarters. Those new members are placed in Post 500 and are immediately eligible to transfer into a local Post --- and are highly encouraged to do so. Contact them. If they have already paid their 2026 dues, they can transfer at no cost. If they haven't paid, invite them to "renew and transfer" at the same time.

What are your "go-to" songs to relieve stress? Mine is Bob Seger's

"Against the Wind." It reminds me that what I thought was hard times 45 years ago didn't last, and I have a 100% survival rate of bad days. A Capella hymns fill my cup when I'm sad, and my guilty mellow pleasure is John Denver.
