



“2026 Vetearn Legislative Priorities”



Each year, veterans from all over Nebraska stand together to support or oppose legislation that is proposed by our State Senators. In Nebraska, The American Legion works with the eight other recognized Veterans Service Organizations through the Nebraska Veterans Council (NVC), to attend legislative hearings, send letters, and hold their Annual Legislative Day at the State Capitol. These other organizations are Veterans of Foreign Wars; Disabled American Veterans; Vietnam Veterans of America; American Veterans; The Military Order of the Purple Heart; Paralyzed Veterans of America; the Marine Corps League; and the County Veterans Service Officer Association of Nebraska. The NVC follows and supports legislative bills that advance veterans’ initiatives. In this legislative cycle, the NVC chose six bills that they support, two they oppose, and one they are remaining neutral on. The NVC is asking for your help this year with these bills. Those bills being supported are LB-693, LB-738, LB-756, LB-786, LB-826, and LB-882. Those bills being opposed are LB-767 and LB-1117. The council is remaining neutral on LB-1072 except sections 127 and 128 which they are in opposition to. At the National level, The American Legion selects about a dozen priority items to present to Congress that impact active-duty military, veterans, and their families. These priorities are chosen based off of the positions and views of its 1.6 million members. These priorities align with the ideals of The American Legion: Mental Health and Suicide Prevention, VA Healthcare Modernization, PACT Act Implementation and Oversight, Protecting Veterans from Predatory Actors, Military Quality of Life, and Protecting the American Flag. To support these priorities and lobby the members of Congress, members from all 55 American Legion Departments make their way to Washington DC every February to participate in the Washington Conference. During this conference, The American Legion Family members visit with their State Senators and Representatives to see how they plan on voting on the priorities and why they feel the way they do about them. Nebraska will have more than fifteen members from The American Legion Family who will be attending the Conference and will be meeting with the State’s representatives.

It is the start of a new year, and as far as membership goes, it is looking good. Nebraska met and exceeded the January 14, 2026, 80% goal, achieving 82.54%. The next membership target date is February 11, with a goal of 85%. We are very close to that goal, and with your continued hard work, we will meet that goal. Hopefully, all Post Adjutants have timely submitted all dues payments received; otherwise, the legionnaire's status is delinquent if not received by 12-31-2025 and suspended if not received by 01-31-2026. If their status is suspended, their benefits through the Legion are suspended as well. Legionnaires who pay their dues on time, but whose Post does not submit them on time will not understand why they are not in active status. This can also affect retention, as members may not renew next year if they encounter issues with this year's renewal. Thank you all for your hard work in reaching the 80% goal, and I hope it continues so we are at or above 85% by February 11, 2026. The American Legion's Big Twelve Competition recognizes Departments that meet or exceed their pledged membership goal percentage by the March 90% target date. Our Department could win \$2,000 if we meet the March pledge to the National.

Adjutant Martin and I just got back from a short trip to Louisville, KY, where the 2026 National Convention will be held. We visited a local Legion Post, Shawnee Post 193, while we were there. It is the closest Post to our hotel. They are highly active in serving their community. They host regular tournaments for pool, shuffleboard, and cornhole. They regularly distribute food to children in their low-income community. They are well known in their community and have no issues with membership. Staying active and relevant in a community helps retain members and attract new ones.

February is Americanism Month. Some ideas of things to do in February: Host a Four Chaplains Day Program, plan school awards with local educators, start planning the upcoming American Legion Baseball season, consider hosting observances of Abraham Lincoln's and George Washington's birthdays, plan an American Legion birthday program for March, or go to legion.org for more ideas.

March is Community Service Month. The anniversary of The American Legion's founding, celebrated March 15-17, is an excellent opportunity for Post officers and members to focus on enhancing the vision and

image of the Legion with the community. Consider forming a committee to organize an open house between January and March to further engage the community.

I look forward to seeing many of you over the next several months at the District Conventions, which start in February. Hopefully, 1 - 3 members of each Post will attend their District Convention. Remember to make nominations for the District Citizenship Award. This award highlights a Legionnaire's contributions in civic duties (like school boards), administrative roles, public speaking, and overall embodiment of character traits like courage, honor, and patriotism, with specific recognition given for exceptional recruiting efforts or service in support of military deployment. Looking forward to having a Citizenship Award winner for every District at our Department Convention in June 2026 in Columbus.



New State Benefit Available to Nebraska Veterans in 2026

As of January 1, 2026, Nebraska disabled veterans have access to a new state benefit that can reduce the cost of owning a vehicle. Under a change in state law, eligible disabled veterans may receive an exemption from the Motor Vehicle Tax and Motor Vehicle Fee for one vehicle that they own and use for personal transportation.

It is important to note that this exemption applies only to the Motor Vehicle Tax and the Motor Vehicle Fee. Other charges associated with vehicle registration such as plate fees, sales tax, wheel tax, and similar local or state fees are not affected and must still be paid. I encourage veterans who own multiple vehicles to review their registration documents and decide which vehicle they wish to designate for the exemption.

Who Qualifies

To be eligible, a veteran must have served on active duty in the U.S. Armed Forces and separated under honorable conditions. In addition, the veteran must have established the existence of a service-connected disability. This includes veterans who are rated at 0 percent. Eligibility also extends to veterans who are receiving compensation, disability retirement benefits, or a pension under a public statute administered by the U.S. Department of Veterans Affairs (VA) or a military department.

How to Apply

Before claiming the exemption, a veteran must have a profile in the Nebraska Department of Veterans' Affairs (NDVA) Military & Veteran Registry. This registry is how the Nebraska Department of Motor Vehicles verifies eligibility.

Contact your County Veteran Service Officer (CVSO) or NDVA staff to ensure you have a profile in the registry and that it is up to date. The CVSO or NDVA staff will advise if any additional documentation is needed.

The exemption can be requested during vehicle registration or renewal in one of three ways:

- In person: Inform county treasurer staff that you qualify for the disabled veteran motor vehicle tax exemption.
- By mail: Include a written request for the exemption along with your Social Security number.
- Online: During the second step of renewal (Eligibility), select the option indicating eligibility for the disabled veteran motor vehicle tax and fee exemption and choose the vehicle to which it will apply.

Timing Matters

For newly purchased vehicles, the exemption request must be made within 30 days of purchase. For renewals, the request must be submitted before the final day of the vehicle's expiration month. Requests made outside these timeframes will not take effect until the next renewal period.

Transfers and Renewals

The exemption may be transferred to another vehicle if a veteran sells their current vehicle or during the expiration month of the registered vehicle. Assistance with these situations is available through a CVSO or county treasurer. Once approved, the exemption automatically applies to future renewals unless the veteran requests a transfer.

I encourage you to consult with your local accredited Veteran Service Officer to learn more about this benefit and other state and federal benefits for which they may be eligible.

Herbert Owen Brennan from O’Neill, was a 1947 graduate of West Point and a full Colonel. Brennan had NOT been required to serve in Vietnam and served as an instructor at the Air Force Academy before volunteering for Vietnam Service.


Col Brennan probably thought he was fortunate to have been selected to fly the F-4 Phantom. The Phantom was used by Air Force, Marine and Navy air wings and served a multitude of functions including fighter-bomber, interceptor, photo and electronic surveillance. The two man aircraft was extremely fast, and had a long range (900 – 2300 miles, depending on sorties and mission type).

He was an Aircraft Commander aboard a two crew member F-4C Phantom, (tail number 64-0697), 366th Tactical Fighter Wing. On November 26, 1967, they took part in a two plane strike mission against enemy targets in North Vietnam. The aircraft was over Quang Binh Province, about 12 miles from the Ban Karai Pass. As the Phantom made its first pass over the target, it exploded and burst into flames for unknown reasons. The Phantom crashed in the target area, and witnesses aboard the other aircraft did not see parachutes before the plane went down. Search aircraft were launched to the area, but received ground fire when they approached the crash site, and saw no evidence of survivors.


The Ban Karai Pass was one of several passageways through the mountainous border of Vietnam and Laos. American aircraft flying from Thailand to missions over North Vietnam flew through them regularly, and many aircraft were lost. On the Laos side of the border, was the “Ho Chi Minh Trail,” heavily traveled by North Vietnamese troops moving material and personnel, through the relative safety of neutral Laos. The return ratio of men lost in and around the passes was far lower than those of men lost in more populous areas, even though both were shot down by the same enemy using the same weapons. It seems improbable that in one of the most heavily traveled sections of the Ho Chi Minh Trail, that many Americans lost went unnoticed by the other side.

Col Brennan and Lt Condit went down carrying FMU 1-35 fuzzes. Circumstances indicated that the destruction of some American aircraft could have happened in one of two ways: They could have taken a direct hit, or the plane could have blown up by its own bombs. There was a distinct possibility that the FMU 1-35 time-delay fuzzes had malfunctioned. Unfortunately, “they” were to prove months later, there was a defect in the fuzzes when the military first began using them. Essentially, the bombs were arming when they were attached to the aircraft. This meant the bombs were live and deadly when released, allowing premature, sometimes immediate detonation. If this happened, over two tons of high explosive would have erupted less than fifty feet from the Phantom. They had rolled in on the target, released their bombs, and had immediately blown up.

The U.S. Air Force originally placed both men in the category of Missing in Action. The Defense Intelligence Agency (DIA) later refined that category according to enemy knowledge, concluding that there is ample reason to believe that the enemy knew the fate of Brennan and Condit. Following the end of hostilities, the remains of Col Brennan were recovered during a joint U.S. and Vietnamese mission and identified. Remains of the other crewman, Lt Condit, remain unidentified. Both are memorialized on the Courts of the Missing at the National Memorial Cemetery of the Pacific.

Need a Copy of a DD-214?

Military Discharge Request: The National Personnel Records Center (NPRC) has provided the following website for veterans to gain access to their DD-214s online: <https://vetrecs.archives.gov>.

This may be particularly helpful when a veteran needs a copy of his DD-214 for employment purposes. NPRC is working to make it easier for veterans with computers and Internet access to obtain copies of documents from their military files. Military veterans and the next of kin of deceased former military members may now use a new online military personnel records system to request documents.

Other individuals with a need for documents must still complete the Standard Form 180, which can be downloaded from the online web site. Because the requester will be asked to supply all information essential for NPRC to process the request, delays that normally occur when NPRC has to ask veterans for additional information will be minimized. The new web-based application was designed to provide better service on these requests by eliminating the records centers mailroom and processing time.

Membership Minute

With the 2026 Mid-Year Conference behind us, it's time to catch our breath and then continue working hard on membership!!!

Gary Hanke, from Ceresco Post 244, won the \$150 drawing for PUFL or Department Life Members on our roster on January 1.

The "Mid-Winter Target Date," with a goal of 80%, occurred just before we went to Norfolk, Nebraska reported 17,300 members --- which was 84.85% of goal. Post 500 and every District --- save one --- were at 80% or more. And the lone District that missed the 80% mark did so by only 8 members. We looked good nationally, too. Nebraska ranked 6th among all Departments. Let's keep generating renewals, reinstatements, and new members so that we can keep leading the pack from the front!!!

The next national target date is the "Presidents' Day Target Date" on February 11, and the goal is 85%. That equates to 17,330 members. We left Norfolk only 7 members short of reaching that goal --- so, we look good in that regard. But I can't stress enough how important it is that we don't stop scratching for members. New. Renewed. Reinstated. Doesn't matter.

Of more important concern is the March 11th "Legion Birthday Target Date." The target is 90%. The American Legion's Big Twelve Competition recognizes Departments that meet or exceed their pledged membership goal percentage by the March 90% target date. The Department in each category that has pledged the highest percentage AND meets this goal receives the award. The percentage does not include members gained through DMS. The winner in each category will be reimbursed for computer equipment purchases of up to \$2,000. Runners-up in each category will be reimbursed for computer equipment purchases of up to \$1,000.

It turns out that Commander Judy pledged that Nebraska would achieve 90.70% of goal --- or 18,492 qualifying members. The information I presented at the Mid-Year Conference wasn't exactly correct in that the percentage Judy pledged was not greater than that of all other Departments in our category. That doesn't mean we can't finish first or second in our category. Those Departments pledging more may default by not making their pledge --- and we can move up accordingly. But we must get to 90.70% to have a chance. By winning or finishing second in our category in the Big 12 Competition, we get both some nice recognition and a bag of cash to spend on computer needs. Let's do it!!!!

Here's some food for thought. I recently sent out a personal email to 128 non-renewed members in my own Post for whom I had an email address. There were 85 non-renewed members for whom we did not have an email address on file. I then tracked the results --- and confirmed the idea that personal contact pays off. The renewal rate for the group that received my email was about 50% better than for the group that did not.

Please transmit your memberships early and often so that we can track our path to success in winning the Big 12 Competition.

The Assistant Adjutant position is currently vacant and the Department is looking to get a replacement onboard quickly.

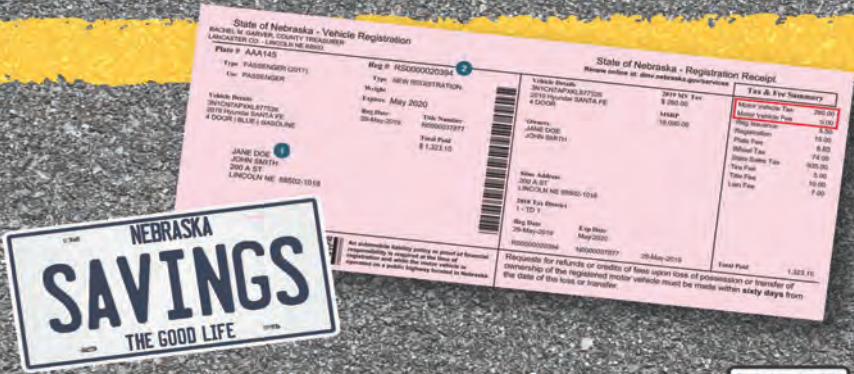

Greetings from your Honorary Junior President!

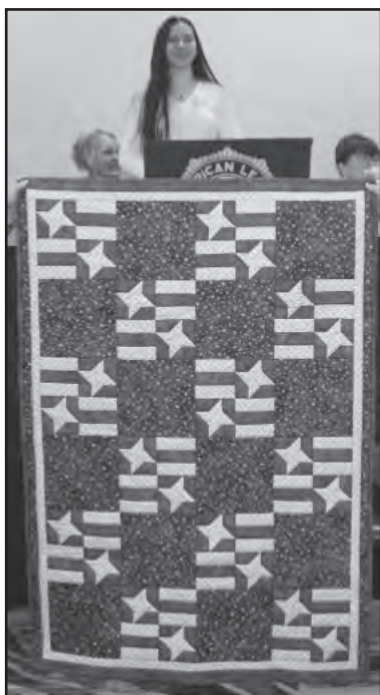

I contacted two past Department Presidents, Bonnie Dumler (1990-1991) and Virginia Nelson (2001-2002); and found that our membership in Nebraska was approximately 30,000 in 1990 and approximately 28,000 in 2000. That averages a loss of about 450 members per year since 1990. Today our goal is 14,284. This is a 1%

increase over last year.

I am excited about what is happening in this organization; share YOUR passion!

Currently, we have sixteen units

that are at or above 100% and fifteen that are above 95%. We need every unit at 100%. It is not impossible.

Congratulations to District 3 and Laura Novak's crew for making the 85% goal by March 15! District 2 and Corrinna Janovec's gang are not far behind with 84%. And a big Congratulations to Nebraska, who continues to be in first place in the Northwestern Division --- and note that we have been in third, second, and now fifth in the nation for membership.

Let's Party like it's 1999 and start membership in the other direction!

Unit Scholarship Committee --- Simply fill in the name of the scholarship that you are judging at the top of the page. For example, write in “Nebraska Memorial,” “Healthcare Professional,” or “Career and Technical Education.” Please review the scholarship applications and rate them using the scoring rubric shown. (A scoring rubric has been created to assist units with choosing scholarship candidates for Department scholarships. If you would like a copy emailed to your unit, contact

Education Chair Cindy Moore at 402-672-2040.) It will make the task of evaluating applications much less daunting. For example, if candidate A meets all of the requirements, but candidate B is missing two, then you can easily eliminate B from the pool of potential recipients. Score and rank the candidates who have ALL the required documents.

More weight has been placed on the narrative, community service, and letters of recommendation rather than on supplying the required documents. Select one winner for each scholarship to submit to the Department on or before March 15.

All applications and evaluations are CONFIDENTIAL and are not to be shared outside of this committee.

Speakers are being contacted, community service projects planned, places of interest to visit, office visits scheduled, and fitting everything into the seven-day schedule.
