**FIGHT FOR YOUR RIGHT TO PARTY**

We had a great Midyear Conference in Norfolk. We gave a couple of skits on Membership and continue to "Stir up Members." Nine Districts were above 80% membership with two very close to 80%. Our next Goal is 85% and District 3 is currently above 85% with District 12 and 2 close behind. Is your Unit working toward 100%?

I have had several Units tell me that they are at 100% and when I check ALAMIS, the Units are close, but lacking 1 or 2 members. Are you using the Membership Goal sheet that was distributed in the original Membership Packets (that should have been discarded)? **Please use the Membership Goal Sheet that was Distributed in the first Newsletter.**

In calling membership chairmen, I learn that some are holding memberships until all are paid. **PLEASE DO NOT DO THAT.** A Member thinks that her/his membership is paid when dues are paid and

**have a Membership Card in hand. Dues are not paid until they are submitted to Department or National and are entered in the ALAMIS system.** Members are delinquent as of December 31<sup>st</sup> and lose continuous membership and have a grace period until January. If you have paid your dues, it is your right to have your dues submitted in a timely manner.

I do want to commend the Units of Nebraska working very hard to maintain membership. Please plan to **Retain** all members from last year, **Rejoin** members who did not pay last year, and **Recruit** new members.

We currently (as of January 20) have 16 Units that are at or above 100%: **They are: Petersburg, Bloomington, Lebanon, Union, Plattsburgh, Greeley, Winside, Winnebago, Broadwater, Bruning, Clearwater, Cody, Colon, Nehawka, Newcastle, and Potter.**

This year will see a change in the names of the floor towns. The decision was made to select prominent Nebraska women to name each floor. The county names will remain the same (using the National and Department Presidents' names). A committee was chosen who accepted suggestions and chose five of the eight names. The GS Staff then was poled to select the remaining three. The chosen list is:

- **Eve Bowring** – First woman to represent Nebraska in the Senate
- **Mildred Brown** – Advocate for educational and women's rights in Nebraska
- **Susan La Flesche Picotte** – First Indigenous women to earn medical degree
- **Minnie Penny** – First President of Nebraska ALA; hero in Schoolhouse Blizzard 1888
- **Elizabeth Pittman** – First African American female lawyer in Nebraska, first African American judge and first female judge in Nebraska
- **Kay Orr** – Nebraska's first (and to date only) female governor; made national hist. as first gubernatorial race between two women
- **Virginia Smith** – First (and only to date) woman from Nebraska to hold seat in the House
- **Evelyn Sharp** – Nebraska's best known aviatrix, served in Army Air Forces, Ord Airfield named after her

National Poppy Day is Friday May 22, but remember you can promote the Poppy every day. Poppy funds can also be collected throughout the year. During the Mid-Year Conference I set up a table about the Poppy program. I asked you to fill out a few questions. One was to tell me how your unit raises Poppy funds. Here are a few of the responses.

- Set donation cans at local businesses
- Contact local businesses for donations

These are all great ways but just remember to follow the guidelines on what those funds can be used for. The guidelines are on the Nebraska ALA website under the Poppy tab or reach out and I can share them with you. If you have other ways that you promote the poppy and how you collect Poppy funds, please share. Some smaller towns struggle with this and I would like to share ideas that may help them collect funds to help our veterans.

It seems like Poppy making is a struggle in quite a few states. Spread the word and see if you know anyone that is interested in making poppies to help build up our inventory. Some states have 4-H groups or Scouts troops help make poppies. Minnesota is having Poppy Palooza's where they get together and have a day to make poppies. I know that Renee VanWinkle enjoys her time with the veterans at the Grand Island Veterans Medical Center when she goes in and helps veterans make poppies. She even taught one veteran that took their skills back to Hot Springs and is still making poppies there. Remember only veterans can get paid to make poppies.

I have had two Zoom meetings with the National Poppy Committee so far. I did finally get the monthly newsletters so look for them on Facebook and the Nebraska website.

Hopefully you have all taken Poppy Poster information to your schools. I am excited to see all of the results. Remember the Poppy Poster Deadline postmarked to me by **April 1**. Please make sure that you send only posters that meet the criteria in the Poppy Poster Rules. You can mail the winning entries from each division to: Justina Birkel, PO Box 64, North Loup NE 68859

There are also the Most Outstanding Unit Poppy Program award and the Best Department Poppy Program award for the Northwestern Division. Please make sure you do end of year reports and send me information so that I can brag about your awesome Poppy programs.

### SAMPLE LETTER TO SENATORS

Dear Senator \_\_\_\_\_

In the beloved Christmas movie, *It's a Wonderful Life*, the angel Clarence declares to the film's protagonist, George Bailey: "One man's life touches so many others. When he's not there, it leaves an awfully big hole."

Nebraska's veterans are currently facing an "awfully big hole" of their own. But this letter is not about funding – although that is always a consideration for our veterans. No, this letter discusses how, just as in our Christmas movie above, creating an alternate timeline for our hero can change the entire fabric of the plot.

So let's begin with the backstory. As you are probably aware, the red poppy was among the first plants to bloom in the devastated battlefields of France and Belgium after World War I. Seeing these blooms, Lieutenant Colonel John McCrae was inspired to write a poem entitled *In Flanders Field*, which gave voice to those soldiers buried at the battlefield by pleading with survivors to remember these veterans, even as a sea of red poppies was cropping up and beautifying the area.

When American professor Moina Michael read McCrae's poem, she was so moved that she wrote her own response, *We Shall Keep the Faith*, pledging that there would always be people to "cherish the poppy red." After the war was over, Professor Michael returned to the University of Georgia, where she taught a class of disabled servicemen, soon realizing they were in desperate need of financial and occupational support. Thus, she conceived of using poppies as a fundraiser; and in 1921, her efforts resulted in the poppy being adopted by the American Legion Auxiliary (ALA) as a symbol of remembrance for veterans.

Fast forward to the early 2000s when then-ALA Department of Nebraska President Lynne Wild received a letter from an incarcerated individual, stating that he was a veteran and wondering whether he could be allowed to make paper poppy flowers during his imprisonment. President Wild visited the prison and taught this gentleman and others how to make the poppies which are distributed on National Poppy Day and throughout the year to honor and remember our veterans.

This program quickly became successful, culminating in the Nebraska prison population producing upwards of one million poppies per year. As a result, Nebraska became the "go-to" state across our nation for obtaining poppies. Sadly, that came to a screeching halt in 2023, as the Nebraska Department of Corrections issued a directive to stop the making of poppies within the prison system. After some inquiries, Corrections reversed course and stated that inmates would be allowed to begin making poppies again, and the ALA cheered this development.

To date, though, there has been no uptick in the amount of poppies being produced by the prison population, which means that not only is Nebraska still short of poppies to honor our veterans, but the entire country is suffering from the shortage caused when one million poppies are removed from production.

Our research indicates that while Corrections is once again allowing inmates to make poppies, these individuals can only do so when they are gathered together as a veterans group; and unfortunately, this veterans group is not being allowed to meet. The ripple effect, of course, is that no poppies are being produced from within Nebraska's prisons.

To once again quote the angel Clarence, "One man's life touches so many others. When he's not there, it leaves an awfully big hole." Our big hole is that we are quickly reaching a point where we are unable to bring awareness to Colonel McCrea's plea to honor our veterans and Professor Michael's directive to "keep the faith" with our nation's heroes.

We are, therefore, asking you, Senator \_\_\_\_\_, to do all you can to encourage the Executive branch of Nebraska's government to fully reinstate the poppy program so that the American Legion Family and other veterans' organizations can continue to honor the brave men and women who have served our country so nobly.

Thank you for your consideration of this request. We look forward to hearing from you.
